FOR PROGRAMMING EXPENSES ASSOCIATED WITH THE JEFFERSON COUNTY HIGH SCHOOL FRESHMAN 10,000 TREE GIVEAWAY (AS AMENDED).


**SECTION I:** The total of ~~\$6,250~~~~\$2,500~~~~\$1,000~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,500 from District 7; \$1,000 from Districts 7 and 9; \$500 from Districts 8 and 15; \$250 from Districts 10, 12 and 13, 14, 17, 21, and 22; through the Office of Management and Budget, to TreesLouisville, Inc. for programming expenses associated with the Jefferson County High School Freshman 10,000 Tree Giveaway.


**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
