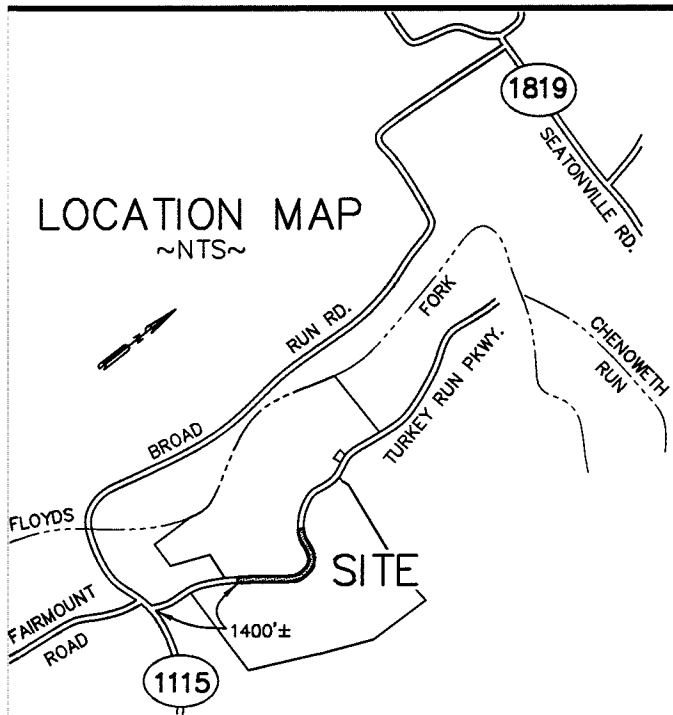


**LOCATION MAP**

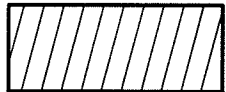
