**AN INDUCEMENT RESOLUTION OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE “ISSUER”) AUTHORIZING THE EXECUTION OF A MEMORANDUM OF AGREEMENT BETWEEN THE ISSUER AND BOYD COMPANY OR ITS AFFILIATE (THE “COMPANY”) RELATING TO THE ACQUISITION, CONSTRUCTION, EQUIPPING AND INSTALLATION OF FACILITIES AT 1400 CECIL AVENUE, LOUISVILLE, KENTUCKY, INCLUDING FOUR OR MORE NEW BUILDINGS TO BE USED FOR LIGHT MANUFACTURING OR WAREHOUSING AND DISTRIBUTION (THE “PROJECT”); AGREEING TO UNDERTAKE THE ISSUANCE OF INDUSTRIAL BUILDING REVENUE BONDS AT THE APPROPRIATE TIME TO FINANCE THE COSTS OF ACQUIRING, CONSTRUCTING, EQUIPPING AND INSTALLING SAID FACILITIES; AND TAKING OTHER PRELIMINARY ACTION (AS AMENDED).**

The following was discussed:

- The Resolution is for a project in District 1.
- The project will construct six to seven office and warehouse buildings totaling 1.3 million square feet.
- This project will use an Industrial Revenue Bond that is a similar concept to a Tax Increment Finance proposal, but will allow Louisville Metro to issue conduit bonds for a industrial development project as detailed in the Kentucky Revised Statute Chapter 103.
- Louisville Metro will be a funding conduit for the debt and the borrower receives a lower interest rate, which will allow the borrower to pay off the bond with the revenue earned.
- The Industrial Revenue Bond is structured similar to a Tax Increment Finance proposal, however, in this instance the developer has a cap to the revenue that will be generated at 80 percent.
- There will be a payment in lieu of taxes that the developer will pay Louisville Metro and the Jefferson County Public School Board.
- This project is anticipated to generate \$13.5 million in what would normally be Tax Increment Financing eligible expenses. However, with this project the cap is \$10.84 million which equals the 80 percent agreed upon.
- Louisville Metro will receive a pilot payment of 20 percent of the revenue until the 80 percent cap is reached.
- Jefferson County Public Schools will receive return of their full district taxes.
- There were several questions regarding whether there will be any manufacturing proprietors in the development.
- The zoning district would allow light manufacturing, but not heavy manufacturing.
- There were several questions regarding the types of light manufacturers that are acceptable in the development versus those manufacturers that are prohibited.
- There were several questions regarding attaching binding elements and/or restrictions to the property.
- There were several questions regarding the developer being a good corporate neighbor within the community.
- There were several questions regarding the decision to use the Industrial Revenue Bond process versus Tax Increment Financing.
- The project did not meet two requirements to be eligible as a Tax Increment Finance project as an active business was operating on the property and it is not a blighted property.
- There were several questions regarding the significant investments and incentives for Louisville Metro.
- This project is anticipated to generate 1,000 jobs and the developer will repay the bond debt with generated revenue.
- There were several questions regarding concessions for occupational taxes.
- There was a request for Committee Member Piagentini, Chair Person Hollander, and Council President James to be added as co-sponsors to the legislation.
- There was a presentation regarding the project entitled the Louisville Logistics Park that is on the former Wayne Supply property. (See attached)
- A portion of the property purchased was sold to Jefferson County Public Schools, which is where Foster Academy is located.
- There were several questions regarding the transition from Wayne Supply to

the Boyd Company.

- There were several questions regarding the number of employees the Boyd Company employs from surrounding neighborhoods.
- There were several questions regarding the diversity of the company.
- There was a request to receive information on the diversity of the company.

The motion to recommend for approval carried by a voice vote and the amended Resolution was sent to Old Business.
