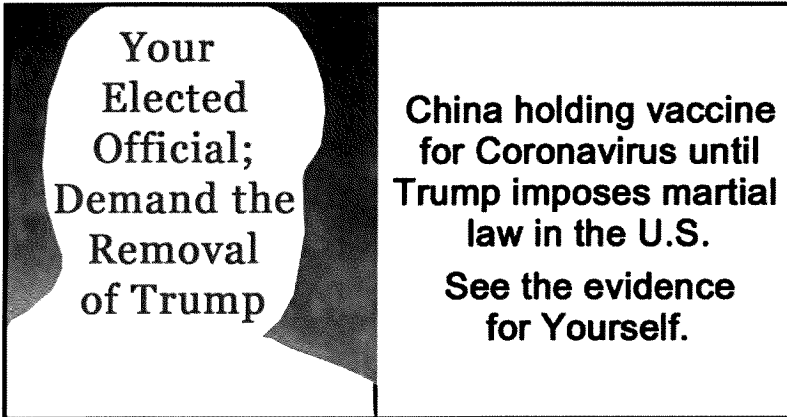

Can you say? "Yes, I believe President Trump is a Russian agent?" And can you say? "Please remove Trump from office? And, "I demand that Trump be removed from office." Now, can you speak (or write) these statements to your elected officials, all of them? . . . local, State, and federal? If you can, then we're on our way to removing him from office. It only takes a critical mass of people joining-in to accomplish this feat. It's not impossible, but if you talk yourself out of it, then we enter the realm of the unknown of never finding

out if he can be removed. For if enough people contacts Sen. McConnell, Rep. Pelosi, your governor, mayor, State legislators, city council members, etc., then it will happen. (I hope you demand the resignations of Pelosi and McConnell, too.)



Certainly with the herein evidence that China dispatched the Coronavirus (virus) for Trump, the intent-to-murder and murdering thousands of people, then you can understand the urgency, here. As the story goes, Donald Trump as a toddler used to spend time at the foot of his father, Fred Trump, at the office. Father Fred was a high-powered real estate developer, too. If so, then perhaps you see how young Trump identified closely with Father in developing the sense of

entitlement as well as power that he acquires. He sees himself in terms of power, of not being denied. This “classic narcissism” is why some say it may be difficult to remove him from office upon losing the 2020 election (keeping in mind that the election may not occur if he is allowed to declare martial law in the U.S.).

But what gets me is, as his presidency, who is that puts together his complex schemes, such as the Coronavirus scam that needs more than one man to pull it off. As discussed, the virus scam is very slick though the evidence still has too many holes in it. There is too much information missing from the complex timeline of the virus. -- And who is helping him stack the courts with young white men? Did he have the idea of removing CNBC's *Nightly Business Report* from the airwaves. Can he continue to ignore climate change?

In February '20, Mathew Dowd of *ABC This Week* naively asked, “What is Trump's strategy?” For those who observes Trump while not taking seriously what he says can see that his strategy is very simple, to weaken America wherever he can, to prepare us for Communist takeover. And, every bad thing that he projects onto his adversaries, he himself is doing those very things. That complex tactic is part of his con as well as his narcissism. For example, he calls the Democrats evil, yet he's the very one continuously lying and doing those evil deeds.

So again, where his narcissism makes him a simplistic, two-dimensional thinker, then who is planning his compli-

cated schemes? Please observe that whenever he returns from one of his frequent overseas trips, something terrible happens. Most recently after attending the *Jan. Global Economic Forum* in Switzerland, he ordered the Feb. 3 killing of Iran's Gen. Qasem Soleimani, leading to the subsequent brain injuries of over 100 U.S. service members in Iraq, an accidently downed jetliner killing 176 people, and the infectious virus outbreak into the U.S. There is too much coordination than to attribute all these disasters as random.

The “stacking the courts” with young white men, for upholding unconstitutional laws passed by Congress, appears on its face to come from longtime planning. Indicating a conspiracy between him, the Democrats, and Republicans.

Whereby, it stands to reason that Trump is indeed meeting his Communist comrades overseas to get instructions for his continuing exploitations. Even over the Jan. 28 weekend, he stated that due to the virus, he may not get to go overseas until this summer, indicating that he is very conscious of his overseas travel and looks forward to it. Though a forensic examination of his overseas movements would tell us a great deal, we can “circumstantially presume” he is receiving instructions from his overseas trips. For where he is a Russian agent, it makes perfect sense that he travels to meet his communist comrades.

Thus I am waiting for my fellow Americans to catch-up with me in realizing the imminent danger we're in. For if

the CDC is spreading the virus to halt the U.S. economy while the Fed continues to lower the prime interest rate, then the world will enter into economic depression. So we have to demand his removal from office now and not wait later for the November elections.

Cause 1: China's Missing Information Is Evidence of Dispatching the Coronavirus

(This scam requires the vaccine.)

OFFENSES: a. crimes against humanity; b. conspiracy; c. treason.

On Jan. 30, I faxed Sen. Joni Ernst (R-Iowa) identifying missing general information from China regarding the Coronavirus. **a)** What is its pathology (timeline & origin)? And **b)** what are its vulnerabilities? China is well aware of the vulnerabilities because currently the gov't is boasting a turnaround in infections that's returning people home from hospitals. Yet that information is not being shared to apparently allow other nations to fend for themselves. Moreover, the herein cumulative evidence points towards China having a vaccine, to demonstrate, as suggested to Sen. Ernst, that China dispatched the virus (**sent to the U.S.** and **elsewhere**) to create the opportunity for Trump to impose martial law in the U.S.

This evidence supports that the **CDC (Center for Disease Control)** is conspiring with Trump and China. On Feb. 4, [2020], NPR (*National Public Radio*) reported the U.S. gov't is limiting capability of how virus testing is carried-out,

and that the CDC is limiting the capability and quantity of the test kits.

The limited scope of the herein 4th Article-1 Petition does not investigate each unanswered question, but proposes that this "missing organic information" posed by the questions would include the timeline of evolution of the virus **under circumstances that the outbreak is accidental**. And the actions of the Chinese, U.S., and other gov'ts would follow an accident. But with that information of an accident missing, for example, we don't have China's record of the timeline. Presidential candidate Joe Biden raised this question of China's unshared information at the Feb. 25 presidential debate amidst Trump's silence on the information. -- For your *ready reference*, here are the 14 obvious questions again:

- 8)** Why isn't U.S. CDC delegating the virus to other U.S. research institutions?
- 9)** Why

is the U.S. vaccine research independent of China's vaccine research? **10)** CDC is propagating the "idea" of an epidemic in the U.S. that facilitates mysterious untraceable community infections. **11)** Why is the CDC restricting the quantity & capability of the COVID-19 test kits? **12)** Why is Trump not requiring this information from China? **13)** Why didn't Trump appoint an epidemiology expert to head this Coronavirus epidemic instead of VP Pence? **14)** Why isn't TV & radio used to train and update on the virus?

Cause 8 in the 2nd Petition (pg. 14) argues the need to require corporations to sell-off all broadcast media assets to become "independent broadcasters" so as to not be coerced into reporting biased stories and propaganda from corrupted gov't and corporate officials. This bias issue also regards the removal of the very popular 40-year broadcast of *Nightly Business Report* (NBR). Hence, today the broadcast media is endangering the nation by ignoring the above questions re: the missing information on the Coronavirus. I.e., the media is not asking these questions, of which clearly supports the conspiracy that China dispatched the virus for Trump to impose martial law in the U.S.



And it makes absolutely no sense that the U.S. is not broadcasting the vulnerabilities of the virus from Chinese data, so people can combat it before it can take root in the body. For example, today, China's epidemic is abating, yet they are not sharing their techniques with the U.S. or W.H.O. And whereupon this conspiracy is long planned, then the missing information makes perfect sense along with the silence of the Trump Administration. -- Recall the conclusion of the Robert Mueller investigation that he reported Trump made 100 contacts with the Russians during the 2016 presidential campaign. This routine contact, itself, is "probable cause" and evidence to remove Trump, proving without a doubt that he is a Russian agent.

Reinventing the wheel. And it makes absolutely no sense that China has not offered its forensic timeline and that the Trump Administration remains silent about receiving no such data from China. U.S. and W.H.O. doctors / researchers need these records on how long- and the investigative data on evolution thereof and the accruing research from China. Otherwise, the U.S. and other nations are simply "reinventing the wheel" that's stalling while the virus is spreading. Here again, this absence of data demonstrates that the virus was sent out by China.

• **China Has the Vaccine**

Now, if the virus is being perpetrated as shown above, then it further means China already has a vaccine for the cure. For the nation will not dispatch the

virus if it does not already have a vaccine to control it. The CDC has already reported that the COVID-19 strain is similar to the flu virus and easy to develop a vaccine.

For here again, China's epidemic is waning with the patients getting better, yet the nation **is not** revealing how the downturn is occurring. Our doctors should be in China and China's doctors should be here in the U.S. As asked, what are its vulnerabilities? How are Chinese patients getting better? For it's very likely they are given the vaccine, now that the virus has been [successfully] dispatched to the U.S.

• **Independent Researches Makes No Sense**

The independent researches between China and the U.S. further demonstrates the virus is being perpetrated around the world. For once again, it makes no sense that the U.S. and other nations are reinventing the wheel to find a vaccine but where China should be sharing its records and information to everyone. We all should be at the same point of China's data. But China is withholding this data that's allowed by Trump. Why?

• **Mysterious Community Infections Also Indicate Virus is Being Dispatched / Sent to U.S.**

You've heard the recent reports of the virus springing-up without the infected persons having connections to people coming from overseas. And these infections are happening rapidly (15 states reported on March 3). But the virus **cannot**

be created from nothing. It has to have a link to China. This, too, is material evidence that the virus is being planted.

And Trump's actions are further evidence. Last Friday he appointed VP Mike Pence to be in charge of the U.S. outbreak, not an epidemiology expert. This is ludicrous and shows Trump is 1) not taking the outbreak seriously, and 2) he is setting-up the nation for the virus to spread. This wanton negligence is more proof requiring his removal from office. -- During the Feb. 23 weekend, Trump scrapped plans by FEMA and the Dept. of Health & Human Services to set-up quarantine arrangements at a federal facility in Anniston, Alabama. Apparently Gov. Kay Ivey did not want the medical facility in her State, though quarantine facilities should be set-up in all States, constantly training, and on-the-ready if needed to receive patients. Here, Trump wavering on what needs to be done demonstrates again that he is not taking the virus seriously and thus leaving the nation in danger of its spreading among us.

On Mar. 4, NPR again reported on suspicious CDC behavior. People are sent home prior to the tests determining positive or negative results. Last week, a whistleblower reported the CDC sent a medical team of twelve to meet and process passengers from China. The team was not trained or given protective clothing.

The fact that the CDC is working alone without other medical institutions is suspicious, too. It seems to be trying to keep the public communications confined

to its specific messaging. This would help to explain the many mysterious “community infections” (discussed above) that don’t have a link to the overseas infections. Once again, the virus cannot come from thin air. -- We should ask Director of the CDC, Dr. Robert Redfield, “Is the CDC working with Trump to spread the virus?”

• **Updates & Training the Public with Television & Radio**

Using the broadcast airwaves to put-out information on the virus is the quickest and most efficient way to get critical updates out to the public. Why isn’t this being done? And is it being done in China and other nations?

These are opportunities to get specific details to people, such as: how the virus is transmitted; techniques for self-quarantine; locations of local healthcare authorities who are handling infected people; the operating hours / closures of major businesses & institutions; school closings; updates on related events, etc.

Local broadcast stations, TV & radio, can alternate in dedicating station facilities to “virus programming,” non-stop, until alternating with the next assigned station.

Here again, the fact that these fundamental, common sense arrangements are not being made demonstrate, too, that the Trump Administration is perpetrating the spread the virus, as is the case.

CONCLUSION:

With the missing general information from China that would set today’s reality on a different course, the evidence is overwhelming that China sent-out the virus for Trump. China would have a vaccine for this scheme as indicated by the turnaround in cases on its mainland. This conspiracy between both the nations’ presidents require their removal from office and to be prosecuted.

At the very least, U.S. authorities and other nations should require Trump and Chinese President Xi Jinping to answer these questions with an examination of China’s documents on the virus. But with the evidence of missing general information on the virus, the nation cannot afford to allow Trump to stay in office. We have to demand his removal since he is acting to destroy America as we know it.

The likely scenario is if Americans don’t act to remove Trump, the virus will continue to spread at his behest, he will declare martial law amidst the confusion of orchestrated chaos, and then the vaccine will be revealed to diminish the infection rates around the world. 2. Americans Must Stop the Low Interest Rates That's Destroying America

(Coronavirus & low rates will cause economic depression.)

OFFENSE: a. Treason

For those who do not yet understand how low interest rates and the **other two bad economic policies** are causing the top-heavy, imbalance, transfer-of-wealth to Wall Street, then you have to look at **the totality of what's not there** but is suppose to be there. For the transfer-of-wealth has everything out of whack. Wall Street is saturated with so much cash that it doesn't know what to do with it. It's running around buying-up everything that force prices to rise while most everyone in the "commercial sector" (poor to upper middle class) is struggling. (The upper middle class is struggling by paying too many taxes, like everyone else, and too high property values.)

This totality of not enough cash = rising homelessness / poverty; food insecurity; tight credit; troubled Social Security; high home prices; high rents; constantly rising gov't taxes & fees; tight gov't budgets & borrowing; gov't program cuts & terminations; healthcare debt; business closings; school budget deficits; education; teacher salaries; low economic growth; pension funds; facilities infra-

For those not familiar with the root causes, it's intuitive to separate these crises into separate problems for analysis and conclude that each must have a separate cause and solution. Usually, gov't officials' impulsively move to raise taxes again-and-again though cash shortages continue to occur. But in fact, each of these problems has the same core cause. I.e., through the Federal Reserve, the transfer-of-wealth removes currency from the commercial sector so that there's never enough cash to go around for everyone else, for regular people.

This problem is illustrated in Figures 1 & 2, attached. In Figure 1, the Federal Reserve (**Fed**), through three bad policies, is improperly sending currency directly to Wall Street and foreign investors. However, Figure 2 shows that the Fed must legally distribute all currency thru the "commercial sector" for the communities' "more equal access" to dollars. (In the commercial sector, dollars reach maximum value thru exchanging hands (contracts). This is also called monetizing the dollar. The same as with holding gold & silver, you want your dollars to have maximum value.) Dollars cannot reach maximum value when sent directly to Wall Street from the Fed.

When the three policies are reversed, as depicted in Figure 2, all currency must flow into the commercial sector thru commercial banks and then pushed out into communities where investors must com-

pete with everyone else in the same commercial environment. This was the wholesome situation prior to May 2, 2008.

The three policies causing this problem are explained below:

1. The Federal Reserve (Fed) must stop issuing wholesale loans / money to investment banks.

These loans violate **Section 13**, clause 2 of the U.S. Federal Reserve Act of 1913, that so states:

“Powers of the Federal Reserve Banks . . . shall not include notes, drafts, or bills covering merely investments or issued or drawn for the purpose of carrying or trading in stocks, bonds, or other investment securities, except bonds and notes of the Government of the United States . . .”

Note: “. . . bonds and notes of the Government. . .” refer to treasury bills, bonds, & notes.”

The ENA (Economic Normalization Act) bill proposed to Rep. John Yarmuth will reverse the Fed’s unlawful May 2, 2008 decision to loan money directly to investment bankers and investment firms (Merrill Lynch, Berkshire Hathaway, Vanguard, Etc.). -- Everyday in the news you hear about “venture capitalists” buying-up some business that then skyrockets the prices on consumers, such as ambulance services, air ambulances, agricultural land, real estate, retail chains; you name it.

Much of that money comes from the Fed in violation of Section 13, of the U.S. Federal Reserve Act.

Correcting this abuse will stop these wholesale dollars going to Amazon, Apple, Facebook, Etc., that’s removing \$trillions from commercial competition and escapes dollar \$valuation. Today’s cheap money going to these firms is why they grow so fast, even in a no-growth economy for the past twenty years, at the expense of consumers paying ever-higher taxes. These companies are required to borrow from commercial banks (or private lenders) the same as all other Americans. **Section 13** equalizes the distribution of Fed currency / wealth.

2. Avoid the next depression; reinstate the Glass-Steagall Act of 1933.

Glass-Steagall was repealed (removed) in 1999. The Act was passed during the Great Depression to stop wealthy carpetbaggers from placing consumer bank accounts at-risk. Reinstating Glass-Steagall will once again shield consumers from carpetbaggers to allow foreigners and citizens to again safely deposit money into U.S. banks. Upon doing so, commercial banks fill-up with this cash and push it out into the communities, requiring less money to be borrowed from the Fed. Restoring this “missing economic activity” increases tax revenues to reduce gov’mts debt, too, which would slow the cycle of tax hikes. **(Reversing all three policies will stop the cycle of tax hikes.)** — Also, reinstating Glass-Steagall will com-

pel commercial banks to demand “normalized rates” from the Fed since the pressure for low rates from carpetbaggers will end. In-turn, the competitively higher rates will help regular Americans to again earn from their savings. -- Certificates-of-deposits will be in demand again.

3. The Fed must end the deceptive low interest rates policy and increase rates to normal, competitive level.

Donald Trump, Wall Street, and its politicians are committing treason when rallying for low rates. As historically shown since 1999, the economy cannot grow with low rates. So it's only a matter of time that China will overtake the U.S. economy.

On Mar. 3, 2020, the Fed again lowered the prime rate, by .5% to 1.25%. This will further reduce economic activity and lead to economic depression if Trump succeeds in spreading the Coronavirus for not acquiring the vaccine from China.

{The Coronavirus will stop many trade and supply routes that can bring down the economy. But a competitively higher interest rate keeps currency flowing into the economy to minimize the effects of the virus disruptions.}

These are not theories, but are sound economic principles proven again and again prior to 1999 during the Clinton years of the booming economy. Americans have lost their memory of what makes the economy work. Competitively higher rates attract currency / investments into the

economy while low rates chases money out of the economy in search for higher rates.

Attached Figure 3 shows confusing terminology from a Bing.com search for the current Federal Reserve (Fed) prime interest rate. As stated, the Fed rate was lowered on Mar. 3 to 1.25%. The terminology is interesting because it suggests or implies that the rate is 4.75%, of where it should be, or higher. It means the U.S. gov't understands very well that the current rate policy of low rates is improper, acting against the growth of the economy. -- **I.e., the gov't understands that it's deceiving the public with destructively low rates.**

Investors / companies enjoy low rates because they can issue low-cost short-term and long-term debt. That is why they are always railing to reduce interest rates and with the **false premise** that it's better for the economy. Yet when Fed Chairman Jerome Powell increased the prime rate to 2.5% from 2017 to 2018, the economy actually grew. This is because as rates rise, commercial banks earn more money from consumer loans that increases economic activity, as investors reduce their borrowing to reduce loan costs at the higher rates. During the last 19 years of low rates, the U.S. economy suffered from **low growth & high debt** due to low rates, of which is why Congress must mandate prime interest rates be normalized (raised to competitively match or above China or India's prime rate).

Even when the economy slows, interest rates should be raised accordingly because it attracts money into the economy, including more purchases of treasury bills and bonds that reduces debt / borrowing from the Fed. — Whereas yesterday, Fed policy was hardly mentioned to the public. But today, politicians are using the Fed to “scam the system” against the interests of Americans. As discussed, low rates are why Gov’t is constantly borrowing that forces increases in tax hikes. Reversing these three policies will stop these debt cycles.

Because Gov’t is deceiving Americans about these economic policies, citizens have to have confidence in their own reasoning abilities to understand these basic principles for themselves. For today, we are being guided by the devil. The toxic mix of low rates and Coronavirus can only lead to economic depression that will end the world’s faith in the U.S. dollar.

To save our nation, we have to demand Trump be removed from office and, as described, that these three policies be reversed .

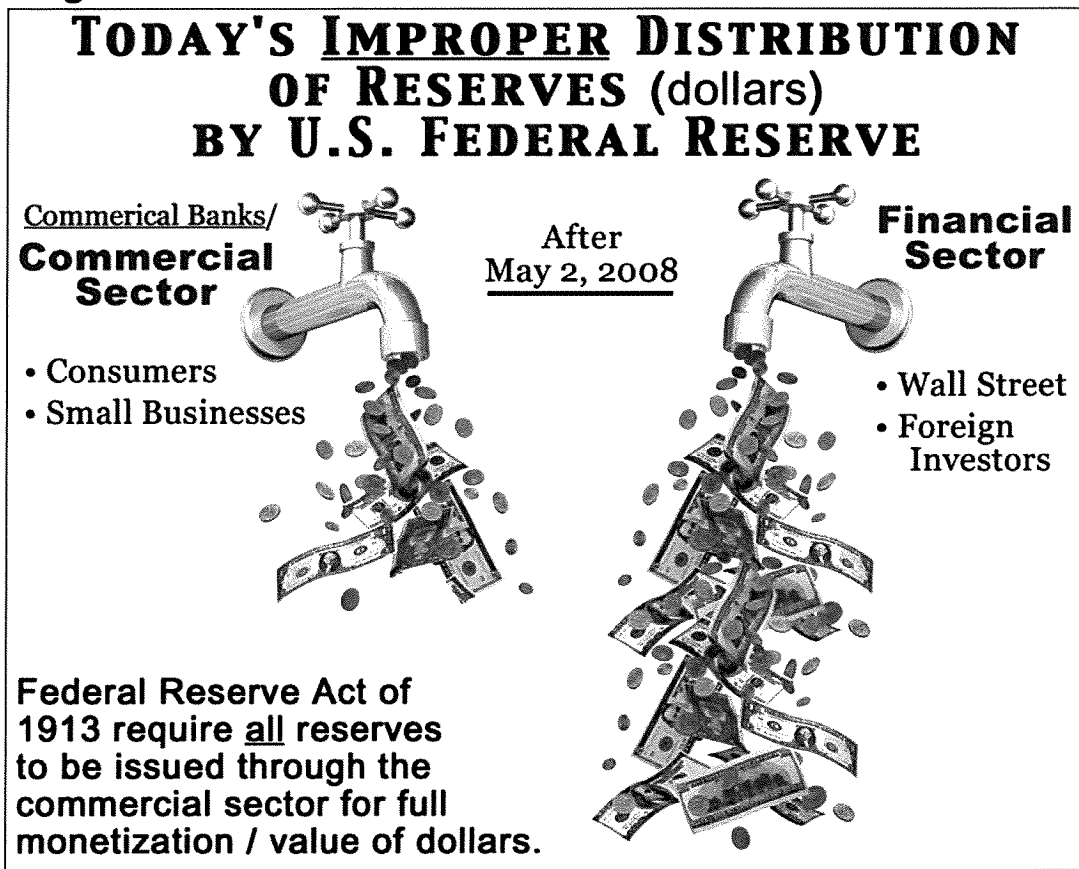
