Commissioner Butler asked Jennifer about the safety of the pedestrians walking down the streets. Jennifer stated that she didn't think pedestrians would want to have sidewalks with steep slopes; however, pedestrians would rather have flat surfaces to walk on.

Commissioner Blake asked Julia, if she would change anything in her staff analysis. She stated that she would change B & E. She would change B because providing some portion of sidewalk would be provisions for safety for pedestrians. She would change E so that it would read to be less negative. She indicated that by providing a portion of the sidewalk the plans were more in compliance with the Comprehensive Plan as opposed to the previous proposal of no sidewalks.

WHEREAS, the Louisville Metro Land Development & Transportation Committee finds, the removal of the sidewalk will not affect the natural resources within the proposal.

WHEREAS, the Louisville Metro Land Development & Transportation Committee further finds the removal of the sidewalk prevents safe and efficient pedestrian transportation to and from Eastwood Cutoff Road. Eastwood Cutoff Road connects to Shelbyville Road where there are non-residential uses and zoning.

WHEREAS, the Louisville Metro Land Development & Transportation Committee further finds, the removal of the sidewalk will not affect open space.

WHEREAS, the Louisville Metro Land Development & Transportation Committee further finds, removal of the sidewalk will not affect drainage.

WHEREAS, the Louisville Metro Land Development & Transportation Committee further finds, the overall site design is not changing and has proven to be compatible via previous development plan approvals. However, the removal of the interior sidewalk

reduces the compatibility of the site with future development as this site will no longer provide a safe connection for its residents to walk to other developments.

WHEREAS, the Louisville Metro Land Development & Transportation Committee further finds, while the sidewalk is not required by the Land Development Code it was provided on the development plan as a tool to comply with the Comprehensive Plan for the PRD zoning change. Not providing the sidewalk takes the site out of compliance with the circulation guidelines of Cornerstone 2020.
