FOR PROGRAM EXPENSES ASSOCIATED WITH CONDUCTING THE "SPIRIT OF THE DRUM." (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of $\$ 17,50015,00016,500$ is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 each-from Districts 1-5; $\$ 2,500$ from District 5; $\$ 1,000$ each from Districts 2, 3, 4, and 6; $\$ 500$ each from Districts $\underline{\underline{\text { __}}} 9,10,13,14,15$, and 21; and $\$ 250$ each from Districts 12, 16, 17 22, 24, and 25; through the Office of Management and Budget, to River City Drum Corp Cultural Arts Institute, Inc. for program expenses associated with conducting the "Spirit of the Drum."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
