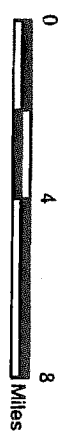
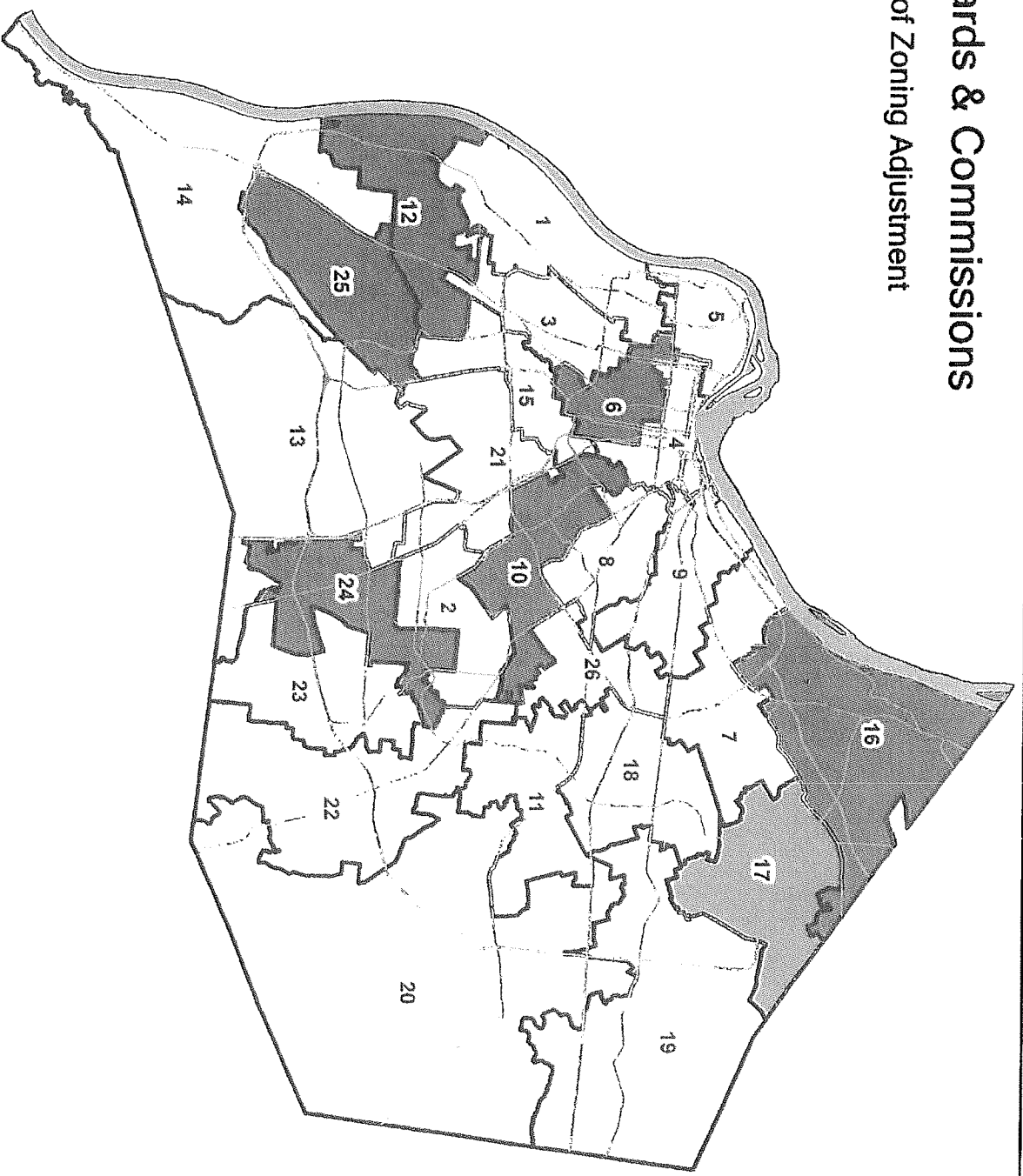

STATUTORY AUTHORITY	KRS 100.217, 100.221
ORDINANCE AUTHORITY	LMCO 32.850
NUMBER OF MEMBERS	7
HOW APPOINTED	By Mayor with approval of Council
EX OFFICIO MEMBERS	None
QUALIFICATION OF MEMBERS	Not more than two (2) members of the Board may be citizen members of the planning commission.  Must reside in Jefferson County.
COUNCIL APPROVAL OF APPOINTMENT	Yes
COMPENSATION	Reimbursement for expenses or compensation or both may be authorized for members on a board of adjustment.
TERM OF APPOINTMENT	3 years and until their successors are appointed and qualified.
VACANCY APPOINTMENT	Vacancies filled by Mayor within 60 days of the vacancy. After that, Planning Commission appoints member to fill vacancy.  When a vacancy occurs, other than through expiration of the term of office, it shall be filled for the remainder of that term.

REMOVAL	By appointing authority for inefficiency, neglect of duty, malfeasance, or conflict of interest. The appointing authority must submit a written statement to Commission setting forth reasons for removal. Member removed has right of appeal from removal to Jefferson Circuit Court.
POWERS	To hear and decide applications for conditional use permits; subpoena witnesses; hear and decide applications for variances; nonconforming use issues hear appeals of any decision from a zoning enforcement officer.
BONDING AUTHORITY	No
RECORDS/REPORTS	Must adopt bylaws for the transaction of business and keep minutes and records of all proceedings, including regulations, transactions, findings, and determinations, and the number of votes for and against each question. A transcript of minutes must be provided when requested. Paid for by requesting party.
PURPOSE	The power to hear and decide cases where it is alleged by an applicant that there is error in any order, requirement, decision, grant, or refusal made by an administrative official in the enforcement of the zoning regulation.
MEETING	8:30 on first and third Monday of each month as set out in Bylaws.
