A clerical error has been found in Ordinance No. 027, Series 2020 as described below.

Ordinance No. 027, Series 2020 is "AN ORDINANCE AMENDING ORDINANCE NO. 115, SERIES 2017 AND ORDINANCE NO. 081, SERIES 2019 RELATING TO FISCAL YEARS 2017-2018 AND 2019-2020 CAPITAL AND OPERATING BUDGETS, RESPECTIVELY, BY TRANSFERRING \$11,000 FROM THE DISTRICT 6 CAPITAL INFRASTRUCTURE FUND TO THE DISTRICT 6 NEIGHBORHOOD DEVELOPMENT FUND."


Ordinance No. 027, Series 2020 (1) was assigned to the Appropriations Committee on February 18, 2020 at Committee on Committees; (2) had its first reading on February 20, 2020 at the Metro Council meeting under New Business; (3) was recommended for approval on February 26, 2020 at the Appropriations Committee; and (4) was passed on March 5, 2020 at the Metro Council meeting on the Consent Calendar. This was all done in reference to the \$11,000 amount.

An incorrect copy of Ordinance No. 027, Series 2020 that stated the amount being transferred as \$5,000 was sent to Mayor Fischer and he signed it on March 9, 2020.

The amount should have clearly been \$11,000 as stated in every meeting in which it was read and discussed. Therefore, to correct this clerical error, the correct version of Ordinance No. 027, Series 2020 is being sent to both Council President James and Mayor Fischer to be signed. The date in which it was read and passed will remain as March 5, 2020 but the approval date, which reflects the date that Mayor Fischer signs it, will correspond with the actual date that he signs the corrected version of the Ordinance.

All actions taken since March 5, 2020 remain in effect.






