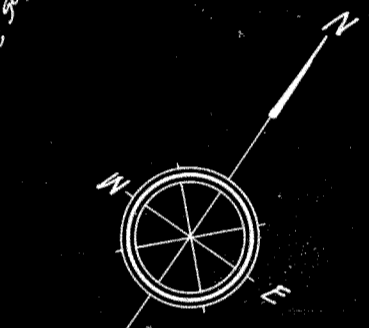
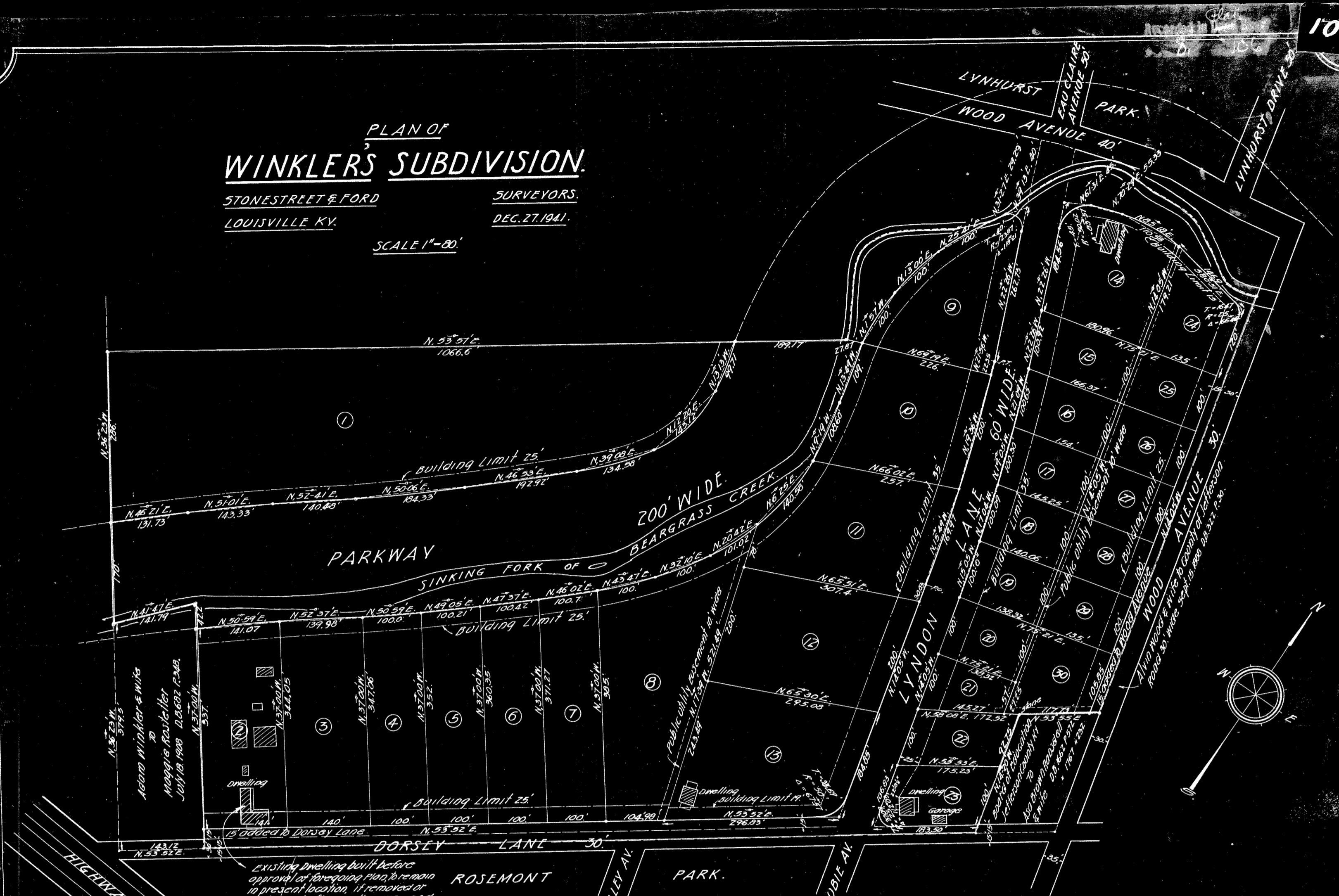


PLAN OF WINKLER'S SUBDIVISION.

An easement for public utilities is hereby reserved on, over, under and within the strips and spaces upon this Plan defined and bounded by dotted lines and marked "Public Utility Easement" to "include the right to the utility companies to remove and trim trees on said easements and the branches of trees overlapping the same and to dispose of any other obstruction thereon to the extent that it may be necessary for the proper installation, operation and maintenance of public utilities within said strips and spaces.
