ORDINANCE NO. <u>69 °</u>, SERIES 2017

AN ORDINANCE APPROPRIATING \$10,500 \$11,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 21; \$500 EACH FROM DISTRICTS 1, 2, 4, 5, 6, 9, 10, 12, 13, 15, 25, AND 26; AND \$250 EACH FROM DISTRICTS 3 AND 14; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO KENTUCKIANA PRIDE FOUNDATION, INC. FOR COSTS ASSOCIATED WITH THE KENTUCKIANA PRIDE PARADE, CONCERT, AND FESTIVAL. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$10,500 \$11,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 21; \$500 each from Districts 1, 2, 4, 5, 6, 9, 10, 12, 13, 15, 25, and 26; and \$250 each from Districts 3 and 14; through the Office of Management and Budget, to Kentuckiana Pride Foundation, Inc. for costs associated with the Kentuckiana Pride Parade, Concert, and Festival.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
