Call to Order

Bipartisan Infrastructure Law - Jeff O'Brien, Develop Louisville

Jeff O'Brien, Develop Louisville, gave a presentation.

The following was discussed:

- The Bipartisan Infrastructure Law ("BIL") is a \$1 trillion federal bill that covers roads, bridges, trenches, water service, broadband, and anything else related to infrastructure
- Two general pots of funding - the first is the Competitive Grants which comes from federal funding, and the second Formula Funding which comes through Surface Transportation Block Grant Program
- Kentuckiana Regional Planning and Development Agency ("KIPDA") administers the Surface Transportation Block Grant Program
- Most BIL programs require a local match - usually 20% for the formula funds
- Question about where the medium size projects are cataloged and prioritized
- Move Louisville's first project was called "Fix It First" and it was to pave streets
- Question about which grants Metro Government anticipates receiving
- The match dollars must come from Metro Government's general fund or State Highway funds
- The East Market Street project will cost \$10 million
- Metro Government will be looking for projects between \$50 million and \$100 million in the Competitive Grants program that will require a high match from the State of Kentucky
- The Formula Funds that come through KIPDA will be focused on the projects that cost \$5 million to \$8 million
- Question about the community's capacity to meet its needs
- Questions about the bridge projects and their funding
- Develop Louisville will apply for a planning grant to connect the eastern and western neighborhoods on Broadway
- Question about whether there is a software package that stores all the projects
- Questions and concerns about the Plantside Drive project, and whether it is a City of Jeffersontown issue or not
