- Working and partnering with others to provide free public services for all Louisville residents
- The two Financial Navigators are long time counselors, they cannot provide financial assistance
- The Financial Navigators will answer phones, provide financial structure and guidance, identify immediate action steps and make referrals to other services
- The money allocated is for the two Financial Navigators
