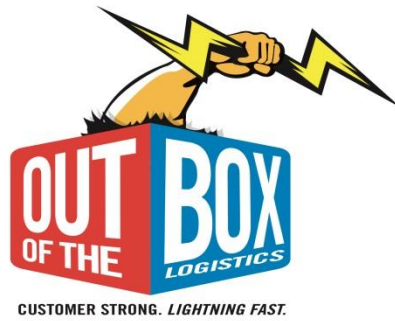

Benefits of the Metro Outsourcing Interoffice Mail delivery to Bee Line Courier Service


- ✓ Each site for Louisville Metro will be provided a “mail code number” for accurate on time delivery.
- ✓ Implementation of “mail code numbers” eliminates a large percent of interoffice mail delivered to the Metro mail room, mail codes will allow Bee Line couriers to deliver mail from one site sending to another on his or her route.
- ✓ Metro sites Bee Line provides service will need mail baskets at an assigned location within the department/suite. Baskets labeled **Incoming Interoffice mail, Outgoing Interoffice mail, USPO mail (with postage stamp) United Mail (mail to be metered)**
