Please consider this letter as our official Statement of Cost for all speed hump related work. Each speed hump, including markings is \$2,950.00 and each sign is \$200.00. Based on our Engineering Studies, a total of two (2) speed humps and two (2) speed hump signs have been proposed for Lambert Avenue, between Sanford Avenue and Buechel Bank Road.
