## Penny,

Thank you for taking the time to express your questions and concerns regarding this proposed development. I will add your message to the file and forward it to the applicant, who may be able to answer some of your questions that I do not have the information on. Any concerns you wish to express can be submitted to me via email, and it will go into the file and be available for review by the Planning Commission prior to any hearing.

I do not have any additional information on "Sunshine Builders" and I am not familiar with them or their portfolio. My understanding is that the development would be for standard market rate apartments. As far as the meeting you reference, that was not a meeting required by the Land Development Code but was rather a voluntary meeting by the developer to talk to neighbors and listen to concerns. Since it was outside any Metro regulations I don't have detailed information on that meeting. I attached the mailing labels submitted by the applicant, as well as the most recent development plan, elevations, and the applicant's Comprehensive Plan compliance information. A public meeting will still have to be held prior to approval of the plan and that has not been scheduled

at this time.
