**Steve** will provide a cost estimate to construct a new sidewalk along both sides of S 45<sup>th</sup> St between Garland & Greenwood. Steve – please provide a breakdown of cost for each side.

Below is the estimate for a new sidewalk along South 45<sup>th</sup> Street from Garland Ave. to Greenwood Ave. I looked at both sides of the street. The west side seems most appropriate for a new sidewalk. The east side presents many more problems like a small berm, more trees, exist. concrete steps and more.....you guessed it.....utility poles.

New sidewalk on the west side of South 45<sup>th</sup> Street would cost **\$90,000**. This would enable us to connect up the existing sidewalks from Riverview & Westchester Aves.
