- Questions were asked regarding where SOS gets their medical supplies from -- hospitals, clinics, and gently used donations from every day people -- examples were provided
- All bio-medical equipment received from hospitals are tested by Bio-Medical Engineer's prior to deployment -- examples of the bio-medical equipment were provided
- At the on-set of the COVID-19 Pandemic, SOS was providing ventilators to the local hospitals in Louisville
- Personal experiences were shared
- Questions were asked regarding whether the hospitals and medical institutions are aware of SOS and their efforts -- SOS collects from all of the larger hospitals locally such as Baptist East, Norton, and University of Louisville
- Thanks was given to SOS for all of their efforts within the community
