Equity, Community Affairs, Housing, Health, and Education Committee - THIS MEETING IS BEING HELD VIA VIDEO TELECONFERENCE

We will be starting in about 30s. This is the equity, community Affairs, housing, Health and Education Committee. I am the chair, COUNCILWOMAN Marva Shanklin, COUNCILMAN. And item one is a resolution authorizing the mayor to accept \$59,357.92 of funding from the U.S. Department of Agriculture through the Summer Feeding Service Grant program, to be administered by the Department of Public Health and Wellness. Read in full. Thank you. We have a motion.\r\n\r\nWe have a motion a second. I'll read. Do we have someone from the mayor's office? Okay. Hi. My name is Sierra Warren. I am the administrator in the Environmental Health Division at Louisville Metro Public Health and Wellness.\r\n\r\nI'm here today to talk about our 04526 a resolution to accept the \$59,357.92 from the usda through the Kentucky. Sorry. Kentucky Department of Public Health. These grant funds were awarded to the Health Department for fulfilling food safety inspections last summer, and will be spent to offset costs of the program, including mileage for the inspectors, computer hardware and uniforms. i'm happy to answer any questions you MAY have. Thank you. I notice this had the summer feeding program, right?\r\n\r\nSo, yes. Where does what do they feed school kids? Yes. Under 18. So families and children in Jefferson County. So there's multiple, you know, 100 plus locations throughout Jefferson County. Some are set up at schools, parks, churches, and families can come there and get and get meals for their, their children for the summer up to 18, under 18, under 18. Yes. Okay.\r\n\r\nThank you. Does anyone else have any concerns? Okay, COUNCILMAN Sam. Thank you, MR. Chair. Where are these feeding locations in South Louisville. I will have to get you the list.\r\n\r\nThey change sometimes year to year, but they do. A handful of JCPs schools, community centers, parks. I can get you the list if you is online. Sure. Thank you. Yep. And they're just starting again.\r\n\r\nThey just put out the list for this summer just yesterday. Thank you. Okay. Any more? Any more discussion? I see COUNCILWOMAN Hopkins is here now.
