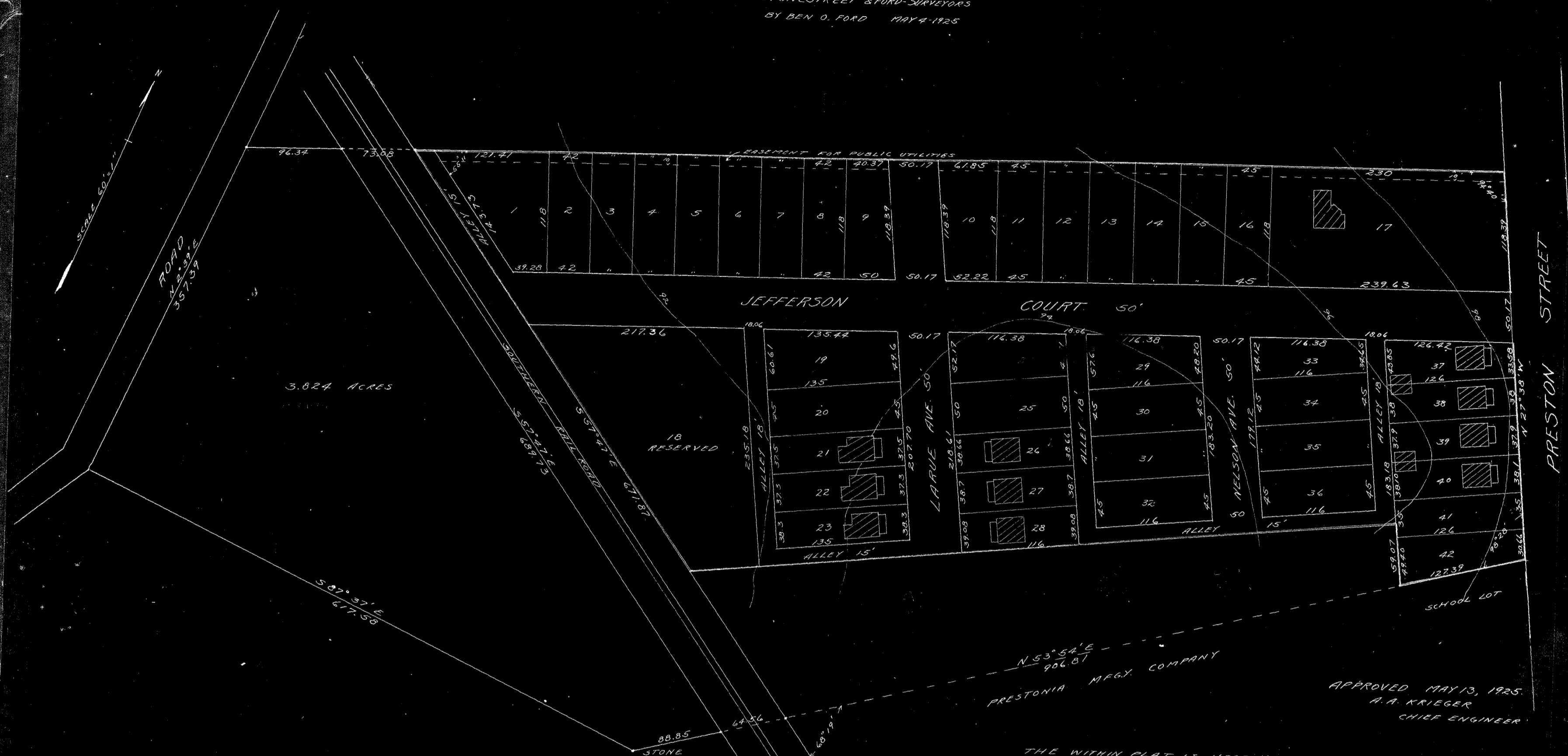


PLAN OF CARDINAL SUBDIVISION
