I would suggest to have the Mckinley farm set a new 4'-5' square wire fence and gate around the new established boundary .
This should not be to much of a problem for the family .
I do not believe from my observation and training that there would not be any associated graves beyond the top of a slight ridge line that is coincident with several mature trees and the remains of the fence in the trees.
Also it appears that the general direction of burial is Head west Feet east .
This would also be within the tradition of the day.
Several stones lye along the West edge where there is a clearly defined fence on an adjacent property line.
So I would expand the present boundary 15' North & West, not East.
Place a 35' buffer around the North and West Boundary line.
I will request that no additional Right-of-Way be dedicated along the front of the cemetery because there are a couple of possible stones near the edge of pavement.

He found fencing along the north and east sides but not really the west. He proposed setting the boundary 15 ft beyond where it seems to end and then establishing the buffer from that. He's also going to talk to Transportation about not dedicating ROW along the road frontage to the south. Richard, did I miss anything?
