>> THANK YOU, MADAM CLERK. FOLLOWING THIS MORNING 1427

LOUISVILLIANS HAVE DIED AND 101,591 DIAGNOSED WITH COVID-19.

THREE PEOPLE HAVE DIED SINCE WE MET TWO WEEKS AGO. THAT IS 44

MORE FAMILIES THAT ARE MOURNING THE LOSS OF A MOM, DAD, BROTHER,

SISTER, CHILD. WE'RE STILL IN THE RED ZONE HERE IN LOUISVILLE

AND EXPERIENCING A SHARP INCREASE IN CASES ESPECIALLY AMONG OUR

CHILDREN. WE'RE STILL IN THE RED ZONE HERE IN LOUISVILLE AND

EXPERIENCING HEALTH CARE WORKERS ARE EXPERIENCING IT. OUR

HOSPITALS ARE DESPERATELY ASKING THAT WE GET VACCINATED. I

CANNOT STRESS, STRONGLY ENOUGH, HOW IMPORTANT IT IS FOR EACH OF

US TO GET VACCINATED AND ENCOURAGE OTHERS TO BE VACCINATED AND

TO WEAR MASKS. PLEASE JOIN ME NOW IN A MOMENT OF SILENCE, FOR

THOSE THAT WE HAVE LOST. THANK YOU. COUNCIL MEMBER HOLLANDER? I BELIEVE YOU HAVE TWO, VERY VERY SPECIAL PROCLAMATIONS TO PRESENT?

>> THANK YOU PRESIDENT JAMES. AS MEMBERS KNOW, I DON'T DO THIS VERY OFTEN. BUT TWO PEOPLE WHO I ADMIRE A LOT AND TWO ORGANIZATIONS THAT I ADMIRE A LOT ARE GOING THROUGH CHANGES. WE HAVE TWO RETIREMENTS IN THE COMMUNITY OF PEOPLE WHO HAVE BEEN SERVING VERY, VERY IMPORTANT ORGANIZATIONS HAD THE COMMUNITY. THE FIRST IS DARE TO CARE. I WON'T SAY, THAT AS WE HAVE GONE THROUGH THIS PANDEMIC, WE HAVE SEEN MORE NEED FOR FOOD ASSISTANCE THAN WE HAVE EVER SEEN IN THIS COMMUNITY AND ACROSS THE COUNTRY. I LIVE ON A STREET WHERE EVERY SATURDAY AFTERNOON, I LOOK OUT OF MY FRONT DOOR AND SEE A LINE OF PEOPLE LINED UP AT A CHURCH. AND IT HAS MOVED TO OUTSIDE TO KEEP PEOPLE SAFE DURING THE PANDEMIC. AND I TRY TO JUDGE HOW DEEPLY WE ARE INTO THE FOOD INSECURITY BY HOW LONG THAT LINE IS. AND THE LINE IS STILL THERE. EVERY SATURDAY. SO. AS BRIAN RIENDEAU WILL COME UP, IS RETIRING AFTER A NUMBER OF YEARS, AS EXECUTIVE DIRECTOR OF DARE TO CARE, HE'LL TALK A LITTLE BIT ABOUT HIS RETIREMENT, AND ABOUT THE ORGANIZATION AND HOW IT WILL BE MOVING FORWARD BUT I DID WANT TO RECOGNIZE HIM TONIGHT AND READ THIS PROCLAMATION. WHEREAS BRIAN RIENDEAU JOINED DARE TO CARE IN MAY, 2009 AND REVENUE NEARLY TRIPLED DURING BRIAN'S TENURE, ALLOWING THE ORGANIZATION TO MEET A GROWING NEED, HEIGHTEN NUTRITIONAL

QUALITY OF ITS FOOD, BRING NUTRITION EDUCATION TO THE COMMUNITY,  
AND LAUNCH INNOVATIVE PROGRAMMING INCLUDING THE 0 HUNGER MOBILE  
MARKET IN A COMMUNITY KITCHEN IN PARKLAND. WHEREAS DARE TO CARE  
PARTNERS WITH MORE THAN 200 NONPROFIT ORGANIZATIONS THROUGHOUT  
THE AREA, WHEREAS UNDER BRIAN'S LEADERSHIP, DARE TO CARE  
INCREASED FOOD DISTRIBUTION BY 150%, PROVIDING FOR 23 MILLION  
MEALS IN 2020, REACHING MORE STRUGGLING FAMILIES AND CHILDREN,  
THAN AT ANY TIME IN IT'S 51-YEAR HISTORY. THOUSAND, THEREFORE,  
THE MOBILE METRO COUNCIL RECOGNIZES BRIAN RIENDEAU AND THANKS  
HIM FOR EXEMPLARY SERVICE TO THE COMMUNITY.

>> THANK YOU, COUNCIL MEMBER HOLLANDER. I HAVE TO SAY THIS AWARD  
IS UNEXPECTED BUT CERTAINLY APPRECIATED. I WON'T TAKE LONG. I  
JUST WANTED TO RECOGNIZE A COUPLE FOLKS. FIRST OF ALL, AS ALL OF  
YOU KNOW, ANY ORGANIZATION IS ONLY AS GOOD AS THE PEOPLE IN IT.  
YOU'RE BLESSED. THIS COMMUNITY IS BLESSED TO HAVE THE FINEST  
FOOD BANK STAFF IN THE COUNTRY. I WORK WITH 200 OTHER FOOD BANKS  
AROUND THE NATION. I CAN ATTEST THIS IS THE FINEST STAFF IN THE  
COUNTRY. SOME ARE HERE TONIGHT. WHILE I AM HERE TO ACCEPT THIS  
AWARD, THE WORK THAT GETS DONE EVERY DAY IS DONE BY 63  
DEDICATED, PASSIONATE FOLKS THAT SHOW UP EVERY DAY AND GET THE  
JOB DONE. SECONDLY. I WOULD BE REMISS IF I DIDN'T THANK ALL OF  
YOU ON COUNCIL. THE COUNCIL HAS BEEN A UNIQUELY STRONG PARTNER  
OF DARE TO CARE DURING MY TENURE. AGAIN, I'LL TALK ABOUT THE  
OTHER FOOD BANKS I ASSOCIATE WITH ASH THE COUNTRY. FEW, IF ANY

SHARE THE TYPE OF SUPPORT THAT WE RECEIVE FROM YOU. THAT SPECIAL AND HAS ENABLED TO US DO A HECK OF A LOT AND THE COMMUNITY FAR BETTER BECAUSE OF IT. I JUST WANT TO CLOSE WITH THAT AND I WANT TO CLOSE BY REMINDING YOU AS COUNCIL MEMBER HOLLANDER SAID. OUR WORK NOT DONE. COVID HIT US HARD AND REVERSED THE DOWNWARD TREND WE WERE SEEING PRIOR TO COVID. WE'RE NOW SEEING RECORD LEVELS OF NEED IN THE COMMUNITY. SO, WHILE I'M STEPPING AWAY, THE ORGANIZATION IS GOING TO BE IN GREAT HANDS WITH CHIEF JAMES AND I WOULD JUST ENCOURAGE ALL OF YOU TO PLEASE CONSIDER, CONTINUING TO SUPPORT DARE TO CARE AS THE ORGANIZATION MOVES FORWARD. THANK YOU.

>> DON'T GO AWAY. COUNCIL WOMAN?

>> THANK YOU. I JUST WANT TO SAY THANK YOU FOR ALL OF YEARS WE'VE WORKED TOGETHER. I ENJOYED WORKING WITH YOU AND HOPEFULLY, I CAN CONTINUE TO WORK WITH DARE TO CARE ON BEHALF OF OUR CHURCH AND IT'S BEEN A BLESSING. JUST WANT TO LET YOU KNOW I'M GOING TO MISS YOU.

>> THANK YOU, COUNCIL WOMAN. COUNCIL MEMBER PURVIS?

>> THANK YOU. I JUST WANT TO SAY, BRIAN THANK YOU FOR CONTRIBUTIONS YOU'VE MADE IN SUPPORTING PEOPLE THAT ARE NEEDY. PEOPLE THAT ARE JUST, LET'S SAY WHAT IT S HUNGRY. THEY CANNOT AFFORD TO FEED THEMSELVES AND THEIR FAMILIES. I REMEMBER THE EVENING A FEW YEARS AGO YOU WERE SO WARM AND PASSIONATE AS WE

HONORED THE REASON WHY DARE TO CARE STARTED. THAT STORY WILL LIVE WITH ME FOREVER. AND I JUST WANT TO SAY, THANK YOU, SO MUCH, FOR ALL THAT YOU'VE DONE. YOU'RE A TRUE PUBLIC SERVANT. AS I CAN SEE, YOUR JOB WILL NEVER BE DONE AS A PUBLIC SERVANT AT HEART. THANK YOU.

>> THANK YOU COUNCIL WOMAN. COUNCIL MEMBER GREEN?

>> YOU AND I HAVE TALKED AND I JUST WANT TO SAY PUBLICLY ONE OF THE GREATEST HONORS OF MY LIFE WHILE IN OFFICE ON METRO COUNCIL IS SEEING THE NEW DARE TO CARE FOOD FACILITY OPEN UP HAD PARKLAND. BRIAN WAS ADMITTED. HE CAME TO ME WITH THE IDEA AND HIS COMMITMENT TO ALLEVIATING FOOD INSECURITY, THE IDEAS HE WAS NOT AFRAID TO BRING THE WHOLE OPERATION TO WEST LOUISVILLE, REALLY MEANS A LOT TO ME. AND SO, GOING TO MISS YOU. GO FORTH AND ENJOY RETIREMENT AND GET A LITTLE PIT OF REST.

>> BRIAN. I'LL SAY WHAT EVERYBODY SERVES IN THIS JOB. THAT INCLUDES YOUR WIFE AND DAUGHTER THAT ARE ALSO HERE, YOU MIGHT WANT TO RECOGNIZE THEM AS WELL. AND I WILL ALSO SAY --.

>> I'M GOING TO RESCUE MYSELF. THANK YOU FOR THAT COUNCIL MEMBER HOLLANDER. I WANT TO RECOGNIZE MY WONDERFUL WIFE AND MY DAUGHTER JESSE ROSE.



>> I WANT TO THANK COUNCIL MEMBERS WHO SPOKE, ESPECIALLY COUNCIL WOMAN SHANKLIN. I WILL NEVER FORGET THE NIGHT SHE DIDN'T VOTE ON THE BUDGET BECAUSE THERE WAS IN THE ENOUGH MONEY FOR DARE TO CARE. YOU HAVE NO BIGGER SUPPORTER.

>> COUNCIL MEMBER KRAMER?

>> THANK YOU, MR. PRESIDENT. BRIAN. I JUST WANT TO SAY WE HAVE HAD THE PRIVILEGE OF WORKING WITH SEVERAL DIFFERENT AGENCIES, WORKING WITH YOUR AGENCY HAS BEEN INCREDIBLE FOR US. WHAT YOU BRING TO IT. SO, THANK YOU. IT'S NOT OFTEN THAT WE HAVE AN AGENCY THAT COMES TO US AND SAYS THIS IS OUR REALITY. AND WE KNOW THAT WE HAVE TO DO BETTER AT FUND RAISING AND HAD IS WHAT WE'RE GOING TO DO. WE'RE GOING TO ASK TO YOU HELP WITH US THIS PIECE WITH A STEP DOWN EACH YEAR AND THEN TO, COME PACK NEXT YEAR AND HAVE ACCOMPLISHED WHAT YOU ASSURED US YOU WILL DO AND FOLLOWING NEAR A MORE OPPRESSIVE GOAL AND CAME BACK AND ACCOMPLISH WHAT YOU SAID YOU WOULD DO. YOU MENTION OUR BEING WILLING TO PARTNER WITH YOU. I THINK THE REAL STORY HERE IS YOU, HAVE BEEN A GREAT PARTNER, FOR US. AND DARE TO CARE HAS DONE WONDERFUL THINGS AND MAKES IT EASY FOR US TO PARTNER WHEN WE HAVE PEOPLE THAT DO THE WORK YOU'RE DOING. WE DO APPRECIATE FOLKS ARE COMING IN TO FILL YOUR SHOES AND IT WILL BE A DIFFICULT TASK AND WE APPRECIATE ALL YOU'VE DONE AND WISH YOU ABSOLUTELY ALL THE BEST IN RETIREMENT. THANKS.

>> THANK YOU, BRIAN.

>> COUNCIL MEMBER HOLLANDER?

>> THANK YOU, PRESIDENT JAMES. SECOND PROCLAMATION THAT I HAVE TONIGHT IS FOR MARIA PRICE, RETIRING FROM THE ST. JOHN CENTER FOR HOMELESS MEN. I'LL JUST MAKE THE SAME COMMENT THAT I MADE ABOUT THE PANDEMIC. IF THERE MAY BE ONE THING THAT WAS MORE IMPORTANT THAN FOOD SECURITY, DURING THE PANDEMIC, IT WAS TRYING TO HELP PEOPLE WHO ARE HOUSELESS, WHEN WE WERE ALL URGED TO STAY HOME. THINK ABOUT HOW HARD THAT WOULD BE. THINK ABOUT HOW HARD THAT WOULD BE TO NOT HAVE A PLACE TO WASH YOUR HANDS WHEN WE'RE ALL TOLD TO WASH OUR HANDS. AND MARIA PRICE HAS DONE ARE YOU JUST A REMARKABLE JOB AT ST. JOHN'S CENTER. SHE'S WITH US. HE'S OUT OF TOWN BUT I THINK WITH US VIRTUALLY. I WOULD LIKE TO READ THIS PROCLAMATION. WHEREAS MARIA PRICE BEGAN VOLUNTEERING AT THE ST. RO JOHN CENTER FOR HOMELESS MEN IN ONE # 94, JOINED STAFF AS DEVELOPMENT DIRECTOR IN 2006 AND BECAME EXECUTIVE DIRECTOR IN 2008, UPON RETIREMENT OF ST. JOHN'S FOUNDING DIRECTOR, SISTER MARY KATHLEEN SHEEHAN, ST. JOHN'S LAUNCHED IT'S PERMANENT SUPPORTIVE HOUSING PROGRAM DURING MARIA'S TENURE, PROVIDING HOUSING AND ONGOING CASE MANAGEMENT TO VULNERABLE HOMELESS MEN WITH 98% OF THOSE SERVED RETAINING THEIR HOUSING FOR MORE THAN 12 MONTHS IN ANY GIVEN YEAR, MARIA HELPED ST. JOHN DEVELOP IT'S STREET OUTREACH TEAM WHICH CONNECTS PEOPLE LIVING IN CAMPS AND

ON THE STREET TO SHELTER AND RESOURCES. WHEREAS ST. JOHN'S DAY  
SHELTER AN SOCIAL SERVICES CENTER HAS GROWN IN PHYSICAL SIZE AND  
PROVIDING SERVICES DURING MARIA'S TENURE, AND NOW, OFFERS  
EMPLOYMENT AND HOUSING COUNSELLING HELPING HUNDREDS OF PEOPLE  
MOVE FROM HOUSELESSNESS TO PERMANENT HOUSING. NOW, THEREFORE THE  
MOBILE METRO COUNCIL RISES MARIA PRICE AND THANKS HER FOR  
EXEMPLARY SERVICE TO THE COMMUNITY. I BELIEVE MARIA IS HERE  
VIRTUALLY. MARIA. THE FLOOR IS YOURS. COUNCIL MEMBER HOLLANDER.  
THANK YOU SO MUCH FOR THE HONOR OF THIS RECOGNITION. HONESTLY.  
THE PRIVILEGE OF MY LIFE HAS BEEN TO GIVE OF MY BEST, AND IN  
SERVICE TO PEOPLE WHO NEED PERMANENT HOUSING OF THEIR OWN. AND  
CERTAINLY, THAT WORK IS NOT FINISHED. I DON'T KNOW HOW I'LL  
CONTINUE TO BE PART OF THE STRUGGLE BUT I LOOK FORWARD TO THAT.  
AND WE FEEL ABSOLUTELY ACCOUNTABLE EVERY DAY, TO THE PEOPLE WE  
SERVE. ON THE STREETS, AT THE SHELTER, AND IN THEIR OWN  
APARTMENTS AND CASE MANAGEMENT WE GET TO DO WITH AND FOR THEM.  
WE FEEL ACCOUNTABLE TO METRO COUNCIL FOR ENTRUSTING US WITH  
PUBLIC FUNDS AND ARE SO GRATEFUL TO BE COMMUNITY SUPPORTED AS  
WELL. AND THANK GOODNESS, BECAUSE WE HAVE CHALLENGES AHEAD OF US  
AND I BELIEVE THAT TOGETHER, WE CAN MEET THOSE CHALLENGES. SO  
THANK YOU SO MUCH FOR THIS MOMENT. AND I LOOK FORWARD TO  
CONTINUING THE STRUGGLE IN SOME OTHER CAPACITY. THE OTHER GREAT  
PRIVILEGE IS GET THE HAND OF TO RAY SHAWN MARTIN WHO STARTS

SEPTEMBER 20TH. I KNOW SHE WILL HELP CATAPULT THIS COMMUNITY FORWARD, EVEN FURTHER, SO, THANK YOU.

>> THANK YOU, THANK YOU VERY MUCH. THANK YOU COUNCIL MEMBERS.

>> THANK YOU, COUNCILMAN. THANK YOU, MARIA. COUNCIL MEMBER BLACKWELL?

>> THANK YOU, MR. PRESIDENT. JUST GOING TO THANK MARIA FOR HER SERVICE AND THANK COUNCIL MEMBERS. WE'VE WORKED TOGETHER FOR A LONG TIME PRIOR TO GETTING ON THE COUNCIL. AND, IT'S COUNCIL MEMBER KRAMER SAID TO BRIAN EARLIER AND A AGREE WITH HIM THAT THESE TWO ARE TWO EXEMPLARY SERVICE LEADERS FIRST OF ALL, AND SECOND, THEIR ORGANIZATIONS, THE WAY THEY HANDLE THE ORGANIZATIONS AND THE WAY THEY ALWAYS COME BACK TO US WITH REAL METRICS AND ABLE TO SHOW US WHAT THEY DID WITH ANY FUNDS WE'VE GIVEN THEM IS JUST REALLY EXTRAORDINARY. AND APPRECIATE YOUR WORK, OVER THE YEARS AND APPRECIATE EXAMPLE THAT YOU SET. YOU TWO HAVE BIG SHOES TO FILL FOR THE PERSON THAT COMES BEHIND YOU. THANK YOU.

>> THANK YOU, COUNCILMAN. COUNCIL MEMBER KRAMER.

>> I'LL BEGIN BY ECHOING EVERYTHING COUNCIL MEMBER ROCKWELL JUST SAID. I THINK YOU'RE RIGHT ON ALL COUNTS. I WANT TO SAY TO MARIA, ESPECIALLY, THANK YOU FOR YOUR PATIENT EDUCATION OF ME. I HAD KNOWN MARIA BEFORE COMING INTO THIS POSITION. SO I HAD A

CHANCE TO SIT DOWN AND TALK ABOUT WHAT SHE DOES. KNEW A LITTLE BIT ABOUT ST. JOHNS BUT CAME TO UNDERSTAND NOT JUST THE WORK SHE DOES BUT THE SCOPE OF THE WORK THAT NEEDS TO BE DONE. SO I THINK I'M BETTER AS A COUNCIL PERSON AS A RESULT OF THOSE MEETINGS WITH HER, I'M GOING TO MAKE SURE I THANK YOU FOR THE THINGS DID YOU FOR THE COMMUNITY AND FOR WHAT YOU DID TO HELP ME BE BETTER AT WHAT I DO. THANK YOU.

>> THANK YOU. THANK YOU COUNCIL MEMBER.

>> MADAM CLERK? ARE THERE ANY ADDRESSES TO THE COUNCIL?

>> YES, SIR, THERE ARE.

>> LET ME REMIND THOSE TO PLEASE REFRAIN FROM USING PROFANITY OR MAKING DEROGATORY STATEMENTS TO COUNCIL MEMBERS. MADAM CLERK. PLEASE BRING THEM FORWARD.

>> CHELSEA WESTBROOK. KELSEY WESTBROOK. DAN BORSCH? WALLACE MCMULLEN?

>> HI. I'M WALLACE MCMULLEN RESIDING AT 4324 DULTON ROAD. AN ACTIVE MEMBER OF THE RENEWABLE ENERGY ALLIANCE OF LOUISVILLE. I'M GOING TO BEGIN TONIGHT WITH A QUOTE FROM PAUL HAWKINS, THE WELL MOAN ENVIRONMENTAL EDITOR AND WRITER. WE WILL EITHER COME

TOGETHER TO ADDRESS GLOBAL WARMING OR WE WILL LIKELY DISAPPEAR IN THE CIVILIZATION. THAT MAY SEEM LIKE A STATEMENT FROM AN APOCALYPSE BUT FOR PEOPLE STILL SWELTERING WITH OUT ELECTRICITY IN HAD LOUISVILLE AND LOUISIANA THOSE WHO DROWNED IN NEW YORK CITY, THE 30,000 FOLKS WHO HAVE BEEN EVACUATED IN CALIFORNIA AND NEVADA, I SUSPECT MANY OF THEM WOULD AGREE WITH THIS STATEMENT. THE STRONG CONCLUSION IS SUPPORTED BY HEADLINE IN THE JOURNAL OF SEPTEMBER 2ND. WEATHER DISASTERS HAVE SOARED SINCE 1970S, THE ARTICLE SAYS STRIKING 4 TO 5 TIMES MORE OFTEN AND CAUSING SEVEN TIMES MORE DAMAGE THAN IN THE 197 #S. SO PEOPLE WHEN PEOPLE DIE IN NEW YORK AND NEW ORLEANS GOES DARK FROM A HURRICANE, WITH SMOKE, AND FIRES THREATENING LAKE TAHOE, WHEN CANADA REPORTED TEMPERATURES OF 128 DEGREES FAHRENHEIT, IT'S TIME TO TAKE CLIMATE CHANGE VERY, VERY SERIOUSLY AND TIME FOR THIS BODY, METRO COUNCIL TO MAKE REAL CONCRETE ACTION. YOU HAVE TAKEN A GOOD FIRST STEP BY PASSING THE 100% RENEWABLE ENERGY RESOLUTION BUT YOU NEED TO TAKE ACTION WHICH REALLY SUPPORTS THE RESOLUTION. IT'S TIME TO MAKE CLIMATE MITIGATION INFRASTRUCTURE PART OF EVERY BUDGET. COUNCIL MEMBER, FRIENDS, YOU HAVEN'T DONE THAT YET. WE NEED YOU TO PURCHASE SOLAR INSTALLATIONS OF ALL AVAILABLE ROOF TOPS. METRO GOVERNMENT CAN BE FUNDING SOLAR INSTALLATIONS ON METRO PROPERTIES AND REDUCING LOUISVILLE'S CARBON FOOT PRINT ALMOST IMMEDIATELY. IF YOU MAKE SUCH INFRASTRUCTURE PART OF EVERY BUDGET YOU CAN BE AT 0 CONSUMPTION

WITHIN THE DECADE. WE PREPARED A LIST. I'M GOING TO GIVE YOU THREE EXAMPLES THAT LOOK LIKE PRIME LOCATIONS FOR SOLAR INSTALLATIONS ON METRO BUILDINGS. I HOPE YOU'LL ACT ON THE GOALS OF GETTING CLEAN ENERGY PRODUCTION UNDERWAY ON CITY PROPERTIES. PLEASE, METRO COUNCIL, START PURCHASING SOLAR. HERE IS THE EXAMPLES, METRO HALL, 527 WEST JEFFERSON. THE HEALTH DEPARTMENT, EAST GRACE STREET. SOUTH LOUISVILLE COMMUNITY CENTER, AT 2911 TAYLOR BOULEVARD. BASED ON PRELIMINARY GOOGLE SECTION, THESE ARE THREE LOCATIONS THAT COULD BE GOOD SITES FOR SOLAR INSTALLATION. LET'S DO IT. I THANK YOU FOR YOUR ATTENTION TONIGHT.

>> HELLO, COUNCIL MEMBER REED, PRESIDENT JAMES, AND ALL MINUTES OF METRO COUNCIL. MY NAME IS CARA TOBE, A 616 RESIDENT AN MEMBER OF THE 490 PROJECT. ASKING TO YOU VOTE NO ON PROPOSED FOP, CDA. SEND IT PACK FOR RENEGOTIATION, PUBLIC SCRUTINY OF THE POLICE CONTRACTS AND THEIR NEGOTIATION PROCESS RESULTED IN A FEW POSITIVE CHANGES, BUT THEY'RE NOT ENOUGH. THE CONTRACT STILL FAILED TO PRESENT A SERIOUS CHALLENGE TO POLICE MISCONDUCT, CORRUPTION, AND ABUSE OF THE COMMUNITY WHICH WITH LPD IS TASKED WITH SERVING. THESE INCLUDE MANY PROBLEMATIC CAUSES THAT WE WROTE I MEMO THAT HIGHLIGHTED ONLY THE MOST EXTREME AND IT WAS STILL A FULL TEN PAGES LONG THERE. ISN'T ENOUGH TIME TO WALK

THROUGH THESE WITH YOU. YOU SHOULD HAVE RECEIVED A COPY OF THE MEMO YESTERDAY. I WILL, HOWEVER, HIGHLIGHT ONE ARTICLE TONIGHT. A NEW ONE, ARTICLE 39 SECTION ONE. STATING POLICE CAN VOLUNTEER ON DUTY UP TO TWO HOURS PER PAY PERIOD. 0 GUIDE LINES ARE INCLUDED FOR HOW THEY CAN USE THESE HOURS. IN THEORY, THEY CAN VOLUNTEER WHERE THEY LIKE. FOR WHOEVER THEY'D LIKE, AND COULD BE VOLUNTEERING FOR ORGANIZATIONS THAT ARE POLITICALLY BIASSED OR THEIR OWN FOP. SURELY, YOU MUST SEE WHY THIS POSES SERIOUS CONCERNS. WE, IF WE'RE GOING TO DEMILITARIZE POLICE AND INVEST MORE IN DEFLECTION, MENTAL HEALTH AND SOCIAL SERVICES OR OUR CHILDREN, LIKE LIBRARIES AND POOLS THESE PROVISIONS MUST CHANGE. CONTRACTS SHOULD NOT RESTRAIN OUR COMMUNITY FROM IMPLEMENTING PROVEN METHODS OF REDUCING CRIME. PUBLIC SCRUTINY MUST CONTINUE AND METRO MUST VOTE NO AND SEND THE CONTRACT BACK SO THESE ADDITIONAL CHANGES ARE MADE, NOW. AS PUBLIC SCRUTINY RESULTS IN ONLY 3 OR 4 CHANGES, EACH NEGOTIATION CYCLE, IT COULD TAKE A DECADE TO SIMPLY THESE MODIFIED OR REMOVED. A DECADE IS TOO LONG WHEN THE COMMUNITY IS HURTING ENOUGH. WE SHOULD BE WORKING ON SOLUTIONS THAT BRING ABOUT HEALTH EQUITY, AFFORDABLE HOUSING OR JOB CREATION WITHOUT GENTRIFICATION. METRO COUNCIL CAN SET AN EXAMPLE, ENSURING THESE PROVISIONS ARE REMOVED FROM THE RIVER CITY FOP, CDAES ENTIRELY. MANY OF THESE THINGS NEED TO CHANGE IN STATE LAW AROUND POLICE PROTECTION THIS IS SET PRECEDENT AND SEND A MESSAGE TO THE STATE THAT LOUISVILLE IS UNWILLING TO



COMPROMISE DANGEROUS BEHAVIORS AT THE COST OF ITS CONSTITUENTS.  
I'M ASKING TO YOU CHANGE THINGS NOW. PLEASE VOTE NO. WE HAVE TO  
STOP ALLOWING LMPD DIFFERENT TREATMENT THAN OTHER GOVERNMENT

>> THANK YOU, MR. PRESIDENT AND THANK YOU COUNCIL MEMBER. THIS, THE GENESIS OF THIS, I NEED TO BACK UP A LITTLE BIT AND TALK ABOUT HOW WE GOT HERE. THE GENESIS OF THIS BEGAN, IF YOU CAN REMEMBER A TIME WHEN COVID DIDN'T EXIST. AND THE, WE WERE FACING SOME BUDGET CHALLENGES WITHIN THE CITY. AND ONE OF THE WAYS THAT ADMINISTRATION CHOSE TO ADDRESS BUDGET CHALLENGES BEFORE METRO



COUNCIL HAD AN OPPORTUNITY TO FINALIZE A BUDGET AND GO TO OUR BUDGETARY PROCESS IS TO START TO PULL TRAFFIC GUARDS FROM PUBLIC SCHOOLS, AND JUST SCHOOLS IN GENERAL, PARTICULARLY TARGETING PUBLIC SCHOOLS, THAT WERE IN SUBURBAN CITIES. SO, THERE WERE ULTIMATELY, HE DID NOT GO FORWARD WITH THAT DECISION. HE IS NOW GOING TO DO IT. FIRST OF ALL THE REVENUE PROJECTIONS WILL BE BETTER THAN THEY ESTIMATED. FULLY FUNDED IT FROM THE BUDGET THAT YEAR AND HE DIDN'T END UP EXECUTING THAT DECISION. BUT THERE ARE A LOT OF CONVERSATIONS THAT WERE CREATED AS A RESULT OF THAT. WITH LMPD AND I SAT IN WITH THE CONVERSATIONS WITH LMPT AND TRAFFIC COURT BUREAU AND OTHER SUBURBAN CITY MAYORS AND OTHERS TO TALK ABOUT THIS. FAST FORWARD TO OLD BUSINESS. A FEW THINGS MATERIALIZED. ONE OF WHICH IS THAT CURRENTLY. NO STATUTE, NO ORDINANCE THAT DEFINES WHO IS RESPONSIBLE FOR, OR ANYBODY IS RESPONSIBLE FOR PROVIDING TRAFFIC BARS ON PUBLIC STREETS IN JEFFERSON COUNTY WHERE NEEDED, PARTICULARLY RELATED TO SCHOOLS. SO, THEORETICALLY, RIGHT, ANY COULD OR COULDN'T PULL TRAFFIC BARS FROM ANY TRAFFIC STREET THEY FELT LIKE IT AND THERE IS NO STATUTORY OR ORDINANCE OR LOCAL CODE TO PREVENT THAT FROM HAPPENING SO, AND, TO BE CLEAR, SINCE MERGER, SINCE MERGER, METRO GOVERNMENT HAS PAID FOR AND STAFFED THESE POSITIONS ACROSS JEFFERSON COUNTY. RIGHT? AND EVEN IN THIS BUDGET, THERE IS SOME VERBIAGE THAT INDICATES THAT THE BUDGET CONTEMPLATES FULL FUNDING FOR TRAFFIC ACROSS THE COUNTY, FOR WHERE THEY'RE NEEDED

AT SCHOOLS, WHERE CHILDREN AND MOTHERS ARE CROSSING STREETS AND THERE ARE TRAFFIC CONCERNS THAT WARRANT THESE GUARDS. SO. NUMBER ONE THING THAT ORDINANCE DOES IS ACTUALLY SPECIFY THAT METRO, LOUISVILLE METRO GOVERNMENT IS RESPONSIBLE FOR THEM. RIGHT? SO WE SORT OF CLARIFIED THAT. FOR THE ENTIRETY OF JEFFERSON COUNTY. OKAY? THAT IS NUMBER ONE GOAL THAT THIS IS ACHIEVES. THE NEXT GOAL IS TO TRY TO ADDRESS THE CURRENT STAFFING SHORTAGE. RIGHT? STAFFING SHORTAGE IS NOT NECESSARILY A NEW THING. IT'S MADE WORSE BY THE PANDEMIC. AND WE CLARIFY FROM LANGUAGE IN HERE THAT I WOULD, THAT COUNCIL MEMBER WINKLER POINTED OUT IN COMMITTEE IS CLARIFYING LANGUAGE OF A LEGAL AUTHORITY THE PAIR'S OFFICE HAS. BUT WE WANTED TO CODIFY IT TO CONVEY COUNCIL'S INTENT IN THIS CASE TO AVAIL HIMSELF OF THE OPPORTUNITY TO FILL THE GAPS IN FILLING THESE POSITIONS. SO FOR EXAMPLE, IT DOES HAVE PART OF THE AMENDMENT. IT DOES ALLOW FOR THE DESIGNATE TO ENTER INTO AGREEMENT WITH THIRD PARTIES INCLUDING BUT NOT LIMITED TO SUBURBAN CITIES TO PROVIDE THOSE TRAFFIC ORDINANCES IN HAD THE CHAPTERS. THE POINT IS THAT IN ORDER TO FILL THESE GAPS, THE MAYOR'S OFFICE CAN, AND WE SAY, SHOULD, WE WANT THEM TO ENGAGE IN THESE THIRD PARTY RELATIONSHIPS THAT SHOULD HELP WITH THE CURRENT STAFFING SHORTAGE AND FILL ALL OF THESE POSITIONS. SO, THAT IS LARGELY WHAT THIS DOES. I THOUGH COUNCIL MEMBER BLACKWELL WAS TALKING ABOUT HOW YOU DEFINE IT. I'LL TRY TO ROUND OUT THAT CONVERSATION A LITTLE BIT. WE WERE CUT SHORT. HOPEFULLY

THIS WILL HELP. THERE IS SOME LANGUAGE HERE THAT MENTIONS SOME OF THE IDEAS, IT SAYS SOME CONSIDERATIONS SUCH AS LOCATIONS THAT THE CHIEF CAN USE TO DEFINE WHERE TRAFFIC GUARDS ARE NEEDED. NUMBER ONE, THE LANGUAGE IS THAT WE DON'T SPELL OUT LANGUAGE FOR SCHOOLS, MAYBE DEMOLISH, SOME SCHOOLS MAY BE BUILT. THERE IS A NEW SCHOOL GROUND BREAKING IN THE WEST END. WE'RE IN THE FINISHED. TRAFFIC PATTERNS MAY DICTATE WE NEED A TRAFFIC GUARD OR DESIGNATE SOMEONE TO MAKE THAT CALL. THAT IS THE CHIEF. WE OUTLINED CONSIDERATIONS THEY MAY TAKE INTO CONSIDERATION. WE USE MAY LANGUAGE INSTEAD OF SHALL LANGUAGE BECAUSE THERE IS A LOT OF CONVERSATION ON POTENTIAL LIABILITY TO THE CITY. AND IT WAS AGREED THAT THAT LANGUAGE, THOUGH THERE IS NO SPECIFIC CASES THAT WE FOUND, WHERE SIMILAR ORDINANCES AND OTHER CITIES CREATED INCREASED LIABILITY. WE THOUGHT USING HAY LANGUAGE WAS SHALL LANGUAGE SUFFICIENTLY MITIGATED THAT. I HOPE THIS HOPES CLARIFY WHAT THE INTENTION WAS. IT SAYS THAT WE'LL TAKE RESPONSIBILITY FOR THE ACTION. AND FOR PROVIDING THIS SERVICE. AND, THE CITY DOES HAVE ABILITY AND HOPEFULLY, WILL, AVAIL ITSELF AND PARTICULARLY FOR CHILDREN CROSSING THE STREETS WHEN TRYING TO GO TO SCHOOL THAT. IS IT. GLAD TO ANSWER QUESTIONS AND I WOULD VERY MUCH ENCOURAGE AND THANK A YES VOTE ON THIS ORDINANCE. THANK YOU, MR. PRESIDENT.

>> THANK YOU, COUNCIL MEMBER. COUNCIL MEMBER HOLLANDER?

>> THANK YOU, MR. PRESIDENT. LET ME SAY CONCERNS ARE EXPRESSED THAT ARE NOT RELATED TO THE IDEA SUBURBAN CITIES WHO HAVE POLICE DEPARTMENTS SHOULD TAKE OUR TRAFFIC GUARDS. I NEVER SUPPORTED THAT. I DIDN'T UNDERSTAND IT. IT DIDN'T MAKE SENSE TO ME. I DO HAVE CONCERNS ABOUT THE ORDINANCE. LET ME JUST SAY THAT COUNCIL MEMBER SAID A LITTLE BIT WHAT THE BUDGET LANGUAGE SAID. WHAT THE BUDGET LANGUAGE SAID IS THAT INCLUDED IN THE POLICE DEPARTMENT BUDGET, WE DID NOT ADD MONEY TO THE POLICE DEPARTMENT BUDGET BUT SAID WITH \$190 MILLION, THAT SHOULD BE SUFFICIENT TO RETURN TRAFFIC GUARDS TO THE SAME SCHOOLS AND AT LEAST SAME SCHOOLS SERVED IN 2018, 2019. I DON'T READ THIS AS SAYING WE'RE ASKING THE CHIEF OF POLICE TO RETURN TO THE SAME SCHOOLS THAT SERVED THIS FISCAL YEAR 2018, 2019. I READ THIS ORDINANCE AS SAYING, WE'RE OR THE FIRST TIME, REQUIRING THAT CHIEF OF POLICE TO PROVIDE TRAINED TRAFFIC GUARDS FOR ANY SCHOOL IN THE METRO WHERE A CHIEF OR DESIGNEE DETERMINES A TRAFFIC GUARD IS REASONABLY NECESSARY FOR SAFETY OF THE STUDENTS. SO WE'RE ALL FOR THAT. RIGHT? WE DON'T KNOW WHERE THOSE SCHOOLS ARE. I DON'T THINK THEY'RE THE SAME SCHOOLS THAT WE HAD IN 2019-201. THE CHIEF WILL TELL YOU, POLICE DEPARTMENT WILL TELL YOU THAT IN 2018-2019 THEY'RE PROVIDING TRAFFIC GUARDS TO THE SCHOOLS WE CAN AFFORD TO SEND THEM TO AND THE SCHOOLS WHERE WE HAD ENOUGH TRAFFIC GUARDS TO SEND THEM TO. IN MY VIEW THIS IS A NEW OBLIGATION TO SEND A TRAFFIC GUARD TO WHERE THE CHIEF THINKS IT'S REASONABLY

NECESSARY FOR SAFETY OF STUDENTS. AND I JUST HAVE TO SAY, I HAVE A CONCERN ABOUT THE COST OF THAT. BECAUSE I DON'T THINK ANY OF US HAVE AN IDEA WHAT THE COST OF THAT IS. AND IT DOES NOT SEEM TO ME TO BE WISE OR AT LEAST I'LL SAY, AND I MAY VOTE FOR THIS AND I KNOW IT'S GOING TO PASS. I'M NOT TRYING TO CONVINCING PEOPLE NOT TO VOTE. I'M RAISING THIS CONCERN ABOUT THE BUDGET, FRANKLY. ANY TIME WE IMPOSE NEW OBLIGATIONS ON METRO AND DON'T KNOW WHAT IT'S GOING TO COST, I THINK WE SHOULD BE LEERY OF DOING THAT. AND I THINK WE'RE DOING THIS HERE. THERE ARE PARTS OF THE ORDINANCE I LIKE A LOT. WE SHOULD ENCOURAGE, CERTAINLY ENCOURAGE ADMINISTRATION AND POLICE DEPARTMENT TO TRY TO USE THIRD PARTIES IF THAT WORKS TO FILL EVERYTHING THAT WE NEED A TRAFFIC GUARD AND HAD ONE IN 2018 AND 2019. I LIKE THAT PROVISION RESEARCH. I'M CONCERNED ABOUT THE COST, WHICH I THINK IS UNKNOWN. FINALLY, LET ME JUST SAY, BECAUSE I THINK IT'S IMPORTANT FOR THE PUBLIC TO KNOW THIS. IF THIS ORDINANCE PASSES AND I'M SURE IT WILL TONIGHT, THIS DOES NOT MEAN THAT WE'RE GOING TO HAVE TRAFFIC GUARDS EVERYWHERE WE HAD THEM IN 2018 AND 2019 ON TOMORROW, OR MONDAY. OR FOR THE FOR SEEABLE FUTURE, WE DON'T HAVE ENOUGH PEOPLE TO PUT AT ALL OF THOSE SCHOOLS. AND THE POLICE DEPARTMENT HAS BEEN VERY CLEAR ABOUT THAT. THEY'VE COME AN TESTIFIED IN TWO DIFFERENT MEETINGS AND SAID WE JUST DON'T HAVE ENOUGH PEOPLE. NOW, IF IT WORKS WE CAN GET THIRD PARTIES TO STEP UP, AND ACCEPT WHAT PAY WE CAN GET, AND BE TRAINED, MAYBE WE'LL HAVE MORE

PEOPLE IN THE FUTURE. THE PUBLIC SHOULD NOT THINK THAT PASSAGE IS THIS ORDINANCE IS GOING TO PUT A TRAFFIC GUARD AT EVERY SCHOOL TOMORROW, OR MONDAY. THAT IS JUST NOT THE CASE AND I'M CONCERNED ABOUT THE UNKNOWN CAUSE OF THIS. THANK YOU.

>> THANK YOU COUNCILMAN. COUNCIL WOMAN FOWLER.

>> MR. PRESIDENT, SO, AND I DON'T KNOW. MAYBE BILL, YOU CAN HELP. REMEMBER WHEN THIS WAS TAKEN OUT OF THE BUDGET BACK, I THINK 2018? THEY'RE TRYING TO MAKE A BUDGET THAT VERY TOUGH YEAR, DO YOU REMEMBER HOW MUCH IT WAS THAT WE WERE ABLE TO SAVE? BY DOING SO? AND I HAVE ANOTHER QUESTION IF YOU DON'T MIND.

>> SURE.

>> WE DIDN'T TAKE ANYTHING OUT OF THE BUDGET FOR SAVINGS ON TRAFFIC GUARDS. WE DID NOT CUT TRAFFIC GUARD BUDGET AT ALL. AND IN TRAFFIC, GOING THROUGH THOSE VERY TOUGH DISCUSSIONS, I BELIEVE I TASKED THE CHIEF AT THE TIME IF THERE WAS ANY THOUGHT OF DOING THAT. HE SAID NO. HE COULDN'T THINK WE'D DO THAT IN THIS COMMUNITY AND WE DID NOT DO THAT. SO THERE IS NOTHING TAKING OUT OF THE BUDGET. I THINK THAT, YOU KNOW I HAVE EXPRESSED A CONCERN ABOUT THE BUDGET MOVING FORWARD, IF WE EXPAND AT LOCATIONS WHERE TRAFFIC GUARDS ARE GOING TO BE, BECAUSE OF THE ORDINANCE. I THINK THIS MORE OF A STAFFING ISSUE THAN A BUDGET ISSUE AT THIS POINT. WITH \$190 MILLION, I THINK LMPD CAN STAFF AND PAY FOR TRAFFIC GUARDS AND AT LEAST THE

LOCATIONS THAT THEY HAD IN 2018 AND 2019. THAT IS WHY WE'VE PUT THAT IN THE BUDGET. I DON'T THINK THEY HAVE PEOPLE TO DO THAT. WE DID NOT CUT THE BUDGET FOR TRAFFIC GUARDS AT ALL.

>> THANK YOU FOR THAT CLARIFICATION. I JUST REMEMBER THAT THE DISCUSSIONS THOUGHT WE DID CUT IT. BUT I DON'T KNOW IF WE TRIED TO CUT IT ON JCPS. I DON'T KNOW. I JUST REMEMBER VAGUELY THE DISCUSSION. SO, THAT BRINGS ME TO SECOND PART, IF I MAY, PRESIDENT JAMES.

>> YES, MA'AM.

>> SO I HAVE TRIED TO WORK WITH THE STATE, WITH LMPD AS I'M GETTING A CROSSING GUARD IN VALLEY HIGH SCHOOL IN DIXIE. BECAUSE THERE IS A SIGNAL, THEY SAY IT'S NOT NECESSARY. BECAUSE YOU CAN'T MAKE KIDS DO WHEN THEY'RE IMPATIENT AND RUN ACROSS THE ROAD BUT THERE IS A FORMULA THEY'RE GOING TO MEASURE WHETHER OR NOT A TRAFFIC GUARD IS NEEDED IN THE SCHOOLS. AND THOSE THAT DON'T HAVE ONE NOW, WILL LIKELY NOT GET ONE. TRP HAS ONE BECAUSE THEY HAVE NO TRAFFIC LIGHT THIS, HE HAVE TWO TRAFFIC GUARDS THERE. AT VALLEY HIGH SCHOOL THERE IS A SECOND ENTRANCE THAT, IS A CONCERN FOR THAT LIGHT AND LIKE I SAID I KNOW THERE IS A FORMULA.

>> COUNCIL MEMBER WINKLER?

>> OKAY.

>> COUNCIL MEMBER PIAGENTINI.

>> THANK YOU PRESIDENT JAMES. AND I DON'T THINK THIS IS TO TOCK  
A BIG BUDGET CONCERN. AS A MATTER OF FACT, I HAVE HEARD SOME  
STORIES OF WHERE THERE SHOULD BE SCHOOLS THAT SHOULD HAVE THEM  
BUT WE DON'T HAVE THE STAFF. AND OTHER CIRCUMSTANCES WHERE WE'VE  
HISTORICALLY HAD TRAFFIC GUARDS IN PLACES WHERE THEY MAY NOT -  
- WE HAVE HAD THEM BUT IT DOESN'T MAKE SENSE BECAUSE OF CURRENT  
TRAFFIC PATTERNS SO I THINK THE BIGGEST POINT HERE FROM A FISCAL  
PART OF VIEW, WE ENTERED THIRD PARTY AGREEMENTS I THINK THERE IS  
A LOT OF OPPORTUNITY FOR COST EFFICIENCY THERE. BECAUSE THERE  
ARE OPPORTUNITIES. ONE STRUGGLE WE HAVE HAD IS THE WAY WE MANAGE  
STAFF VERSE WHAT'S YOU CAN DO IN A THIRD PARTY ARRANGEMENT. YOU  
CAN DESIGNATE CERTAIN PEOPLE TO CERTAIN SCHOOLS AND EVEN THE  
DIVISION OF TRAFFIC GUARDS TWO YEARS AGO. AND IS INDICATED THAT  
THEY LOSE PEOPLE EVERY YEAR. AS EARLY AS GOING THROUGH TRAINING  
WHEN REALIZE THEY WON'T GET SIGNED TO THE LOCAL SCHOOL THAT THEY  
WOULD HAVE THE TIME TO DO SERVICE FOR AND GET ASSIGNED SENIORITY  
BY THE WAY THE CURRENT LABOR ARRANGEMENT WORKS. THEY DON'T GET  
THAT AND MAY END UP QUITTING. SO I THINK THERE IS A LOT OF  
OPPORTUNITY HERE TO BE FAIRLY BUDGET NEUTRAL. AND I'M GLAD YOU  
SAW UTILITY AS COUNCIL MEMBER. THANK YOU.

>> THANK YOU VERY MUCH.

>> COUNCIL MEMBER WINKLER?



>> YES. THANK YOU, PRESIDENT JAMES. TO ADDRESS COUNCIL MEMBER HOLLANDER'S CONCERNS, OUR NUMBER ONE OBJECTIVE AS A CITY GOVERNMENT IS TO ADDRESS PUBLIC SAFETY. AND FOR OUR YOUNGEST RESIDENTS SO ENSURING THAT WE'VE GOT CROSSING GUARDS TO KEEP KIDS SAFE AND CRITICAL FUNCTION IS OUR GOAL. I THINK COUNCIL MEMBER HOLLANDER IS CORRECT. PASSING THIS TONIGHT DOESN'T MEAN WE'RE GOING TO HAVE CROSSING GUARDS THERE TOMORROW. BUT, IT SHOULD SEND A MESSAGE THAT IS SOMETHING WE'RE WORKING ON. I'LL COME BACK TO THAT. I HAVE AN AMENDMENT I WANT TO MAKE. I THINK THIS ISN'T A BUDGETARY QUESTION BUT A STAFFING QUESTION. AND IF THIS LANGUAGE HELP AS DRESS THAT SPECIFIC STAFFING ISSUE. BY ALLOWING US TO BE, AND ENCOURAGING THE ADMINISTRATION TO BE CREATIVE IN THEIR CONTRACTING, IT WILL ALLOW US TO FIND PEOPLE THAT CAN DO THIS WORK WHERE THEY ARE. I MENTIONED THIS IN COMMITTEE. ONE OF THE SUPERINTENDENTS, THERE IS AN INDEPENDENT SCHOOL IN MY DISTRICT. THE SUPERINTENDENT POINTED OUT SHE'S FEELING CONFIDENT SHE HAS STAFF THAT ARE AT SCHOOL IN THE MORNING AND INTO AFTERNOON THAT WOULD LIKELY BE WILLING TO CONTRACT TO DO THIS WORK. THEIR CONCERN WOULD BE CONTRACTING TO COULD IT AND SENT ACROSS THE COUNTY. IF THEY CAN CONTRACT WHERE THEY ARE SHE'S CERTAIN THEY'LL FIND PEOPLE WILLING TO DO THAT AND I'M CONFIDENT WE'LL FIND THAT SOLUTION SORT OF HYPER LOCALLY ACROSS THE COUNTY. DOESN'T MEAN YOU NEED ALL OF A SUDDEN PAY YOU KNOW, 3X OR 4X OR 10X WHAT YOU'RE PAYING ALREADY. YOU JUST PUSH

THE SOLUTION DOWN TO WHERE PEOPLE ARE AND ELIMINATE A SIGNIFICANT BARRIER THAT YOU CAN DRIVE 40 MINUTE AS ARES TO GO TO WHERE MY ASSIGNED POST IS. THAT IS AN ELEGANT SOLUTION AND I APPRECIATE COUNCILMAN PIAGENTINI'S WORK AND CRITICAL WE SOLVE THIS PROBABLY IMMEDIATELY. TO THAT END, COMING BACK FULL CIRCLE, I WILL MAKE AN AMENDMENT, AND MAYBE COUNTY ATTORNEY CAN HELP WITH ME BUT ADDING SECTION FOUR, SO NEW SECTION FOUR BECOMES SECTION GIVE READING SOMETHING TO THE EFFECT OF, THE CHIEF OR CHIEF DESIGNEE WILL PROVIDE METRO COUNCIL A QUARTERLY UPDATE ON STAFFING PROGRESS. AND THE INTENT THERE, AND AGAIN, HOLLY SORRY TO PUT YOU ON THE SPOT. IF YOU CAN HELP CLEAN THAT UP, THE INTENT THERE BEING THAT WE ARE IN A SENSE OF URGENCY TO PUSH THESE PEOPLE INTO THE CROSSWALKS WHERE WE NEED THEM. I DON'T KNOW, YOU CAN QUICKLY HELP ME CLEAN THAT UP.

>> HOLLY WITH THE COUNTY ATTORNEY'S OFFICE. I THINK, IF I UNDERSTOOD YOU CORRECTLY, YOU'D LIKE SECTION FOUR TO NOW READ THE CHIEF OR CHIEFS DESIGNEE SHALL PROVIDE, OR, METRO COUNCIL WITH QUARTERLY, I BELIEVE YOU SAID?

>> QUARTERLY, CORRECT.

>> UPDATES.

>> ON THE STATE OF TRAFFIC GUARD CROSSING.

>> I'M SORRY, ON?

>> ON THE STATE OF TRAFFIC GUARD STAFFING.

>> HOW ABOUT THE STATUS OF TRAFFIC GUARDS?

>> PERFECT.

>> SO CHIEF OR CHIEF DESIGNEE SHALL PROVIDE QUARTERLY UPDATES TO METRO COUNCIL ON THE STATUS OF TRAFFIC GUARD STAFFING.

>> YES. THANK YOU. AND THAT WOULD BE A NEW SECTION FOUR AND CURRENT SECTION FOUR BECOMING SECTION FIVE.

>> YES. I'D MAKE THAT PART OF THE MOTION.

>> CAN I HAVE A SECOND?

>> SECOND BY COUNCIL MEMBER HOLLANDER. IS THERE DISCUSSION? HEARING NO DISCUSSION ON THE AMENDMENT, THOSE IN FAVOR SAY AYE. OPPOSED? THE AMENDMENT PASSES. COUNCIL MEMBER WINKLER. COUNCIL MEMBER DR. BLACKWELL.

>> THANK YOU, MR. PRESIDENT. SO, COUNCIL MEMBER PIAGENTINI MENTIONED, THERE IS A POLICY THE LACK OF METRICS AND I UNDERSTAND WE'RE GOING TO AGAIN CONTINUE TO WORK ON THIS. AND I APPRECIATE COUNCILMAN WINKLER'S AMENDMENT WILL HELP US KEEP THAT IN FULL FRONT TO BRING IT BACK AGAIN FOR CONVERSATION. I'LL, I WOULD SAY THAT I DO THINK WE'RE IN A SITUATION. I DO THINK IT'S SOMETHING THAT IS IMPORTANT. AND, IT'S IMPORTANT FOR EXPANDING TO A LOT OF PLACES WHERE WE DON'T HAVE PEOPLE NOW BECAUSE, IT'S

JUST REALLY, FOR WHATEVER REASON, COUNCILMAN FOWLER WITH A GOOD EXAMPLE. ONE SCHOOL HAS TWO. AND NEEDS THEM. BUT ANOTHER SCHOOL YOU HAVE SOME CONCERNS AND YOU CAN'T GET ONE BECAUSE THEY'VE NEVER BEEN THERE BEFORE. SO ALSO, COUNCIL MEMBER FOWLER POINTED OUT THE PROBLEM WITH THE AMENDMENT I WAS GOING TO PROPOSE. WAYS GOING TO SAY THAT YOU NEED TO HAVE A GUARD THERE UNLESS THERE IS SOME SORT OF TRAFFIC SIGNAL THAT IS ALREADY IN PLACE THERE TO DIRECT TRAFFIC. SO, WE DO THAT IS NOT A GREAT SOLUTION AFTER ALL. BUT IT TO CONCERN ME THAT WE DON'T HAVE ANY STRONG METRICS FOR HOW WE GET THOSE THINGS PLACED. AND THEN, ALSO, THAT THE CHIEF, THE CHIEF IN AN AWKWARD SITUATION, TOO, IN TRYING TO MAINTAIN BUDGET IN DECISIONS YOU MAKE WILL INCREASE. YOU KNOW? TAKING IT OUT FOR THESE TRAFFIC GUARDS. YOU KNOW, ADDITIONAL MONEY FOR THE TRAFFIC GUARDS WILL COME OUT OF LMPD BUDGET. I ASSUME. I'M HAPPY WITH WHERE WE ARE AND GIVES US AN OPPORTUNITY TO CIRCLE BACK IN WHAT OTHER PLACES WE ACTUALLY NEED THESE TRAFFIC GUARDS, THANK YOU.

>> THANK YOU, COUNCIL MEMBER. IS THERE ANY FURTHER DISCUSSION? HEARING NONE. ORDINANCE REQUIRING ROLL CALL VOTE. MADAM CLERK. COULD YOU PLEASE CALL ROLL.

>> THANK YOU. MAY I HAVE A MOTION AND SECOND?

>> MOTION BY COUNCIL MEMBER WINKLER, SECONDED BY COUNCIL MEMBER REED. THE ITEM IS BEFORE US. IS THERE ANY DISCUSSION? COUNCIL MEMBER ACKERSON?

THEY'RE NOW ASKING FOR IT TO BE REZONED FROM TRD TO R6 MULTI FAMILY WITH REVISED DEVELOPMENT PLAN AND CALLS FOR 128 UNITS, EIGHT BUILDINGS ARE THAT TWO STORIES TALL THIS, IS A REDUCTION FROM THE PLAN THEY'D FIRST SUBMITTED. WE DID ADD AN ELEMENT TO THAT DEVELOPMENT PLAN WITH ITEM 14. SAYING DEVELOPER SHALL NOTIFY PLANNING COMMISSION AND STAFF WHEN CONSTRUCTION IS COMPLETE. OVER TURNED THE DECISION, PEOPLE HAVE SPOKE IN OPPOSITION AND I AGREE AND I'M GOING TO REPRESENTATIVE OF THOSE. THIS NEIGHBORHOOD IS ABOUT A

40, 50-YEAR-OLD ESTABLISHED NEIGHBORHOOD. AND THIS DEVELOPMENT IS ESSENTIALLY GOING TO GO RIGHT IN THE MIDDLE OF IT. IT'S GOING TO BE HOARSE SHOED ASH, HAD NEW DEVELOPMENT. AND THESE TWO STORY BUILDINGS AND IN ONE CASE, LEE-STORY BUILDINGS ARE GOING TO BE LARGELY IN PEOPLE'S BACKYARDS AND INVADING PRIVACY AND AGAIN. THE RECORD DOESN'T, I COULDN'T FIND ANYTHING, MADAM CHAIR, WITH GREAT ASSISTANCE TO ME. [ AUDIO INDISCERNIBLE ] . . THANK YOU.

>> THANK YOU, COUNCIL MEMBER. COUNCIL MEMBER WINKLER?

>> YES. THANK YOU MR. PRESIDENT. I JUST WANTED TO CONFIRM THERE ARE NO ALTERNATIVE FINDINGS OF FACT. A YES OR NO VOTE, EITHER ONE, WOULD STILL SUPPORT THE PLANNING COMMISSION. PLANNING COMMISSION IS CONTINUING TO MOVE FORWARD. RIGHT? BUT APPROVAL WOULD MOVE FORWARD IF THAT IS CORRECT?

>> YES. THANK YOU MR. PRESIDENT. A QUESTION MAYBE FOR COUNTY ATTORNEY. SO, I HAVE HAD SEVERAL INSTANCES OF PROPERTY BEING ZONED FOR A SPECIFIC PURPOSE AND THEN, I'M ALWAYS FINDING ELEMENTS ON THERE THAT REQUESTED IF THEY HAVE A CHANGE IN THE PLAN FOR IT TO COME BACK TO PLANNING COMMISSION AND OR, METRO COUNCIL. AND I JUST DON'T KNOW IF THAT IS SOMETHING EVERYBODY DOES AND IT'S ALL ACCEPTABLE? OR CAN YOU FILL ME IN ON THAT?

>> HAPPY TO. THERE ARE TWO DIFFERENT SITUATIONS THAT MIGHT POP UP. THE FIRST IS LET'S SAY A PROPERTY IS REZONED TO C2 AND THEY SAY IT'S GOING TO BE A RESTAURANT. WELL, THEY MAY DECIDE IF IT'S DEVELOPMENT FOR A COMMUNITY MAYBE RESTAURANT THEY'RE WORKING WITH DROPPED OUT, OR YOU KNOW THEY RAN NATIONAL METRICS AND THERE WASN'T SUFFICIENT WARRANTS OR THEY CAN MAKE THE PLAN WORK BECAUSE OF UNKNOWN GEOGRAPHICAL FEATURE. OCCASIONALLY WE GET PROJECTS WHERE POST ZONING THERE IS A NEW DEVELOPMENT PLAN AND OUR DEVELOPMENT CODE CONTEMPLATES THAT IDEA OF A REZONING IS THAT A CATEGORY OF USES ARE APPROPRIATE SO IT CAN FEEL DISINGENUOUS WHEN THAT HAPPENS. BUT THAT SORT OF THING DOES

HAPPEN. THERE IS NOTHING FINDING SOMEONE TO A PLAN, OTHER THAN THE FACT THEY HAVE TO PAY MONEY AND SPEND TIME TO GO AFTER PUBLIC PROCESS FOR PLANNING. AND ON THE OTHER HAND WE HAVE A CASE LIKE THIS, THEY'RE GOING FOR DIFFERENT REZONING. I CAN'T PEEK FOR DEVELOPER IN THIS CASE AND WHY SORT OF A PREVIOUS PLAN WAS ABANDONED. OBVIOUSLY WE'RE AWARE OUR DEPARTMENT HAS BEEN SORT OF THE MAIN DEMAND THING WE'VE BEEN SEEING. SUBMITTED IN RECENT MONTHS. >> RIGHT. AND I UNDERSTAND THAT THIS IS A LITTLE BIT DIFFERENT. HE'S SEEKING A DIFFERENT ZONING BUT WHEN SOMEONE GETS AN M OR C2 THEY DON'T HAVE TO COME BACK TO GET AN R ZONING FOR ANYTHING. THEY CAN GO AHEAD AND BUILD WHATEVER THEY WANT. TO THE APPROVAL COME INTERESTS PLANNING COMMISSION. CORRECT?

I DON'T KNOW IT THE WAY THAT RESIDENTS THAT LIVE THERE DO. FOR TO US START, YOU KNOW, MY TIME WE COME TO PLANNING AND
