Neighborhood Meeting Followup

We had 10 neighbors from District 11 and 2 neighbors from District 26 that came out to the meeting last night. Thank you to all of those who committed your time to come out and join in on the discussion for this Conditional Use Permit application.

To recap the meeting, I informed all attendees of the purpose for this proposed permit, which would allow my property at 7901 Sunbury Lane to be rented for a period of 30 days or less at a given time. Currently in Jefferson County, a rental that allows guests to stay for under 30 days, is considered a transient use and requires a permit as well as additional taxation for those rented days. If a property is rented for longer than 30 days at a time, it is considered a long term rental and therefore does not require a permit to operate.

I went on to inform the attendees that I have been operating short term rentals in Louisville for 5 years, and have an excellent track record. I am a full-time real estate broker, and short term rental manager. I will be managing this property myself with my wife and my business partner. Through my 5 years as a host, I have formulated a system to avoid bad guests to the best of my ability. I put my guests through an additional screening process above and beyond what Airbnb, VRBO, Booking.com etc. use. I also have cameras on the exterior of the home, as well as noise detection devices inside the home. We also have a 1 review minimum before a guest can book with us.

One of the topics I adamantly discussed was the topic of parties. We don't allow or tolerate parties at any property, especially at this one. We don't rent to guests who are local to Louisville. We inform every guest ahead of time about our quiet hours and house rules, which are to be strictly adhered to.

Scott Harrington from Councilman Kramer's office also attended the meeting, and provided insight about the process as well as next steps. Scott told the neighbors that there is a short term rental on Summerfield Drive in the Four Season's Two neighborhood, which has been operating without any issues or complaints for the past year.

My wife and I purchased this property in 2019. At the time we bought it, the home was in disrepair, and had drug addicted squatters living inside of it. Needless to say, we not only invested a lot of money into the home to bring it back to life, but we invested our time, energy, blood, sweat and tears into this home. We have 2 small children, 1 of which was brought home from the hospital to this house. We cherish it, we respect it, we enjoy it, and we want to keep it for as long as we can. I understand that most neighbors are concerned about who the new guest will be each week or month that comes to stay at the home, but I can assure you that whoever it is will be better than the people who lived here when we purchased it, but more importantly, I can assure you that I do not and will not allow people to come to this home who have any intention other than to enjoy it and enjoy our city.
