WHEREAS, following the Planning Commission's recommendation, on June 14, 2018, Metro Council passed Ordinance #085, 2018 adopting Plan 2040. Plan 2040 was also forwarded to the 12 cities with zoning authority in the Louisville Metro planning unit. The plan was formally adopted by each of the legislative bodies or deemed to have been approved by operation of law pursuant to Kentucky Revised Statutes; and

WHEREAS, the Metro Council has adopted 34 neighborhood plans in accordance with LMCO Chapter 161; and

WHEREAS, the Planning Commission and Metro Council have adopted these 34 neighborhood plan executive summaries as amendments to Cornerstone 2020; and

WHEREAS, the Planning Commission finds that these 34 neighborhood plan executive summaries are in conformance with the Goals, Objectives, and Policies of Plan 2040; and

WHEREAS, the Planning Commission finds that these 34 neighborhood plan executive summaries should be adopted as amendments to Plan 2040;

RESOLVED, that the Louisville Metro Planning Commission does hereby **APPROVE** Resolution 18NEIGHPLAN1004 which **RECOMMENDS** to Metro Council that the listed Neighborhood Plan Executive Summaries be adopted as amendments to Plan 2040.
