- Evolve KY has partnered with Metro Government and is in charge of education and promotion of the benefits of electric vehicles and charging systems
- Questions about how many businesses have taken advantage of the Green Fleets challenge
- Louisville Gas and Electric Company is the only company currently signed on for the Green Fleets challenge
- Question about what the total number of charging sites there are throughout Louisville Metro
- Louisville Metro has 10 sites throughout their properties, four of the sites are at libraries, one is at the Edison Center, and one is site in Middletown
- Question about how to adopt a charging station
- There are several charging stations throughout Frankfort Avenue area
- Question about what Metro Government is doing to be ready for the federal assistance that is going to come with the infrastructure package for electric vehicles
- Charging systems will be put in community wide
- Question about whether developers are required or encouraged to have charging systems
- Electric vehicles and charging systems are not just an economic development issue it is also a tourism issue
- The market is starting to demand electric vehicles and charging systems as well
