PRESIDENT YATES: And on that, my colleagues, would you please join me in a moment of silence in honor of Councilman Bill Hollander's father, James Hollander, in honor of Councilwoman Leet's mother, Annie Marie Franklin, and in honor of Sebastian M.

Please join me in a moment of silence.

[Moment of Silence]

PRESIDENT YATES: We don't have any pages. I would like to wish my little girl Ava Yates a happy 11th birthday. Most of you have seen her here. If you are watching, Happy Birthday.

All right. Addresses to the council. Mr. Clerk, are there any addresses to the council?

MR. CLERK: Yes, sir, there is.

PRESIDENT YATES: Let me remind those addressing the council to please refrain from any profanity or making derogatory statements to questions about.

Mr. Clerk, would you please bring the first person forward?

MR. CLERK: Deborah O'Gorman

DEBORAH O'GORMAN: This is Deborah O'Gorman

You know I have epilepsy and I run a support group. I work with Fourth Street Live. I'm addressing you on the homeless people. This past week we had 6,900 people here. People sit there on fourth street, help me, help me. The Christian people bought them food from T.G.I. Fridays, the

Hard Rock, and they gave them food. They don't want the food. They want money. You know we have a beautiful convention center there. I have a booth at the state fair every year. This is my 22nd year. I work with legal aid. People get out and say I can't get a job, I just got out of jail. Employers for ex-offenders, Pepsi, all these people are hiring ex-offenders. I tried to get them to go to legal aid over at Kentucky towers.

When I called the police to come there to get these people off the street, because this is just one example, the next two weeks we are going to have 29,000 in the drag strip racers before the convention center. When our convention center opens up, we have all these beautiful hotels. I live right across from the Omni. And that Omni is already packed to 2025. I am telling you. This is not right. We are a city that is building, not falling down. I have got members of my group waiting for disability, and we can't work. No, we can't.

The point is I don't want to hear you can't get a job. There are too many people saying I got jobs. Work two jobs. I have got jobs here and jobs here. People just getting out of jail, there are jobs right here. Legal aid is working with you to find a real job. We are not talking about \$5. We are talking about \$10 to \$15. I'm advertising this at my booth at the state fair. And legal aid. When I call the police, the police do show up. My father was fourth district police, and I respect the police very much. But these people are now putting up tents at WFPL on Fourth Street right across from the old Cunningham.

We are not California. I'm from New York. And we don't take it here. We have got to get these people off the street. It is going to chase our conventions before we get here.

Now, the point is Mr. Cordish has his security so people can't go in there. And Vick Topper bought the second street McDonald's and now people can't walk there. Let's make the whole area the same way. Thank you.

PRESIDENT YATES: Councilwoman Barbara Shanklin. Point of personal privilege.

COUNCIL MEMBER SHANKLIN: I just want to say if you have an updated list of the jobs, we would like to share that list. So if you have an updated list, I have an old list but I need to know where the jobs are. Thank you.

PRESIDENT YATES: David, would you like to grab that from her? Do you have that with you? Thank you.

MR. CLERK: Anna Blake.

ANNA BLAKE: Can you hear me? Okay. My name is Anna. I would like to voice my support for Council Member Sexton Smith's proposal for a buffer zone in front of the AMW surgical center. I'm a private citizen and not much of a public speaker, however, I have felt extremely bothered by the protests that antiabortion activists have been making in a city that I'm otherwise very proud of. As a member of the community who feels passionately about the rights and safety of women, I feel it is imperative that the center is permitted to operate with a safe surrounding to provide optimal care and dignity for the patients they serve. Thousands come to Louisville for a legal medical procedure at Kentucky's last remaining

abortion clinic and if Louisville is to remain a compassionate city, it is important that we ensure these people are allowed to safely receive the care they need.

While it is our 1st Amendment right to practice free speech it is also our 14th Amendment right to make our own decisions and receive an abortion if that is our decision. I fully support both of these rights as I'm sure most Americans do, but I feel there needs to be a line drawn. As a matter of fact, there already is. There are several forms of speech that are not protected under the first amendment. These include but are not limited to obscenity, fighting words, defamation, and true threats. Anyone who has worked there walks through the protests, or simply walks by the sidewalk can hear these coming from the protestors outside the surgical center. Protestors have been known to film them as they walk in, call them murderers and threaten them and their families. A few months ago the protestors blocked the clinic entrance requiring law enforcement to intervene and remove the trespassers. Many, many follow patients and manipulate them into feeling guilty for the decision they made.

Nobody has to like abortion and all Americans have a constitutional right to free speech but when that constitutional right goes unchecked and becomes inappropriate enough that it infringes on others' rights, something needs to be done, and I wholeheartedly support Council Member Sexton Smith's proposal to enact a permanent buffer zone to uphold the constitutional rights of Kentuckians.

DANIEL COBBLE: I wish to update my findings on the Metro Council 2014 ordinance on raising the minimum wage in Louisville. I argue we are making economic decisions through the prism of three bad monetary policies. These three policies are low-interest rates, private investors receiving their capital directly from the Federal Reserve, and three, without the Glass Steagall Act, citizens and foreigners cannot safely deposit their money in U.S. banks. These relative policies are detailed on page two. Some of you know of the recent study on Seattle's 2014 minimum wage hike to \$15. Seattle workers are losing approximately \$425 per month and \$1,500 annually.

More broadly, in both 2014 and 2015, the average wealth of the U.S. decreased by \$5.5 trillion. \$11 trillion for both years. With today's stronger U.S. financial climate, we can safely assume 2016 and 2017 would yield at least these same amounts. \$22 trillion within these four years. How then are we accumulating this immense wealth while not able to pay down our national debt, now at over \$19 trillion? This means your taxes paid to service the debt goes into a black sinkhole, having no effect at all. These numbers do not lie. I explained in oxymoron in 2014. These policies -- bonded by the U.S. treasury and through the U.S. financial sector, where the super rich are, and away from the commercial sector where you and I are. This violates antitrust laws and the Federal Reserve act of 1913 that requires reinstating the Glass Steagall Act of 1933. This lopsided \$22 trillion will bail out all states' troubled pension funds, social security, bad student loans. It will properly fund our public schools, provide raises for schoolteachers and Donald Trump's \$53 billion

for the military, etc. And with trillions left over for corporate profits.

Please copy and mail this packet to your local, state, and federal officials that demand that these three policies be referred to rebound our economy, or remove them from office.

PRESIDENT YATES: You may finish your sentence.

Councilwoman Sexton Smith, would you please introduce your guest?

COUNCIL MEMBER SEXTON SMITH: Yes, Mr. President. May I approach the podium and invite my guest to join me?

PRESIDENT YATES: Please do so.

COUNCIL MEMBER SEXTON SMITH: Thank you.

Mr. President, we have a little tiny one down here behind me. And I don't know if anyone can lift her up. But if not I would love for her to approach the gate to everyone can see her as she is with us. Would you wave at all my friends, please? There you go.

Mr. President, thank you very much for opening the bench to our special guests this evening. We are here this evening to honor the life and legacy of another little one. So here with me is Micheshia Norment, who is affectionately known by all of us in the community, and the country and yes, the world, as Keshia. We love her dearly and we will stand with

her and beside her as she has been a true champion for strength and love and power of the love and transformation over what she has experienced in the last two months.

So, Keshia, on behalf of the entire Louisville Metro Council, as your council representative, you have been living in District four for a long time. You have continued to live in District four. I'll read the official proclamation honoring the life and legacy of your little one.

The proclamation reads. In memoriam honoring the life of Dequante Hobbs, Jr.

Know ye that the Louisville metro legislative council hereby recognizes.

Whereas, Dequante Hobbs, Jr. was born January 26, 2010, in Louisville and lived in the Russell neighborhood, and he was known affectionately as little Q.

Whereas Dequante was a special needs child with a passion for education and especially reading.

Whereas Dequante attended Wellington Elementary and excelled in spelling, reading, and was recognized for having the very best penmanship in his entire class.

Where Dequante was promoted to the second grade and did not get to attend the ceremony.

Whereas Dequante taught himself how to play the piano at three years of age and composed music on his tablet.

Whereas Dequante instilled hope in the hearts of everyone he met.

Whereas Dequante was shot on May 21st, 2017, while sitting at the kitchen table and passed away shortly after midnight on May 22, 2017, with his mother by his side.

Whereas Dequante loved butterflies, as the picture depicts on the screen, and he loved trucks.

Dequante's mother Keshia launched justice for little ones, the nation's first reading program to honor the life and legacy of little ones. It is a campaign for families who have lost their little ones to violent, justice for little ones is asking everyone to read a book in honor of our very own Dequante, Little Q.

We hereby confer this recognition with all the rights can privileges and responsibilities thereunto appertaining. In testimony whereof we have caused these letters to be made with the official seal of the Metro Government to be hereunto affixed. Done in Louisville, Kentucky, this 27th day of July, 2017, as your honorable 4th District Councilwoman.

Keshia, would you honor and bless all of us here this evening and just say a few words about what reading and how little Q lived his life and why that was so important to him?

>> Thank you.

I was raising my son to be a very well-educated young man. Reading books at the library was one of his favorite things. Sometimes once a week. -- -- (off mic).

COUNCIL MEMBER SEXTON SMITH: Thank you, Keshia.

Each of the Louisville Metro Council members placed a bookmark. And those who have children and grandchildren -- yes, wave your bookmarks. Thank you, Councilman Engel for that leadership. If anyone has children

and grandchildren and you would like to have more, they have been here every step of the way. We have more of those. And we would like to thank you for your leadership and being there for so many over so many years in their time of need.

[APPLAUSE.]

Thank you very much, Mr. President, and all the folks here with us in Keshia' family. And I would like to especially recognize Dequante Hobbs Sr., who is standing right here. Thank you.

PRESIDENT YATES: Thank you, Councilwoman.

Councilwoman Shanklin, please introduce your guest.

COUNCIL MEMBER SHANKLIN: If there is anyone here who has worked with Dale or knows Dale, please come on down. Mr. President, I brought lieutenant Dale Thompson to honor him. As council people, we have police officers we work with every day. And some go, some come. We see different ones.

But Dale, he has been in my District 13 years and has meant a lot to us in the Newberg area. You get attached to the same ones. But the way it is today, they move them around, and I know it wasn't that long ago some of the other council people were crying because their person moved. Well, I was thinking, well, I have Dale and he is going to stay. Well, finally, he is moving.

So I'm really heartbroken. And I just want to tell a little story about Dale. I have worked with Dale a long time, and I have a lot -- and some of you may know this. I have praised him now and then. I think one of them was here the week before last. And I have one that is in my district right now. And from time to time he may be standing out front.

The other day, I looked in my mailbox and I had this much mail in there from this individual. And his name was on it. And the first thing I did, I called my major, and then I told him, well, I don't know what to do about it. I said, call Dale, he will know. So he called me back. And Dale told me all about the situation. And he said we will have a detective come and all of that.

So Dale has been very special to me. He knows the people in the area. It means a lot. And one other thing that a lot of people don't know about Dale, he is Rick's personal security. If you watch the U of L games, you'll see Dale sitting there. Last week he surprised me with a U of L basketball jersey signed by Rick PATINO. I was so surprised, but I should have known something was up when he gave it to me because I had been begging for years. So I am heartbroken, but I did want to recognize him because he has done so much for me. And he did bring an officer with him and said she will be taking care of you. And you know how short I am.

This lady was shorter than me. And so I didn't have a lot of confidence. But I know she knows her job. He said Barbara, you'll be all right. She will be looking out for you. I looked at her, and she was a little bitty lady. I appreciate Simpson being here as well, because he is one of the other officers. I want to give this recognition to Dale.

Louisville Metro Council, to all whom these letters shall come, greetings.

Know ye that the legislative council of the Louisville/Jefferson County Metro Government hereby recognizes and honors Lieutenant Dale Thompson in honor and recognition of your 13 years of devoted tireless

service to the Newberg community as an integral part of our district. And I mean that.

Here is a councilman who will spend 12% of that that could be going to sidewalks, road, beautification, things that will affect their citizens' lives. That boils down to we will pay for this lack of public protection one way or another. And unfortunately for the district, District 8, this is one way they are paying for it and this is something we should be looking for in an annual budget and the city should be taking our police department staffing a little more seriously. I am going to support this and support councilman Coan in his efforts to maintain safety in District 8. Thank you, Mr. President.

This is the NDF we did a couple years ago, and we also did a program on metro TV about the training and the outreach. And it is a good program that goes to churches and community exercise schools, and it teaches adults and children the hands-only CPR which can be taught very quickly and is life-saving. If anyone wants to add to it, that is fine. We have reached our goal. This should get them through the next year with their capital needs. So thank you very much.

COUNCIL MEMBER WOOLRIDGE: Thank you, Mr. President. These dummies for the heart foundation, they are very valuable. When I chaired health and education, they came before our committee. I would like to contribute to this.

COUNCIL MEMBER MULVIHILL: Thank you, Mr. President. I'm going to just briefly speak on item 63 and 64. Collectively. Both of these items were heard last week in government accountability. There were further amendments made. Both items passed out unanimously.

However, prior to that there was a work group in place that met twice and spent considerable time discussing and amending these items as well. And this is about the anonymous tip line and the harassment policy that we are looking to put in place. I think both of these items are very good pieces of legislation. Again, there was a considerable amount of time put in by the work group and as the committee as well. And I have to thank the county attorney's office because they were there with us every step of the way in helping us craft this. So with that, I would ask the primary sponsors to give an overview of the changes in 63 and then likewise in 64, and that is Councilwoman Green.

PRESIDENT YATES: Thank you. If either would like to click in the queue.

COUNCIL MEMBER GREEN: I'll go first. Thank you, Mr. President. I first want to make sure that I publicly thank Councilwoman Leet for having the wherewithal to be able to recognize the gaps in policies and procedures here in Metro Council. So everybody in this building deserves to be able to live and to be able to work in an environment free from harassment. What we have hoped to do is to put together a comprehensive legislation to make that actually occur. So in addition to thanking

Councilwoman Leet I would definitely like to thank Ms. Martin and Mr. GRANAGER who have spent a considerable amount of time. Thank the work group for this as well. Two pieces legislation. I will address them together.

The tip line ordinance is fairly simple. All it does is bring Metro Council under the purview of the existing tip line. That tip line is open 24 hours a day. There is a toll-free number that would be allowed to be utilized. So this allows us to go up underneath that already-existing umbrella.

The next piece of legislation, the resolution I will address, what this does, again is to allow us to have a process and procedure here at Metro Council that protects our employees and that protects each of us as council members from any type of harassment. It also holds all of us responsible should we commit that kind of behavior. So I addressed in committee of the whole what the process is and I will also address here publicly what the process is.

There are three ways that a harassed individual could report harassment. The first way being they could directly call the anonymous tip line. They could also directly call the third-party investigators we are instituting as part of the process. And they could also call their supervisor. The supervisor, many of us council members, this policy puts a duty to report on us. The next step would be the third-party investigator would have 48 hours in order to be notified of what the allegations are. The third-party investigator would take up to five days to determine whether or not they believe that the allegations are vexatious. If they are not, the third-party investigator has 30 days to investigate what the

allegations are. A sworn complaint must be filed as part of the process by the individual alleging harassment.

At that point, the person who is the alleged harasser would have seven days to respond after the third-party investigator has completed their report and at that point the committee of the whole would have 21 days in which to decide whether or not they want to follow the recommendations of the third-party investigator. A considerable amount of time and energy has been spent on both of these pieces of legislation. I feel like they are good pieces legislation. They are well thought-out, and I would appreciate your support. Thank you very much.

PRESIDENT YATES: Thank you, Councilwoman Green.

I have in the queue Councilwoman Vicki Aubrey Welch and Councilwoman Cheri Bryant-Hamilton but I'm thinking Councilwoman Leet would like to speak.

Councilwoman Leet.

COUNCIL MEMBER LEET: Mr. President, this policy has been months in the making, and I want to thank my colleague Councilwoman Green as well as to acknowledge the help of the county attorney's office. They have spent hours, they have spent time on Sunday. When there was certainly other things we could have been doing. I believe what we are working on and what is before us this evening will ensure protection of not only Metro Council members but also our other colleagues, employees, their assistants, the clerk, and everyone else working in Metro Council hallways. And I feel like we should never feel unsafe in our work environment, and I think this these two pieces of legislation will move us

closer to that and bring us closer to the 21st century. I appreciate your support.

I would like to state that I have received a message that Councilman Blackwell would like to be added as a sponsor of this. I would like to throw that out there as a motion as well.

PRESIDENT YATES: Thank you, Councilwoman.

Councilwoman Welch.

COUNCIL MEMBER WELCH: I would like to be added as a sponsor. And I can verify I also got the e-mail from Councilman Blackwell's office that he wanted to be a cosponsor.

PRESIDENT YATES: Thank you, Councilwoman.

Councilwoman Cheri Bryant-Hamilton.

COUNCIL MEMBER BRYANT HAMILTON: Thank you, Mr. President. I would like to thank the work group. And I would like to be added as a sponsor.

PRESIDENT YATES: Thank you, Councilwoman.

Councilwoman Barbara Sexton Smith.

COUNCIL MEMBER SEXTON SMITH: Thank you, Mr. President. And I too would like to thank everyone that worked on this. This has been a long journey, and great work has taken place. Great communication and exchange of ideas has brought us, yes, Councilwoman Leet, into the 21st century. So thank you, and councilwoman green, for leading that. Please add me as a sponsor.

PRESIDENT YATES: Without objection, she is added as a sponsor.

Councilwoman Parker.

COUNCIL MEMBER PARKER: Please add me as a sponsor.

PRESIDENT YATES: Councilwoman Butler.

COUNCIL MEMBER BUTLER: Would you please add me.

PRESIDENT YATES: Councilwoman Fowler.

COUNCIL MEMBER FOWLER: Would you please add me as a sponsor as well?

PRESIDENT YATES: Councilwoman Shanklin.

COUNCIL MEMBER SHANKLIN: Please add me.

PRESIDENT YATES: Councilman Stuckel.

COUNCIL MEMBER STUCKEL: Please add me.

PRESIDENT YATES: Councilman Johnson.

Without objection, would everyone like to be added as a sponsor?

Without objection, all those in attendance, please be added as a sponsor, Mr. Clerk, including myself.

Is there any further discussion? You have to raise your hand if you want to discuss, as the queue is full.

Hearing none, this is an ordinance requiring a roll call vote. If the clerk would open the voting.

Without objection, the voting is closing. The voting is closed.

MR. CLERK: 20 yes votes and six not voting.

PRESIDENT YATES: The amended ordinance passes.

We will pull up a reading of 64, which has been discussed.

MR. CLERK: A RESOLUTION OF THE LOUISVILLE METRO COUNCIL AMENDING THE METRO COUNCIL POLICIES AND PROCEDURES TO ADD AN ANTI-HARASSMENT POLICY. (AMENDED BY SUBSTITUTION)

Read in full.

PRESIDENT YATES: May I have a motion and second for approval?
Properly moved and seconded. Councilwoman Green, would you like to add to
this?

COUNCIL MEMBER GREEN: Yes. President Yates, I just wanted to
find out if all the individuals who were added as sponsors to the previous
one would like to be added as this one. I think that would save us only
time.

PRESIDENT YATES: Without objection, all members in attendance
would be added as sponsors. No objection made. All members will be added
as sponsors.

Councilwoman Leet.

COUNCIL MEMBER LEET: We need to include Councilman Blackwell on
this.

PRESIDENT YATES: Mr. Clerk, without objection, Councilman
Blackwell has requested he be added as a sponsor to the ordinance. Please
do so.

Without objection. All members in attendance and Councilman
Blackwell.

Councilwoman Leet.

COUNCIL MEMBER LEET: Thank you, Mr. President. I don't think I
said thank you to everyone in the last time I spoke for the collaborative
efforts. We had good discussion. I wish we could pass all legislation this
way. I thought we worked well together. It was almost like the budget
process. So thank you all.

PRESIDENT YATES: Thank you, Councilwoman.

Is there any further discussion? Hearing none, this is a resolution allowing for a voice vote. Mr. Clerk, but I'm going to go ahead and ask you to open the roll call.

MR. CLERK: 20 yes votes and 6 not voting.

PRESIDENT YATES: The amended resolution passes.

Mr. Clerk, out of request from each of the sponsors, I have been asked to hold items 65 and 66.

MR. CLERK: So noted.

PRESIDENT YATES: Our next item of business is new business. As you leave the chambers, please do so quietly so the clerk may read new business.

I would ask those council members that wish to make announcements to please remain in chambers and request to speak on your system under announcements.

New business comprises items 67-89. Would the clerk please read those assignments and their assignments to committee.
