

**Statement to Louisville Metro Council, July 30, 2015**

***"Please Help End My Physical Suffering By Bad Judges"***

I am Carolyn Jones. Please enter this statement into the record. I come to remind the Metro Council that I still suffer from lodged dental droppings within my chest and lungs. I suffer daily from inflammation built-up in my body. I have swollen, uncomfortable lymph nodes under each arm pit. I must apply pressure to these lymph nodes to relax my arms. My underarms are also bruised blue, due to the lymph nodes being stressed.

I can only sleep with my limbs in a propped positions to avoid laying the wrong way, to prevent heart palpitations. Both of my thumbs are irritated and painful when I barely tap them in anyway.

I also suffer skin irritation, my headaches are worse, and it's difficult to do the simplest daily activities. I had an MRI a few weeks ago, due to a car accident. A few hours later, my eyes started hurting, I believe caused by the foreign bodies inside me.

Obviously I need treatment. And it is unbelievable that the courts have not ordered treatment for me. The Metro Council and citizens of Louisville have to power to end my suffering. The judges do not like for blacks to prevail in court, no matter what Our evidence is. Louisville judges also deny the rights to some whites, too. As you know, my Notices-of-Removal are filed with **Jefferson County Sheriff John Aubrey** and the **Kentucky Supreme Court** for removing **Judge Charles L. Cunningham, Jr.** from the bench. Judge Cunningham has refused to process my medical claim, even though no attorney would accept my case.

And now my claim is in the Kentucky Court of Appeals. And these judges are not considering the urgency of my medical condition.

And because I am fighting my case, I believe I am being attacked almost everyday by "directed energy weapons" (DEWs), the same as

Ms. Connie Marshall has complained to you.

If you want a clear mind, non-confused thinking, then you have to “do the right thing.” Then life becomes clear. Our nation will continue to degrade, until we as a people decide to do the right things in Our daily lives. Here, you can help end my physical suffering by demanding the *Court of Appeals* to “**expedite case 2014-CA-1628.**”
