ADOPTION AGREEMENT

This Agreement is made on 11/5/2014 between the Louisville/Jefferson County Metro Government, acting by and through its Department of Louisville Metro Animal Services ("MAS") and Ritchie Gypsy, the adopter. By signing and initialing each statement below, I acknowledge receipt of A544384, a dog, described as a chihuahua sh, tan in color from MAS. I am at least

1. \_\_\_ Provide proper and sufficient food, water, shelter, training, exercise and veterinary treatment for the animal in a devoted and humane manner for the duration of its natural life. I will not allow the animal to be used for purposes of vivisection or experimentation.
2. \_\_\_ Have the animal examined by a veterinarian within three (3) business days of the adoption at my expense.
3. \_\_\_ I understand that, if the animal needs veterinary treatment, I will be responsible for that cost. I will have this animal vaccinated, examined by a veterinarian and licensed every year. If at anytime I cannot afford, do not want to spend the necessary money, or do not want to pursue further any needed medical treatment, I will return the animal to MAS.
4.  Not sell, give away or abandon the animal. If for any reason, I no longer wish to own the animal, I will return the animal to MAS for placement or evaluation. Any decision on the disposition of the animal after its return to MAS will be made solely by MAS.
5. \_\_\_ I shall not attempt to recover from MAS any expenses paid by me in connection with the animal.
6. \_\_\_ Keep my animal enclosed on my property and within control. I will not permit the animal to run at large or to become a public nuisance. I will keep a current means of identification, including rabies and license tags, on the animal at all times. I will ensure that all microchip registration information is kept current with the HomeAgain national registry. If I lose my animal, I will immediately retrieve the animal from any public or private shelter when notified that the animal is being held there. If the animal is lost, I will diligently attempt to locate and reclaim the animal. I certify that the animal is being adopted to remain with me and my immediate family.
7. \_\_\_ I understand that this animal may have possible known, unidentified or incubating medical issues.

MAS has explained to me, and I understand, that adopting a pet requires a lifelong commitment to provide for the animal's care and contentment. I acknowledge that I have carefully considered this adoption, and the responsibility it requires of me, and that I shall make every effort to provide for the needs of my new pet, whatever they may be, to the best of my ability. As a last resort only, I understand that I can exchange my animal for another MAS animal or return the animal for a refund or credit minus \$25 as an administrative fee, within seven (7) calendar days from the date of this Agreement. If I choose to seek medical treatment for the animal instead of returning the animal, I will be fully responsible for all expenses. After this seven (7) day grace period, I can relinquish my animal to MAS but understand that I shall not be entitled to any refund or credit for any costs I have incurred.

I understand that the information provided to me about the animal I am adopting may have been received by MAS from third parties and that MAS cannot guarantee that this information is accurate or complete.

I understand that animals can be unpredictable and that MAS cannot anticipate or insure against unexpected conduct of animals adopted from MAS. I acknowledge that Metro Animal Services does not make, through its agents, volunteers, or employees, any warranty regarding the future condition, temperament, or conduct of the animal. I hereby accept the animal as is, and assume all risks and responsibilities associated with ownership of the animal, including bites, medical issues and other behaviors. I hereby release, indemnify and hold harmless Metro Animal Services and the Louisville/Jefferson County Metro Government, its directors, officers, volunteers, agents, servants, and employees from any claim, cause of action or liability of any sort or nature, whether known or unknown, arising out of or in connection with this animal.

I agree to pay all court costs and attorney's fees arising out of any legal action connected in any way to this Agreement. I understand this Agreement and shall comply with its requirements.

**ADOPTION WAIVER**

These are your rights under Chapter 91 of the Louisville Metro Code of Ordinances:

If you purchase any puppy, dog, kitten or cat and:

- Within thirty (30) days after such purchase, the animal is certified by a veterinarian as having been unfit for purchase because it suffers from, or dies as a result of, a disease or parasite condition, or
- Within one (1) year of the date of purchase, the animal is certified by a veterinarian as suffering any congenital or hereditary condition;

*You Loose*

**Then you have the right to return the animal to the seller within seventy-two (72) hours of the veterinary certification and receive a full refund or exchange of equal value, or you may keep the animal and attempt to cure the condition. You may recover certain qualified veterinary fees up to the purchase price of the animal. If you sign this waiver, you will lose these rights.**

I understand that I waive these rights and take ownership of this animal "as-is" and that the Louisville/Jefferson County Metro Government makes no warranty, expressed or implied, including, without limitation, any warranty of merchantability or fitness for a particular purpose.

Louisville Metro Animal Services !

For those people that say rescues are strict, harder to adopt a dog than a child, that we ask for financials, a 10 ft fence, a sprawling mansion and everything else..first off that's a total lie and not even close to the truth. BUT great rescues pour their heart, soul and pockets into every dog we take in. We love these dogs and want them to never ever suffer again. THIS is one example of many of why rescues have policies and procedures. I have literally cried over this boy, went to bed thinking of him and it crushed me knowing that he had to leave with the monsters a few weeks ago. I'm ecstatic for him now and forever grateful to the rescue. These photos don't show how bad off he truly is. He has the sweetest soul though and will never go without again. 🙏❤️

Earlier this month, people were celebrating the fact our local shelter was able to give all their dogs away. I can tell you first hand that no one in the rescue community shares in those celebrations. Most people are shocked when I express how much I hate "empty the shelter" events. So I explain why:

LMAS does zero vetting when doing this. An example is the person who claimed they were the owner of a dog She had been found GUILTY of animal neglect cruelty after LMAS brought charges against her. Part of her punishment was she could not own a dog for 2 years. Yet LMAS adopted a dog to her 6 months later. It wasn't the same dog but the dog ended up in a bad situation and was euthanized.

LMAS will not take back the dogs they adopt out. After every "empty the shelter", rescues are flooded with requests from people who got a dog and no longer want it. The reasons vary and in most cases it's because they never should have been given that particular dog. I have a list of examples for this point.

Those are my top two reasons but the photos below should drive my point home. This dog was adopted for free at LMAS in December. He weighed almost 40 pounds at the time. He was taken to the vet 2 weeks ago weighing 24 pounds. Owner was given medicine and instructions to follow up. Today on the follow up he weighed 22 pounds. He was dirty, dehydrated and reeked of urine. Most likely he's been locked in a crate the majority of the time with no access to food, water or a place to go to the bathroom. The owner didn't want to mess with him anymore but LMAS wouldn't take him back. Lucky for him a Dog Rescue stepped in to save the day. He is now part of the Family. What that means is he will get top notch care and once he is ready for adoption all applicants will be thoroughly screened - vet check, home visit and multiple conversations with us. And once he's adopted, as with all our dogs, he and his adopters will have our ongoing support.

Next time you hear about an "empty the shelter" event" I hope you remember these photos. Most of those dogs don't end up as fortunate as this sweet boy...

Their policy is that you can return an adopted dog within 30 days. After that it is an owner surrender. At the current time they are telling people that owner surrenders will be immediately euthanized.

That poor dog with fear aggression - turned in as a stray 4/26, went to foster, returned from foster 5/2, adopted 5/5, returned 5/7 for fear aggression, adopted again 5/14, returned again 5/22 for fear aggression, went to foster on 5/25. No wonder the dog hates everyone. Dog ID # A714306

For the 4 returned as aggressive to animals, 3 were adopted out and one is in foster

For the aggressive fear that's actually 2 records for the same dog. It was returned and adopted out again, returned again and went to foster

For the 4 that were aggressive to people, 2 were euth'd and 2 were sent to rescues

Sometime ago I believe it was in June. Jerry Foley was on Wave 3 News. When he was asked why they don't take in owner surrenders? Jerry Foley replied if they took in owner surrenders they'd be forced to euthanize strays for space. Allegedly Ozzy and Ashley Book was on vacation. If owners try to surrender their pets LMAS tells them it will be immediately euthanized.

So what is the above statement really saying. First off LMAS has gotten a new tool out of their tool box called EUTHANIZATION !!! Yep its used to justify not taking in owner surrenders even if you adopted the animal from LMAS. This is a absolute breach of contract to say the least.

What is the hidden real truth behind LMAS real statement. It allows them to claim to be a no kill shelter this is a out right lie!

How can you call yourself a no kill shelter when you refuse to take in owner surrenders? The thing that usually happens next is animals are dumped in the streets and owners say they ran off. When a rescue such as myself scans for a micro chip and contacts owner they don't want the dog back. .So I try to find the animal a new home.

If a rescue doesn't get the dog first the dog ends up being hit by a car, abused by people throwing things shooting arrows or guns at them or even worse they become bait dogs for fighting with their mouths taped shut. This is all due to LMAS refusal to accept owner surrenders.

So how can LMAS claim they are a no kill? By proxy they sentence a lot of dogs to a horrific death by refusing to take in owner surrender.

Ozzy does anything that makes him look good. Ashley Book wow I asked for a appointment to speak to her, well I got it but it wasn't actually with her it was with the Master Manipulator Skip, with over 30 years in the government Ashley said maybe 15 words and skip did the rest I didn't ask for a appointment with skip whatsoever I asked for a appointment with Ashley Book. But in reality I got it with the Master Manipulator Skip. So most people if there is another conference pending will say you have this much time then you will have to stop due to we have another appointment. But in reality Skip the master manipulator comes out with ok time to go we have another appointment.

People who work at LMAS are scared to speak out because they'll be fired. Rescues are scared to speak out because they'll be denied the option to pull animals and other tip bits they get at LMAS.

CONCLUSION:

LMAS needs to have a oversight committee with complete access to all data ,records, reports, any and all activity meetings, functions, all financial info animal info. Further the oversight should have a right to voice their approval or denial of a director of LMAS. Oversight should be allowed to interview, question, rules regulations, safety issues, Animal Rights, they should also have to power to interview any all staff undisturbed, uninterrupted, to investigate issues such as disclosed herein.

I will gladly Volunteer to be a fair impartial part of the oversight committee without pay for the welfare of the animals and I want LMAS to be right to succeed and advance forward but also I want accountability, integrity, honesty, for the animals.
