

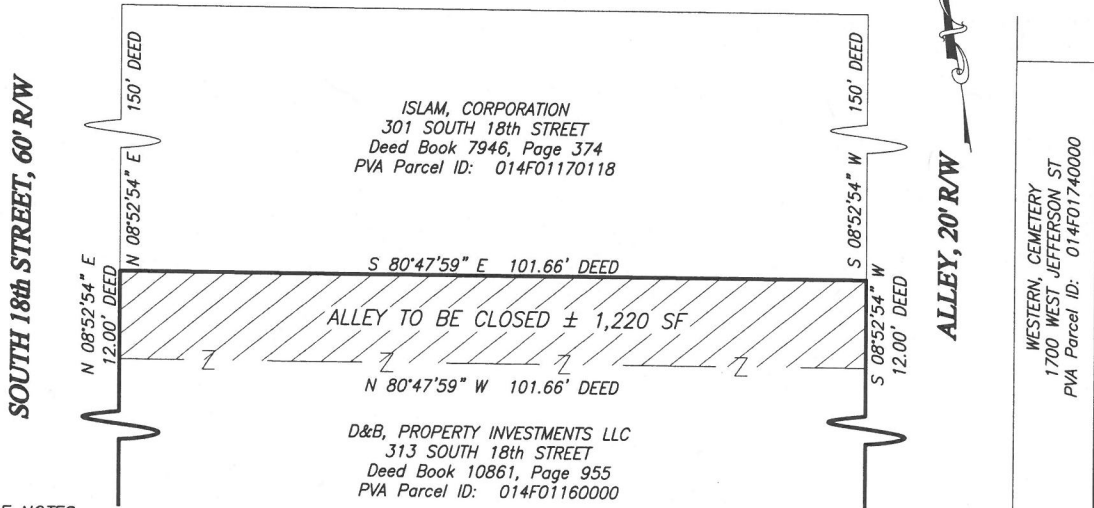
DESCRIPTION OF ALLEY TO BE CLOSED

Commencing at the northwestern-most corner of a parcel conveyed to the Islam Corporation, as described and recorded in Deed Book 7946, Page 374, in the Office of the Clerk of Jefferson County, Kentucky; pursuant to above referenced deed, said point being the "Southeast corner of 18th and Jefferson Streets". Thence, with the westernmost deed line of the aforementioned Islam Corporation parcel, South 08°52'54" West, 150 feet to the True Point of Beginning. Pursuant to deed, said point being on the southernmost deed line of aforementioned Islam Corporation parcel. Thence, with the south deed line of the aforementioned Islam Corporation parcel, South 80°47'59" East, the deed distance of 101.66 feet to a point on the west line of a 20 foot alley. Thence, South 08°52'54" West, 12 feet, to the northeastern-most deed corner of a parcel conveyed to D & B Property Investments, LLC, as described and recorded in Deed Book 10861, Page 955, in the above referenced Clerk's Office. Thence, with the north deed line of D & B Property Investments, LLC, North 80°47'59" East, 101.66 feet, to a point of the east line of South 18th Street. Thence, along the east line of South 18th Street, North 08°52'54" East, 12 feet to the True point of Beginning, enclosing +/- 1,220 square feet.

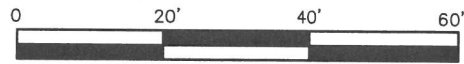
MERIDIAN NOTES
