Call to Order

Chair Person Dorsey called the meeting to order at 3:01 p.m.

Roll Call

Chair Person Dorsey introduced the committee members and non-committee members present. A quorum was established.

A motion was made by Vice Chair Piagentini, seconded by Committee Member Purvis, that this Ordinance be untabled.

The following was discussed:

A motion was made by Chair Person Dorsey, seconded by Vice Chair Piagentini, that this Ordinance be amended by substitution as shown in the attached document "O-593-20 PROPOSED CABS 03.16.21 - Ordinance for Paid Parental Leave 12 Weeks Final 1.pdf."

- There were several questions regarding whether 12 weeks of paid leave mirrors the Federal guidelines.

A motion was made by Vice Chair Piagentini, seconded by Committee Member Winkler, that the proposed amendment by substitution be amended as follows:

- In section 7, page 4 (2nd to last sentence) strike "vacation" from the sentence leaving "holiday and short term disability."

- Add a sentence stating "employees will not accrue vacation time off during paid family leave," preceding the sentence stating "a employee may be eligible for this benefit..."
- There were several questions regarding whether current employees accrue sick and/or vacation time during paid family leave.
- There were several questions regarding employees continuing to earn accruals during paid family leave.
- There was a discussion regarding how Louisville Metro processes accruals. Current policies state that employees do not accrue sick time during paid leave, however, employees may accrue vacation time.
- There were several questions regarding whether the 12-week paid leave would begin at the onset of the leave or after an employee's accrued time has been exhausted.
- There was a discussion regarding the breakdown of various accrual times employees may receive such as sick, comp, vacation, floating holidays, and sick incentive.
- There were several questions regarding the maximum amount of time an employee may accrue during paid leave.
- The maximum amount of time an employee may accrue leave time is contingent upon the employee's tenure with Louisville Metro.
- There was a discussion regarding whether employees are required to exhaust all sick time before using other accrued time while on paid family leave.
- There was a discussion regarding whether employees may accrue paid leave time during a paid leave period, but do not accrue paid leave time while on a non-paid leave period such as Family Medical Leave.
- There was a discussion regarding whether this policy change for family leave would be a spin-down versus paid benefit.
- There was a discussion regarding all eligible candidates under the policy.

The motion to amend the proposed amendment by substitution failed by a voice vote.

- There was a discussion regarding making clear distinctions and definitions between kinship and foster care.

A motion was made by Chair Person Dorsey, seconded by Committee Member Mulvihill, that the proposed amendment by substitution be amended as follows:

- Remove "FOSTER CARE also means any temporary kinship placement resulting from a court order."
- Add the definition of Kinship Placement as follows: "KINSHIP PLACEMENT. Kinship placement means the temporary placement of a minor with a relative or fictive kin by a court order."
- In subsections 35.014(B)(2) and (3), after "foster care" add "or kinship placement."

The motion to amend the proposed amendment by substitution carried by a voice vote.

The motion to amend by substitution carried by the following vote:

There was discussion about a change from ‘PAID PARENTAL LEAVE’ to “PAID FAMILY LEAVE” that was already made in the title of the amendment by substitution.

The motion to recommend for approval carried by following vote and the amended Ordinance was sent to Old Business:
