REQUEST

 Category 3 Plan to construct a single-family residence, submitted in accordance with Ordinance Number 16, Series 2006 that requires proposed development in the Portland Neighborhood to go through a Category 3 review prior to issuance of a building permit (as amended).

CASE SUMMARY/BACKGROUND/SITE CONTEXT

1-story, 6,467 sf. medical office is proposed.

The FAR is below the maximum permitted in the C-2 zoning district. The proposed setbacks and building height meet dimensional standards. The applicant has submitted elevations of the proposed house that meet building and site design standards. A 3-ft. masonry wall, required to screen the parking, is proposed. The required parking, sidewalk, internal pedestrian connections, landscaping and tree canopy are proposed.


