

Councilman Blackwell,

Major Hasch asked me to send you an email in regards to OT funding to address the street/drag racing concerns in the area of Intermodal and Logistics. From previous emails that I have the primary times of the activity occurring is from 2200-0300 hours on the weekends. Due to the amount of people participating in the activity 4 officers would be a good amount to address the concerns. Four officers for four hours each night of a detail would cost approximately \$960. If we were to run details for four consecutive weekends that should help spread the word and help to curb the activity. To run one detail each week for a month the approximate cost would be \$3,840. Please let me know your thoughts on this and how you would like to proceed.

Also, Officer Boyd checked today about trespass waivers for the area businesses and is following up with each of them to get everything posted to help with enforcement actions that we take.
