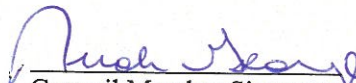

Beechmont Neighborhood Association volunteers to help maintain a Metro Park's Landscape Bed along the Olmsted Parkway of Southern Pkwy. The Metro Council Office has paid for the landscape bed to be cleaned up and re-planted in alignment with Olmsted's vision as a phase 1 project. Starting in the spring, volunteers will need to have access to water the plants. Right now, we don't have a solution for how they can regularly access water at the site.
