### Call to Order

The following was discussed:

- There were several questions regarding the existing traffic guard collective bargaining agreement and whether it would allow Louisville Metro to contract with third parties.
- There was a discussion regarding the provisions of the collective bargaining agreement and its flexibility to allow contracting with third parties.
- There were several questions regarding whether the Mayor's Office had taken any measures to exercise the provisions of the collective bargaining agreement to contract with third parties or suburban cities.
- There was a discussion regarding the urgency of addressing/rectifying this issue, including sharing two videos of an incident where no crossing guards were present.
- There was a discussion regarding the process for the Louisville Metro Police Department to delegate crossing guards throughout Louisville Metro at Jefferson County Public Schools.
- There was a discussion regarding staffing shortages with crossing guards and police officers in the Louisville Metro Police Department.

A motion was made by Vice Chair Peden, seconded by Committee Member Fox, that this Ordinance be amended as stated by Council Member Piagentini.

- There were several questions to clarify the wording changes while reviewing the current legislation.

The motion to amend carried by a voice vote.

The discussion continued and the following was discussed:

- There was a discussion on the current staff shortages of traffic guard personnel in the Louisville Metro Police Department. Currently, nine traffic guards positions have become vacant in the past two weeks.
- There was a discussion regarding whether the Louisville Metro Police Department could provide officers to patrol schools during the traffic guard shortage.
- There was a discussion regarding police officer shortages.
- There were several questions regarding the number of crossing guards needed to staff all Jefferson County Public Schools. The Louisville Metro Police Department is tasked to provide crossing guards at 116 schools.
- There were several questions regarding the process to determine which schools require/need traffic guards.
- There were several questions regarding whether the traffic guard applicants may select the schools/locations to work.
- There were several questions regarding whether the Louisville Metro Police Department has contacted outside groups, such as volunteers, to train as crossing guards.
- There was a discussion regarding the Mayor's Office prioritizing hiring traffic guards.
- There was a discussion regarding having multiple traffic guards at larger schools.
- There was a discussion regarding Jefferson County Public Schools hiring off-duty officers to work on school property versus public property, i.e., public roads.
- There was a discussion regarding cost-sharing between Louisville Metro and suburban cities to employ crossing guards.
- There were several questions regarding whether the Louisville Metro Police Department had contacted suburban cities to contract additional traffic guards.
- There were several questions regarding whether the Louisville Metro Police Department considered opening the current traffic guard contract for renegotiations.
- There were several questions regarding whether the Louisville Metro Police

Department has received any direction from the Mayor's Office regarding this issue.

- There was a discussion regarding Louisville Metro being responsible for roadways.
- Council President James requested to be added as a sponsor of the legislation.
- There were several questions regarding whether the Louisville Metro Police Department would discuss opening the collective bargaining contract with the Mayor's Office.
- There were several questions regarding whether the Jefferson County Public School Foundation or Parent Teacher Association could fund third party vendors for crossing guards.
- There were several questions regarding whether Louisville Metro could fund training for volunteer traffic guards if the Jefferson County Public School Foundation contracted with third parties.

A motion was made by Committee Member Fox, seconded by Committee Member Flood, that this Ordinance be amended, to add the following: "In the event the school is located in a suburban/rural city within Louisville Metro and provides full-time police services to their community, they shall either provide the service or cost-share with Louisville Metro."

- There was a discussion regarding Jefferson County Public School students attending schools throughout Louisville Metro including in suburban cities.
- There was a discussion regarding cost-sharing not being a component of the original statute creating the Louisville Metro Government.
- There was a discussion regarding cost-sharing causing financial impacts on suburban cities.
- There was a discussion regarding the jurisdiction of Louisville Metro versus suburban cities on public roads.
- There were several questions regarding whether Louisville Metro has authority to dictate how suburban cities may expend funds.

The motion to amend failed by a voice vote.

- There was a discussion regarding a possible memorandum of understanding between the Louisville Metro Police Department Chief and suburban city police chiefs.
- There was a request for a Jefferson County Attorney opinion on whether Louisville Metro has the authority to dictate suburban cities' expending of funds.

The motion to recommend for approval carried by the following vote and the amended Ordinance was sent to Old Business:
