MEETING NOTES
MARIAN DEVELOPMENT/BRADFORD MILLS
June 11, 2018

The meet was held at the Germantown Paristown Neighborhood Center. Justin Brown with Bradford Mills, LLC and Cliff Ashburner with Dinsmore & Shohl introduced the proposal, which is a Conditional Use Permit for off-street parking to add spaces for the existing Bradford Mills Lofts.

The questions raised by those in attendance included concerns about on-street parking in the area, policing the parking lot, lighting plans for the commercial part of the project, trash pick up, and overall operation of the Bradford Mills Lofts development.

Mr. Ashburner explained the CUP process and timing. Mr. Ashburner also explained that the application was in part because of the concern about parking that was raised during the initial rezoning process for Bradford Mills. Mr. Ashburner explained the lighting requirements of the Land Development Code and that the proposal would comply with them.

Mr. Brown answered additional questions about the use of existing spaces and the policing of the existing parking spaces. He explained that existing tenants get a parking pass and may obtain guest passes to use the parking lot. He also explained that a courtesy officer patrols the lot to make sure non-residents are not using it.

Mr. Ashburner answered a question about drainage by stating that the existing system would serve the new spaces, too.

Mr. Brown explained that the previously-planned commercial space will no longer be commercial but will either be additional units or common space. Mr. Brown reiterated that Bradford Mills wants to be a good neighbor and that he will work to address issues that may arise in the future.
