Amendment Summary: Projected Savings

Total: \$2,211,900

Bond Issue Dates for 2015-2016

Mayor's Proposal –
Issue Bonds/Notes on December 1, 2015
First Payment would be due June 1, 2016
(Six Months after Issue Date)

Metro Council Amendment –
Delay Issuance of Bonds/Notes until February 1, 2016
First Payment would be due August, 2016
(Six Months after Issue Date)

*Amendment would not change the payment amount.
1st payment would be delayed 2 months.

Priority: Increasing Paving / Road Improvements

Mayor's Office Suggested Language for Budget Amendment

Funding Source: Increase Principal Amount of the 2015B Bond from \$10,000,000 to \$15,000,000

Purpose: Roadway paving distributed as follows: \$1,950,000 to be utilized by each Metro Council Member to pave \$75,000 primarily neighborhood roads in their respective District \$3,050,000 to be utilized by the Public Works & Assets Department to pave roads in the worse condition based on (c) below Collector and arterial roads will be rerated as stated and funded in the Capital Budget All roads funded by these bond proceeds will be approved by the Metro Council Appropriation Committee if not contained in the FY16 Capital Budget

Metro Council FY16 Paving Plan

Fund Reevaluation of Corridors and Arterial Roads:	\$200,000

Additional Paving/Road Improvements on Neighborhood Streets:	\$1,950,000

- All Roads must be identified by December 31, 2015
- Monthly Reports are to be submitted to Metro Council by Public Works outlining progress addressing road needs and schedule for addressing these needs.

Budget Language Changes (Verbiage submitted for approval at Committee on Tuesday)

Q. Public Works & Assets will provide the Council with a monthly status report of all paving projects funded from any source. The report will contain at a minimum all paving projects funded, expected start date, completion date and actual cost of the project.

R. Public Works & Assets will provide the Council with a monthly status report of all sidewalk repair projects funded from any source. The report will contain at a minimum all sidewalk repair projects reported (funded or unfunded), expected start date, completion date and actual cost of the project



Future Road Funding

LG&E Franchise Fee

- If there is a franchise fee, Members of the Metro Council's Budget Committee believe funds derived from it should go towards improving Metro Roads.
- The Franchise Fee will be renegotiated and reviewed by the Metro Council in November 2015
- The current LG&E Franchise Fee is expected to collect approximately \$3.8 million during the final nine months of the current agreement expiring on March 31, 2016.
