**President James stated this Resolution is to encourage Congress when they consider their next package related to the Covid-19 pandemic to include legislation to help people with their rent by paying directly to their landlords for rent payments. In Kentucky we have an Eviction stay that is in effect until July 1, 2020. However, after July 1, 2020 this will become problematic. In Jefferson County there will be thousands of citizens at the start of eviction. The Government asked the businesses to shut-down due to the Covid-19 pandemic and a lot of citizens have lost their jobs no fault of their own. He stated he don't want to see them evicted on the street.**
