PRESIDENT KING: Thank you. I do know that Councilman Yates is here in the building, and he will be in momentarily. Councilman Tandy has an excused absence. Please cause the record to reflect that.

MR. CLERK: So noted, sir.

PRESIDENT KING: Councilman James, you have a page tonight.

COUNCILMAN JAMES: Yes, Mr. President. I do.

PRESIDENT KING: Would you like to introduce your page?

COUNCILMAN JAMES: I would love to introduce my page.

PRESIDENT KING: You have the floor.

COUNCILMAN JAMES: There she is. So, colleagues, I would like to introduce you to MiAngel Carr. Her last name is Carr. Her first name is MiAngel. She loves her school. She is fourth grade at Cochran Elementary School and she turns ten on the 30th of August, which is in two days. So this is like her opportunity to have a great birthday treat. And so if we could all just take a moment and say happy birthday to MiAngel. Happy birthday.

And MiAngel lives with her grandparents and she is very active in school. Cheerleader in second year and she participates in the principal's club and she has a certificate for the after-school science club. And last year she made the honor roll. So, colleagues, I would really like you to welcome MiAngel. Thank you.

PRESIDENT KING: Thank you, Councilman.

Mr. Clerk, are there any addresses to the council?

MR. CLERK: Yes, sir.

PRESIDENT KING: Please bring them forward.

MR. CLERK: Kim Baker.

PRESIDENT KING: I would like to remind those addressing the Council to please refrain from using profanity and from making derogatory statements.

You have the floor.

KIM BAKER: Good evening. I just want to say how wonderfully behaved you are, MiAngel. My eight-year-old would never sit that still. Happy birthday coming up.

I'm here on behalf of the Kentucky Center and I'm here tonight to tell you about an education program that we have called the Governor's School for the Arts. I think most of you all know the Kentucky Center, for the programming that we do at the center. I just left the center and the deaf festival is going on. And if you have ever seen people who are deaf, they applaud like this. And I have never heard such thunderous applause children clapping like this. And later on we have Lincoln and Marcellus. If you haven't got your tickets, I hope you can join us. And then we have everything going on with the orchestra.

We have a real commitment giving your community a lifelong education with the arts, and we do it through our education programs, which are great, and I know I have addressed the council about them.

Tonight I want to tell you quickly about the Governor's School. You will hear more about that from the executive director, but what I want to let you know is that right now the school is only serving about half the number of qualified students. I am a graduate of the program. I graduated in 1987. When you come to my office, right next to my college diploma is this. It is the diploma for the graduation

of the Governor's School. And I bring it with me because I am proud of it.

I am the first member to graduate from college, and because of the experience and exposure to the arts that the Governor's School gave me, I have chosen to stay in Kentucky, stay in Louisville, and pursue my lifelong relationship with the arts. And it really did happen because of that program. It is very life-changing, and any student who goes through that program will tell you the same thing. I thank you for your time today and I look forward to seeing you hopefully very soon at the Kentucky Center. Thank you.

PRESIDENT KING: Thank you.

MR. CLERK: Carrie Nath.

CARRIE NATH: Well, thank you so much for inviting us here this evening, for allowing us to come and speak with you all. As Kim said, I'm the executive director at Governor's School for the Arts.

What is GSA? You might be familiar with our summer program, a three-week college residency art conservatory for students all across the state where we look for those potential angels when they graduate high school. Congratulations and thank you for being here this evening.

We look for children that have potential that want to succeed in the arts that want to be prepared for college and their careers. We are multidisciplinary in our structure, so we

may have our drama students acting in films the new media are creating. The instrumental students create the soundtrack. So we want to hone those 21st century skills of collaboration, creative thinking, and creative problem solving.

We mandate community service and the students love it. They go all over right now to the community in Danville enforcing leadership through our leadership track as well as our artists and residents. We have guest artists that come in nationally and internationally. Field trips, we bring the entire student body here to the Kentucky Center and attended the Kentucky Shakespeare's inaugural under our alum Matt Wallace.

Any student can apply. We get 1,800 applications a year. Out of that, 400 students qualify annually. Right now we take 223 because it is a tuition-free program. It is \$3,800 per student, but right now we can afford to support 223 of those positions. And 24 percent of those students come from the Jefferson County area, from the Louisville Metro area. So our investment in students and families from Louisville Metro is \$204,000 annually to students and families that live in Louisville.

But is that all that we do? No, it is not. We have multicultural recruitment as part of our recruitment program and that is focused right now in the Jefferson and Fayette County area. Our greatest success story is Lanaya Roberts, going to Syracuse on a full scholarship. She left this fall and has just

started school. We do a college and career day. 85-plus colleges and universities represented.

The students go through the orientation in the morning. Out of those, they offer GSA-specific scholarships, including U of L. 98 percent of our alumni go to college, 98 receive scholarship, and the average scholarship is \$79,600. And we also have auditions here in the Louisville area. Five locations in the state. We do free workshops to help students prepare for that audition.

So we spur economic development by bringing in over a thousand families here every year for those events. We invest in these students, and we believe in reducing the brain drain. 14 percent of our overall alumni have moved back to Louisville. 712 people who have started business or are working in careers in the arts.

So you will see an application coming your way about asking for your support of the scholarships and supporting more of these students in attendance, and I cannot thank you enough for hearing about our program this evening. And we look forward to your being able to take a look at the application. And thank you so much for letting us be here this evening.

PRESIDENT KING: Thank you.

MR. CLERK: Ashley Baskette. Ashley Baskette.

COUNCILMAN YATES: I would like to take just a second and recognize my little angel at home, Ava Grace. I apologize. Ava and Grace, you are both watching on TV. Grace is my five-year-old daughter. You will see on the screen. It is her birthday today. And bless her heart, she likes to watch us on TV. So if everybody would say happy birthday to Grace. I love her dearly. She is the light of my life. Thank you, Mr. President.

PRESIDENT KING: Thank you. Very nice.

COUNCILMAN YATES: Happy birthday, Grace.

PRESIDENT KING: All right.

Councilwoman Parker, I believe you have a guest tonight.

COUNCILWOMAN PARKER: This is Principal Houston Barber. And I would like to give him special recognition this evening because we have been trying to get together to do this

for a little while. And so tonight's the night and I'm happy it has finally occurred.

I have always been an avid supporter for quality education for our kids and the economic impact engaged students and young adults will have on our communities. And one individual truly stands out as a model in success in that area, and that individual is Principal Houston Barber. While a principal of Fern Creek High School, he made significant progress towards moving Fern Creek out of turnaround status. Assistant principal at Louisville High School. Dr. Barber is a graduate from Marquette University. Past board member of the Kentucky Museum of Arts and Crafts. Last year Principal Barber was more than willing to take his methods of success to the Academy at Shawnee and raised student success just like he did at Fern Creek High.

He did it with a servant's heart. He accepted the position for no extra pay. His success is naming and claiming every child, intentional focus on sustainable systems through analyzing results, targeted interventions, individualized career pathways, and reaching benchmarks on the ACT, mentor support for social, academic and behavioral issues, after-school enrichment, innovation, nontraditional thoughts of engaging students, and retention of quality staff.

I would like to read and present the proclamation for Principal Barber for service to our students and families and

our city, and to his commitment to education and serving our community.

Louisville Metro Council. To all whom these letters shall come, Greetings: Know ye, that the Louisville Metro Council in the spirit of deep gratitude and appreciation for your service to the Louisville community hereby honors and awards Dr. Houston Barber the Certificate of Distinguished Service in recognition of outstanding service to our community as principal of the Academy at Shawnee.

Whereas the future of our country lies in our children. And whereas, Principal, our mentors are guides for teachers and leads by having a positive attitude and enthusiasm for learning. And whereas he served as the principal of Fern Creek Traditional High School and made significant process toward moving Fern Creek out of turnaround status.

Whereas the dedication and commitment of Dr. Houston Barber to name and claim every student has proven to increase achievement, and whereas we hereby offer this honor with all the rights, privileges and responsibilities thereunto appertaining. We cause these letters to be made and the seal of the Louisville Metro Government to be hereunto affixed.

PRESIDENT KING: Thank you, Councilwoman.

COUNCILWOMAN HAMILTON: Mr. President.

PRESIDENT KING: I'm sorry. Councilwoman Hamilton.

COUNCILWOMAN HAMILTON: Yes. I couldn't let this moment go past.

Thank you, Councilwoman Parker, for recognizing Principal Barber. You know, we have had the students here from the Academy at Shawnee, and I think I mentioned at the time that they have an experiment that is currently in space. And so we are hoping that Dr. Barber and the students will come back in October when I believe it comes back.

The Science and Engineering Club went to a conference in Washington where they presented their experiment. So we have a lot of things to be thankful for for education in our community and at the Academy at Shawnee. So come back in October. Thank you.

PRESIDENT KING: Thank you, Councilwoman.

Councilman Stuckel, I believe you have a guest.

COUNCILMAN STUCKEL: Colleagues, I stand before you tonight to honor a true public servant, Bill Schreck. Bill joined the Metro Government -- well, it wasn't the Metro Government back then. I guess it was the county in 1974. And I first met him in 1978 when I entered the homebuilding industry.

And so over the past 36 years Bill and I have worked together, and actually I think he is one of the principal people that forged an alliance between the builders and developers and the inspection people so that we weren't looked at as adversaries. We were looked at as partners.

When I read the proclamation here, you will see what he has done in the way of serving the community. Bill actually retired in 2009 but was called back in 2012. And now he is retiring again, I think, effective next -- I think he just wants to get these plaques is the deal.

So here is the proclamation. To all whom these letters shall come, Greetings: Know ye, that the Louisville Metro Council hereby recognizes and honors Bill Schreck. Whereas Bill Schreck began his career in government in 1974 as a housing inspector and a title extractor.

And whereas Bill Schreck has since served in the Department of Building and Housing, IPL, codes and regulations, Jefferson County PDA, Metro Public Works and Assets, vacant and abandoned property initiative, and develop Louisville. And whereas Bill Schreck has taken on a leadership role in many of those agencies.

And whereas Bill Schreck has also served on in local boards, including Project Warren, Habitat for Humanity, and the Center for Neighborhoods.

Whereas Bill Schreck is retiring on September 5th. Now we therefore honor Bill Schreck for his commitment to the community and service to others and hereby name him an outstanding citizen of Louisville. And it was signed this day by President King and myself.

Bill, congratulations.

BIL SCHRECK: I would just like to say that it has really been an honor to be a part of this organization for all these years. I have never really considered it a job. I have always liked to come to work. It has been a great time. I really enjoyed it. Thank you.

PRESIDENT KING: Thank you, Bill.

Bill, I wasn't sure who the guest was who we were bringing down tonight, but I think I speak for all of us -- and Glen did it very well -- but thank you for your service. Thank you.

Councilwoman Woolridge, do you have a proclamation to present?

COUNCILWOMAN WOOLRIDGE: Yes, I do.

PRESIDENT KING: If you can quit laughing over there.

COUNCILWOMAN WOOLRIDGE: Thank you, Mr. President. It is all my colleagues' fault. I won't repeat what they said.

Mr. President, I want to remind everyone why this day is so important and why we celebrate. Women's Equality Day is an annual event that our country celebrates every year on August the 26th. The date of August 26th was selected to commemorate the 1920 passage of the 19th Amendment to the Constitution granting women the right to vote.

This amendment was the result of a very long -- sometimes not very peaceful -- civil rights movement led by women that had its formal beginnings in 1848 at the first World's Women's Rights Convention in Seneca Falls, New York. The observance of Women's Equality day not only commemorates the passage of the 19th Amendment, but also the opportunity to call attention to women's continued efforts toward full equality.

In fact, 52 percent of Louisville's residents are girls and women. Today I'm asking you to commemorate and celebrate all the women in our lives in appreciation of all that they have done and continue to do on this Women's Equality Day. We recognize that women are strong, vital, talented individuals who should have every opportunity to realize what they are truly capable of, that there are no limits on what they can accomplish and that they can realize your goals and dreams.

Mr. President, at this time I would like to read the proclamation. And it reads:

A proclamation by Louisville Jefferson County Metro Council. To all whom these letters shall come, Greetings: Know ye, that the Louisville Metro Council Hereby proclaims August 28, 2014, as Women's Equality Day.

Whereas, women in the United States were given the right to vote on August 26, 1920, when the 19th Amendment to the United States Constitution was certified. The amendment was first introduced many years earlier in 1878, and whereas, every

president has published a proclamation for Women's Equality Day since 1971 when legislation was first introduced in Congress by Bella Abzug.

And whereas, the observance of Women's Equality Day not only commemorates the passage of the 19th Amendment, but also calls attention to women's continuing efforts toward full equality, and whereas, we have combated and had successes on many fronts, we know that disparities still exist in many arenas. And whereas, we must continue to promote full rights and privileges that are given to male citizens of the United States for all women.

Now we therefore hereby proclaim August 28, 2014 Women's Equality Day in the Louisville Jefferson Metro area and urge all citizens to celebrate this day with appropriate programs and activities. Done, at the Louisville/Jefferson Metro Council, this the 28th day of August 2014. Mary C. Woolridge, Councilwoman Metro Council District 3, Jim King, President of Louisville Metro Council.

And if you men would like to stand and give us an applause, we would welcome that applause for all we do.

PRESIDENT KING: Consent calendar has been properly moved and seconded. It requires a roll call vote.

Mr. Clerk, please open the voting. Without objection, the voting is closing.

Record Councilman Downard as a yes, please.

The voting is closed.

MR. CLERK: There are 25 yes votes and one not voting.

PRESIDENT KING: The Consent Calendar passes.

Mr. Clerk, a reading of Item 42, please, under Old Business.

MR. PRESIDENT KING: The committee-amended ordinance is before us.

Councilman Blackwell, this came from your committee.

COUNCILMAN BLACKWELL: Yes. It came with unanimous support, but it came from committee adding Councilwoman Hamilton to the total of \$9,822. We appreciate your support.

PRESIDENT KING: Any further discussion?

Councilwoman Hamilton.

COUNCILWOMAN HAMILTON: Yes. I am happy to support this. This is a mentorship between Iroquois Elementary and the third, fourth and fifth graders. It is skill-building, academic, and critical thinking. And I think the students in the past have benefitted, so I'm happy to support it.

This too was amended in committee to add additional sponsors. And so it is on Old Business tonight for that. And we will certainly allow others to join on that tonight, if they would like.

PRESIDENT KING: Thank you.

Councilman Stuckel.

COUNCILMAN STUCKEL: \$500 from District 17.

PRESIDENT KING: And, Councilman Blackwell, what was the ask on this?

COUNCILMAN BLACKWELL: 52,000. We have plenty of time.

PRESIDENT KING: Thank you.

Councilman Benson.

COUNCILMAN BENSON: Thank you, Mr. President. \$500 from District 20.

PRESIDENT KING: And Councilman James.

COUNCILMAN JAMES: Thank you, Mr. President. \$500 from District 6.

PRESIDENT KING: Councilman Johnson.

COUNCILMAN JOHNSON: \$500 from District 21.

PRESIDENT KING: Thank you.

Councilwoman Shanklin.

COUNCILWOMAN SHANKLIN: Thank you, Mr. President.

\$500 from District 2.

PRESIDENT KING: And Councilman Yates.

COUNCILMAN YATES: Thank you, Mr. President. I was thinking that we were already on, but it doesn't look like it. I would like to add a thousand dollars from District 25. Harbor House does tremendous work in my area.

PRESIDENT KING: Thank you.

Is anyone else seeking recognition?

Mr. Clerk, that adds up to 3,500; is that right?

MR. CLERK: It is, sir.

PRESIDENT KING: District 10 will add 500 to make an even 4,000.

May I have a motion to amend, please?

PRESIDENT KING: Thank you. All in favor say aye.
Opposed? The amendment passes.

Any further discussion? Hearing none, this ordinance requires a roll call vote.

Mr. Clerk, please open the voting. Without objection, the voting is closing. The voting is closed.

MR. CLERK: 25 yes votes and one not voting.

PRESIDENT KING: Thank you. The ordinance as amended on the floor passes.

COUNCILMAN BLACKWELL: Thank you, colleagues.

PRESIDENT KING: Mr. Clerk, a reading of Item 44, please.

PRESIDENT KING: Thank you. The committee-amended ordinance is now before us.

Councilman Blackwell.

COUNCILMAN BLACKWELL: Thank you, Mr. President. A familiar reason for this to be on Old Business. It was amended in committee to add additional sponsors, and I think we may have a few additional sponsors tonight as well.

PRESIDENT KING: Thank you, Councilman.

Councilman Downard.

COUNCILMAN DOWNARD: Thank you, Mr. President. I'm committed to this already and will remain so. Is there -- legislatively, this was for several things. Part of which was for construction activity, part of which was for the walk, and part of which was for operating expenses. Was I wrong? Does anybody know? I think there were some people who would jump right on if they could do capital. And I thought in the Committee of the Whole it was asked and there was capital. I'm already on, but there would be some more, I think. Do we know?

PRESIDENT KING: I don't know that we can get an answer to that question. I will go on to Councilman Stuckel and someone can possibly come back.

Councilman Stuckel.

COUNCILMAN STUCKEL: \$1,000 from District 16.

PRESIDENT KING: Councilman Miller.

COUNCILMAN MILLER: \$500 from District 19.

PRESIDENT KING: Does anyone know what the ask was on this? Well, it was in excess of the 34?

>> It was 42,250, if I'm looking at it correctly, Mr. President.

PRESIDENT KING: Thank you.

Councilwoman Shanklin.

COUNCILWOMAN SHANKLIN: Yes. I thought I gave on this, Mr. Blackwell.

COUNCILMAN BLACKWELL: You had agreed to, but it wasn't on the sheet yet, so we will have to add yours to the amendment.

COUNCILWOMAN SHANKLIN: I signed off on it last Thursday because Jim tried to get me to put 2,000 and I put a thousand.

PRESIDENT KING: My note that I have here says we needed to add you as an additional thousand dollars for District 2.

COUNCILWOMAN SHANKLIN: Correct.

PRESIDENT KING: You are correct.

COUNCILWOMAN SHANKLIN: Okay.

PRESIDENT KING: Thank you, Councilwoman Shanklin.
Councilman Kramer.

COUNCILMAN KRAMER: Thank you, Mr. President.

As Councilman Downard pointed out, I had been informed that this would be for capital. And I would be willing to support improvements that need to be made here in Louisville, and so was happy to do that. But as I look through the paperwork, I can't find anything where they are talking about doing anything capital with the proceeds. And my fear at this point is if I commit -- and I'm asking the county attorney -- if I commit, does the Lymphoma Society have the flexibility to use

funds for capital if it is not listed in their documentation? I suspect they can't, but I don't know that for sure.

PRESIDENT KING: Does the county attorney want to address that question?

SARAH MARTIN: Yes, Mr. President.

PRESIDENT KING: Sarah, would you like to address that.

SARAH MARTIN: Sarah Martin with the county attorney's office. The recipient has to follow the guidelines as set forth in the NDF paperwork. So it depends on how broadly the language is written whether or not they would have the flexibility. I don't have it in front of me, so I can't speak to the specific question. But if it was written broadly enough that they could expand it for capital purposes, that would be permissible.

>> Thank you.

PRESIDENT KING: I don't know that that was helpful. It was as helpful as you can be, but you're right. I don't know if it got you where you wanted to be.

Councilman Blackwell.

COUNCILMAN BLACKWELL: I think maybe -- I'm not an expert here, but the issue is the way they wrote what it is going to be used for was to use it for the expenses area of the fundraiser, and then I don't think they spell out -- or at least I don't think I see anywhere where they spell out what the funds they collect will be used for. That might be where we have a

discrepancy. Doesn't help you much. It just tells where we have the discrepancy.

PRESIDENT KING: Councilman Downard.

COUNCILMAN DOWNARD: Thank you, Mr. President.

The chair of the Budget Committee and I discussed this. And it talks about the contributions being for the fundraiser. And then the repeats for the fundraiser being used for operating cost. There is a place to put capital and they could have checked it.

PRESIDENT KING: All right.

Councilman Yates.

>> Great organization.

COUNCILMAN YATES: Mr. President, yes, I just wanted to bring the attention. I remember during the presentations and looking through this, the reason I was so supportive of this is it looked like it was four-time return on the money, so we looked for every thousand dollars to put up to raise the money they were essentially raising \$4,000. And for such a terrible disease, they have made progress in treatment. And personally my mother has leukemia. So I'm very personally interested in it and maybe a little bit bias.

I know cancer in one way or another affects just about everybody. So if we can move this forward to find better cure and is better quality of life for people, especially when we get that return on the money. We are looking to how government can

help the private community raise and earn. We talked about a 400 percent increase, that is why I'm very supportive and I would encourage everyone else to be.

PRESIDENT KING: Thank you.

Is there any further discussion?

Councilwoman Parker.

COUNCILWOMAN PARKER: Yes. District 18 would like to add \$500.

PRESIDENT KING: Thank you.

And District 10 was on for a thousand. I'm going to increase that to 2,000. So I have a total of \$4,000 here in the amendment.

Is anyone else seeking recognition? May I have a motion to amend?

>> So moved.

>> Second.

PRESIDENT KING: I'm sorry.

Councilwoman Shanklin.

COUNCILWOMAN SHANKLIN: President King, if you increased it a thousand, I will increase mine another thousand.

PRESIDENT KING: Thank you, Councilwoman.

So I'm going to incorporate that in the amendment, if you don't mind. I have a motion and a second for a \$5,000 increase in the ordinance.

Is there any further discussion on this? Hearing none, all those in favor say aye. Opposed?

We now have the ordinance in front of us. It requires a roll call vote.

Mr. Clerk, please open the voting. Without objection, the voting is closing. The voting is closed.

MR. CLERK: 24 yes votes, one abstention, and one not voting. The one abstention is Council Member Ackerson.

PRESIDENT KING: Thank you. The ordinance as amended passes.

COUNCILWOMAN HAMILTON: I agree with that.

PRESIDENT KING: Thank you.

COUNCILWOMAN HAMILTON: Thank you, Mr. President.

There are quite a few activities upcoming in District 5 and West Louisville over the next two weeks until we meet.

So August 31st, Sunday, the Dirt Bowl finals. It has been postponed because of the rain. And hopefully it won't get postponed this Sunday, but there are a lot of games that will start this afternoon. The Sunday, August 31st, Shawnee Park.

September 2nd will be Dress for Success Career Readiness Training. It will be taking place each Tuesday and Thursday at Northwest Neighborhood Place from September 9th through -- September 2nd through October the 30th. If you are interested, go by the Northwest Neighborhood Place and find out more about that.

COUNCILMAN OWEN: Thank you, Mr. President. A few announcements involving the eighth district and environs.

The first is my monthly meeting with constituents where I sit in a coffee shop on Baxter/Bardstown Road. Always the last Saturday in the month, except I don't hold a Talk with Tom in December. But on August the 30th I will be at Dunkin

Donuts at Mid City Mall from 9:00 to 11:00. And I will be sitting there. And anybody that wants to come by and chat with me about anything that is interesting them, I will be glad to be there.

Zombie Walk, that will be disruptive of traffic on Bardstown Road. It is tomorrow night, the 29th day of August. The walk itself will start at Mid-City Mall and go not a long distance to the 1000 block of Bardstown Road. The problem is the walk itself will start at 8:29 p.m. on August the 29th, 8/29/2014.
