Good morning, Heather,

Thank you for your inquiry and for assisting in this matter.

The Friends of the Farnsley Kaufman House will be hosting their annual fundraising dinner and auction on Saturday, June 11, 2022, at Riverside, the Farnsley Moremen

Landing. Typically, the organization hosts the annual fundraiser every fall; this will be our first in-person event since October, 2019. The group did not host their largest fundraising event in 2020 (due to COVID-19) and we postponed the event we had originally scheduled for September 11, 2021. The June dinner and program is preceded with a cocktail hour and silent auction--and the event includes a live auction of specific items. We have selected Kingsley Meats & Catering as our caterer, and we expect 90-100 guests; to date, we have 85 guests. Funds generated from the event support the organization's very modest operating budget, program development, and repair and restoration of the 210 year old historic Farnsley Kaufman House and outbuildings.

This year we have suffered considerable vandalism and destruction at the House, outbuildings and grounds. We faced the challenge of removing a homeless camp that established residence in a chicken coop. It took several months to remove the camp. They destroyed the property, including burning wood stripped from the two century year old outbuildings. We continue to work with LMPD, JCPS and PRP Fire to address the issue. In the coming months, we will begin repair on the foundation and have been securing bids for various construction/preservation projects. The cost of the foundation repair is \$12,000.

The pricing for the dinner/auction is as follows: we are selling tables of 8 for \$500; individual tickets are \$65.00.
