Council Member Piagentini spoke about the allegations of sexual harassment against several female employees at TARC. He stated that it is the responsibility of the Government Oversight and Accountability Committee to execute oversight of functions of government when things are broken. He reviewed some of the Whereas Clauses in the Resolution which outline the reasons for the investigation. He also stated that an amendment was needed so that they could give the victims a voice and at the same time protect their innocence.

A motion was made by Council Member Piagentini, seconded by Council Member Engel, that this Resolution be amended as follows:

In regards the scope of the investigation, amend Section I, bullet point 6, second sentence, between "...all persons" and "and/or bodies..." to add "while protecting and preserving victims rights, privacy, and anonymity (unless otherwise required by statute or law)...."

Council Member Piagentini also mentioned a technical amendment regarding the spelling of 'investigation' in the title. He concluded by asking for additional co-sponsors and support of this amended Resolution.

She stated that she would like to have left out the sexual harassment and specific allegations.

She concluded by requesting to be a co-sponsor.

Council Member Dorsey stated that she would echo the message of Council Member Sexton Smith in regards to the Council staying in their lane. She also stated that the recommendations coming from this investigation need to be applied across all government agencies and quasi-agencies.

Council Member Purvis stated that she would be a co-sponsor and that the Council needed to send a message that they are trying to protect the victims and other potential victims.

Council Member Hollander spoke about his concerns regarding multiple investigations. He stated that he was pleased to hear that there would be a meeting regarding these investigations, as coordination of the on-going investigations could expedite the resolution of the issue and lessen the burden on the victims.

Council Member Kramer spoke about the process not being short cut as this Resolution initiates the appropriate process to better understand all of the implications of decisions made at TARC and possibly beyond.
