Discussion of Collective Bargaining Agreement for Louisville Metro Police Department's Lieutenants and Captains - Chief Erika Shields, Louisville Metro Police Department

The following was discussed:

- The need for policies and supervision for LMPD to be successful
- Contract helps keep people in Louisville and puts rights and expectations in place
- Commitment to hold LMPD accountable
- Early Intervention System, and whether any terms in the contract regarding record retention will inhibit the ability to have a robust system
- Having leadership that will hold people accountable when they make mistakes
- Retention and job satisfaction being related to frontline leadership
- Issues with record retention language -- referenced the contract, Section 2 - Receipt of Complaints, Subsections C and D, regarding how informal complaints can be handled and only having to be retained for two years
- Having the ability to terminate rather than use suspension with pay if necessary
- Chief not being a pseudo-political appointee and making tough choices without consideration of who the next mayor may be
- New Deputy Police Chief being hired
