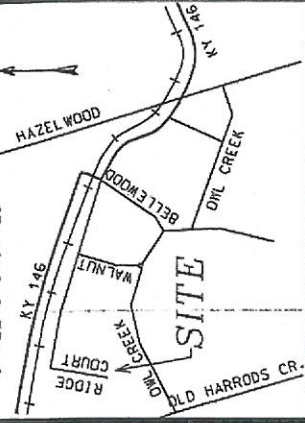

LOCATION MAP (N.T.S.)

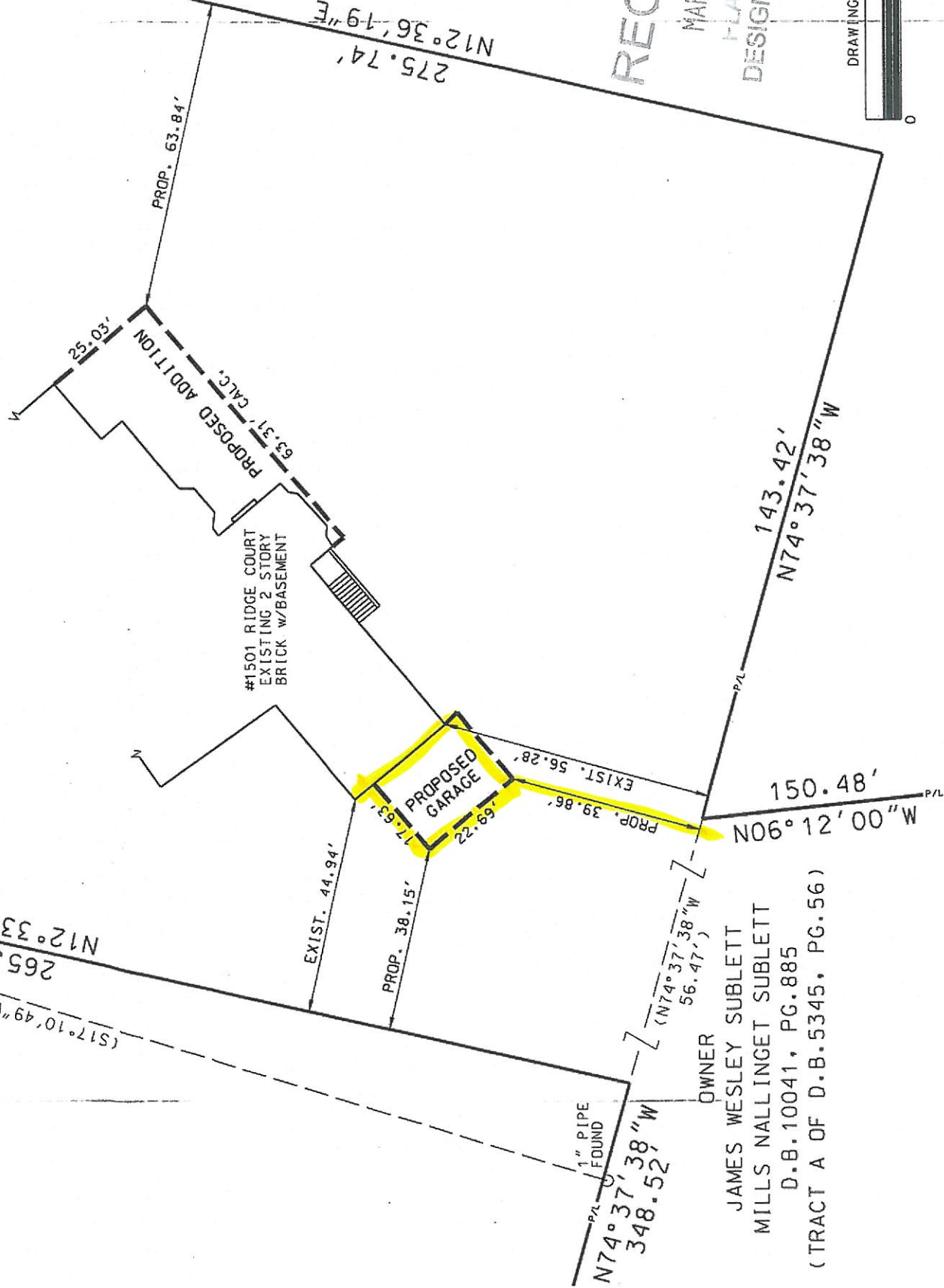

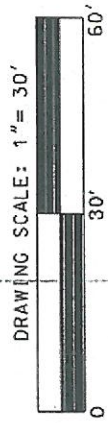
