Mr. Caleb,

I have reached out to other providers for competitive quotes in replacing the handrail on these structures and will let you know if we receive a quote for significantly less than the provided estimate. The current \$10k estimate is expected to be a top limit for the removal and secure, quality replacement of the pedestrian bridge handrails. I've attached an image to give an idea for what we are expecting for the new handrails.

The structure to the south of Broadmoor Blvd is the priority for replacement due to its current state. If the councilmember would be interested in having the handrail replaced along both structures, so as to have them aesthetically and structurally match as well as being in a similarly improved state, this can be accomplished in the same project.

Good afternoon Mr. Allen,

I just spoke with Councilwoman Shanklin. She said that it seems like \$10,000 is an awful high price for a set of handrails...she indicated that she would consider funding one set of handrails (where they are currently missing), but if there is any way to get the price down a bit, it sure would be helpful.

Our office has already allocated much of our money into other projects in the district, including around \$300k in tennis courts/pickleball courts in Petersburg Park, and numerous speed hump/sidewalk projects around the neighborhood. Because of this, our money is tighter than it may seem. With this in mind, Councilwoman Shanklin will not be able to fund both of the handrail projects at this time.

Just let us know if there might be any wiggle-room with the \$10,000 figure, after which I will let you know what Dr. Shanklin's ultimate decision is.

Caleb,

At 4109 SAINT CHARLES LN there is a pedestrian bridge that no longer has hand railing. It has only had a chain link fence in place of hand railing but now the top rail of the fence is missing and the chain link fencing is only attached at the bridge ends. In its current state it is posing a safety issue. I'm going to have High Safety Services put up sidewalk closed signs.

The replacement of the change link fence with handrail is estimated to cost \$10,000. Right across Broadmoor Blvd there is another pedestrian bridge. This one still has the chain link fence with top rail intact, but it is old and we could repair replace both with ADA hand rails for \$20,000 at the same time. Could Councilwoman Shanklin fund one or both of these hand rail projects?

Public Works can replace the damaged chain link fence with ADA railing, with the guardrail budget however if Councilwoman Shanklin has the funds the guardrail budget would be more appropriately spent on guardrail replacements. Please let me know what the Councilwoman says.
