The following was discussed:

- University of Louisville willing to collaborate with Metro in this endeavor
- Question regarding the requirement to see systemic change/results and what other communities have done in regards to education or promotion of this work in the broader community
- Focus on what the community wants to focus on, such as youth violence
- Two parts that need to happen - adaptation and parallel ownership
- Using parts of various models to determine what works and does not work
- Multiple levels are targeted at the same time, with changes in policies, practices, resources, understanding, ability to access resources, and motivation to engage in certain situations
- Question regarding how to engage the community in a way that reflects readiness and communicates that changes will be sustainable, will take time, and will not produce an immediate response
- Study in Louisville regarding Louisville's readiness for change, which resulted in responses about Louisville being great at planning and terrible at executing
- Staying committed and engaged over the long term to bring about change
- Question regarding strategies to keep people focused
- Question regarding how to balance long-term solutions with a finite budget
- There must be a balance between funding for short-term and long-term efforts
- Committing to a plan for a few years before deciding on whether it is moving the community in the right direction - and keep the process transparent
- Having accountability from the community
- Need to work with groups in the community rather than out-of-state groups since they are more vested in the community
- Question about how to keep the community from losing hope when change is occurring at a slower pace than which they expected and instant changes are not seen
- Question about the impacts on racism on the African American psyche and how it effects the way information is processed -- dealing with behavioral

change in regards to mindset  
- Managing expectations - communicate how things work together for the whole picture
