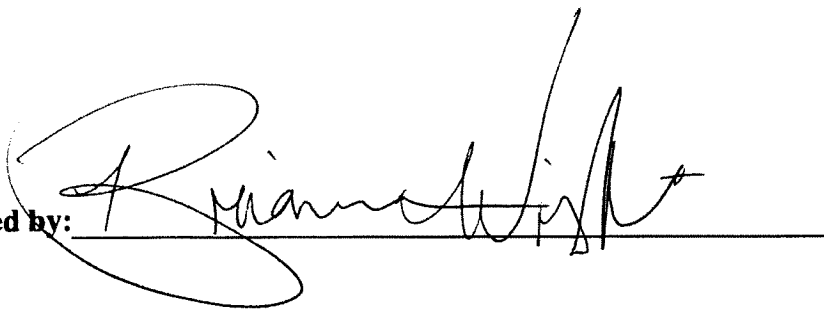

Hi Brianna,

As per our phone call, a brief update

Outside the D4 cases we already work on with our FY23 CDBG funds, we identified 13 D4 cases that could be considered "emergency."

It is always difficult to estimate the costs for each home repair. For our Home Repair Program, we typically estimate that costs could be as high as \$24,999- but that's because we would do more to the house than just an "emergency" repair.

In many cases, the actual costs are lower- sometimes 17k, sometimes 21k.

For an average emergency repair where one or two key items get repaired or fixed, I think \$5,000 could be used as a benchmark. It just really depends on the case.

We only really know when we go out there to inspect.
