Beginning at a point in the north right-of-way line of said Bardstown Road, approximately 219.9 feet southeast of the east right-of-way line of said Watterson Trail, as shown on the plat of J. R. Crask's Subdivision of record in Plat Book 8, Page 136 in the office of the Clerk of Jefferson County, Kentucky;

Thence leaving said right-of-way line, N 01°54'30" E, a distance of 629.87 feet;

Thence S 88°22'30" E, a distance of 601.70 feet;

Thence S 02°51'00" W, a distance of 343.63 feet;

Thence S 88°28'06" E, a distance of 365.68 feet;

Thence S 02°17'56" E, a distance of 595.50 feet;

Thence S 25°18'36" W, a distance of 282.10 feet to the north right-of-way line of said Bardstown Road;

Thence with said right-of-way line N 57°06'09" W, a distance of 302.43 feet;

Thence N 55°40'00" W, a distance of 422.18 feet;


Thence N 01°55'22" E, a distance of 34.52 feet:
