My name is W. Sue bishop, I reside at 3301 Dupin Dr in Louisville Kentucky 40219. I moved here from Phoenix Arizona in 2005 after getting married to my amazing southern husband. I made this drastic move across the country after 36 years of residency in Arizona because I wanted a change in my environment. My husband and I have lived in our home for 14 years. Where it is located across the street from Evangel Christian School. The only traffic we have dealt with prior to four years ago was school traffic as well as church service letting out on Sunday. These seem to be normal traffic patterns you have to deal with in your daily life. Especially while living in a neighborhood located close to places where people like to gather, such as a school or Church. Of course that didn't concern us until we seen a little bit more of a hurry to get to school on time or to get to service on time, we noticed more erratic driving. However located directly in the front of our property is a guardrail to protect our family, property, possessions, and livelihood. This particular guardrail has been impacted over the past eight years 4 times. once by an 18 year old brother of a student, once by a drunk driver, once by somebody who was not all there, and once by somebody trying to escape authorities.... Needless to say the emergency corridor that travels through minors from Preston to Outer loop is heavily abused already. In about 2015 I noticed extreme amounts of heavy traffic heading quickly through my neighborhood heading down to Evangel Church located on 5400 Minors Lane. After a little bit of investigation I figured out the Pastor Bob Rogers was allowing Ford Plant's overflow to store their cars in his parking lot until they shipped out. I was very disturbed by this for many reasons... first of all, I've always been taught when you're a churchgoer you leave room for newcomers? The parking lot is packed full of new vehicles leaving a very small section of parking lot available for the congregation. My second issue with this is the amount of lights it shines on my house every single time they drive down the stretch of Minors Lane. I have attached some pictures to give you a better idea of how these light shine directly on the front of

my home, as well as provided a thumb drive with videotape showing exactly how intense the traffic is coming down Minors Lane already. So as I watch this transform over a few days as well as weeks, I decided to take matters into my own hands and go down to the church parking lot to speak to whoever was on site securing these vehicles. I was aggressively approached as well as my vehicle almost impacted by Ford's obnoxious outsourced driver company. Needless to say I didn't get anywhere and at this moment I was extremely upset with their conduct so the following day I made my way into the HR department of Ford plant and spoke to Steve Campbell and his constituents. I expressed my concerns about the erratic drivers and how dangerous they are driving. We brought my home up on an aerial overview map, we discussed redirecting the traffic behind the lake down clay to avoid the heavy flow of traffic coming towards my house. I am raising three grandchildren, one who is in the spectrum of Autism and suffers from PTSD on a very severe level given his history. These lights, squealing tires, diesel engines, light bars, have definitely impacted my home, my peace, my dwelling, my ability to sit on a porch, my ability to sit on my couch, my ability to feel safe outside, and let my children play in the front yard.. However this problem continued on for a couple of years I made my way into the HR department of the Ford Plant a total of three times, I emailed Ford located in Flint Michigan and was contacted by the training coordinator expressing my concerns about how they were handling themselves in our residential neighborhood, John flink emailed me back expressing his concerns as well. I have also attached those letters in regards to rectifying this problem and taking care of it. Nevertheless this problem was never taken care of and continued on all the way up to the current date. Today! I have also attached a picture of the current status of the parking lot full of Ford's s as I type this letter. I have had so many issues with Ford's driving company being erratic in my neighborhood for 4 years solid. I have called LMPD numerous times, but I know this isn't considered a urgent situation but when they go around my grandson special needs bus at 6:45 am, it becomes a VERY URGENT situation for me as a grandmother! I have been so frustrated over the past four years with the amount of traffic that Ford and evangel think they are permitted to bring in our neighborhood but I was told it's commercial and they're allowed to have their cars over there even though it has reached a high level of a nuisance....? I didn't think they were allowed to drive in our neighborhood, hundreds at a time, for 5 days straight with 20 minute breaks in between as the fleet loads up at the plant and comes back over and over and over 24 hours- 48 hours- 72 hours straight... they get off the 65, fly up Outerloop, shoot down Minors Lane use the same access this company is trying to use for their new development. They take my corner on minors and dupin smelling like they have burnt every

seal in a brand new vehicle. I have been yelled at, screamed derogatory words at me, flipped off because I am not happy with drivers being paid \$33? For every car they bring... What a set up for disaster? Inconsiderate business owners have allowed this sort of behavior to happen over the last four years. They have been "allowed to get away" with disrupting our neighborhood for way too long. Our safety has been threatened since 2015 in regards to the location of my house and how much traffic flies down Minors. The level of a nuisance this extra flow of traffic has caused to my family and my grandson is unbelievable... I am firmly opposed to any sort of rezoning in my neighborhood. I feel the traffic is already at a very dangerous level. My corner is the location of 7 bus stops and the my thumb of my neighborhood holds about 20+ bus stops before 9:40am I am also aware of the increase in accidents that have happened on Minyard, Minors, Outerloop intersection. There was a fatal accident the first week of February on this exact corner killing a man on a motorcycle.... so given the amount of traffic and the recklessness that this is going to bring to our neighborhood I firmly oppose this.

I also want to address the impact is going to have on my property as it stands right now. Back in 2014 Bob Rogers did a brief showing on backyard oil drillers. I'm sure some of you are aware of this because he did not have the proper documentation to authorize him to do this, so after ignoring the city's request to plug the holes, he was fine \$4,000 for illegally drilling in that property. That is located right next to the Shell lake and since 2014 the saturation of our ground has increased tremendously. I understand they claim to put in some sort of water way to address this issue. That is also what was promised to the residence located behind Cheddar's and currently their yards are flooded... The greatest predictor of the future is the past and it is obvious the land in question is a wetland... I remember going over to that lake and fishing for the first time here in Kentucky. It was the lake I caught my first big mouth bass in. I had never seen a big mouth bass in person so I was extremely excited about this event. My children and grandchildren have walked around that lake, fished, and played over there for years in the past and now the current status of it is a complete dump full of garbage and has literally been trashed so nobody can enjoy any of it...the water that is resting over there and has been for quite a few years is extremely dangerous and loaded with toxins. Anybody that knows about drilling into the ground where there is a shell lake close by knows you risk releasing methane gas and toxins into the ground/air especially when you drill into the ground without authorized permits created for addressing safety. I also remember walking around there years ago and bearing witness to native American burial grounds. This was an exciting thing for me to witness being since I was from Arizona and I grew up with native American Friends my entire childhood. I have

I also have a big concern with sharing our neighborhood roads with 18 wheelers while our buses are in route. I find this to be a very dangerous move even though it brings a lot of cash flow it is going to bring a lot of safety concerns for us as parents, grandparents, and residents of this neighborhood. I do not want to worry about competing with the roadway when it comes to my grandchildren traveling in a bus safely. I don't want them smelling fumes from idling 18 wheelers that are waiting to get into the yard so they can make their money. I refuse to sit back and let a corporation on an industrial level move in when I am an asthmatic of 42 years...I just find that this is an extremely dangerous situation let alone and extreme a nuisance to us. We all have valid concerns because some of us have lived in these parts longer than others so we have history and roots. I am just not okay with laying down and letting you move into my neighborhood under the radar and then robbed me of my only investment which is my home or even worse hurt one of my children, animals, or neighbors because you're trying to make a buck....I understand everybody's position especially being from Phoenix Arizona but at the same time I am opposed to this and I wanted to be documented that my concerns are validated. I have attached some paperwork as well as pictures along with a thumb drive to kind of Express how outrageous the traffic is already.

I think you for your time I hope that to take our concerns into consideration and our families future hangs in the balance.
