As an aside, if anyone on Metro Council is interested in the numbers of burials per year from the indigent program, I am happy to give those to you; just let me know. I can break them down from the database.

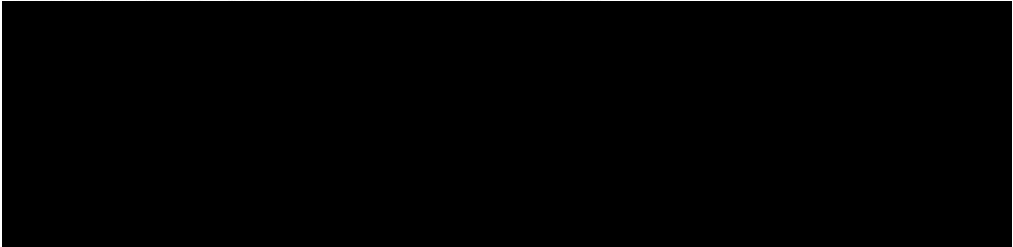

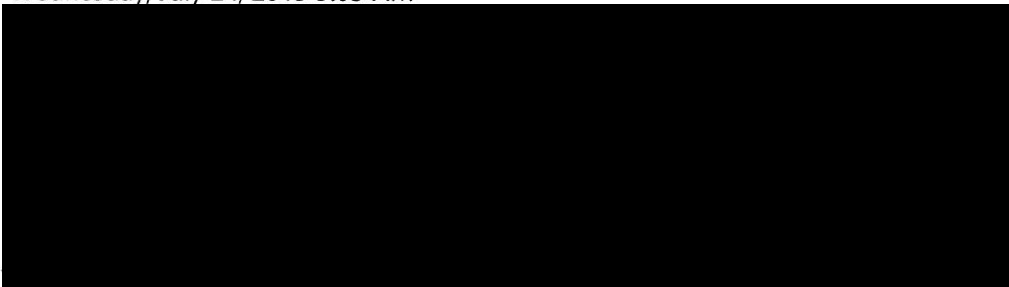

Sorry for the late notice, but this literally came to light this morning!

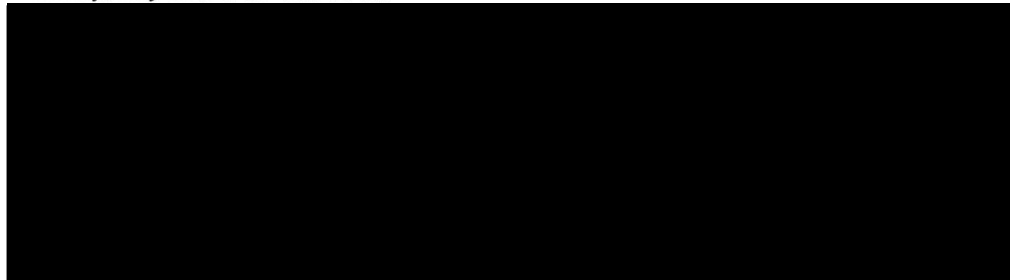

Special thanks to all of you for your ongoing service as volunteers for this very worthy program.

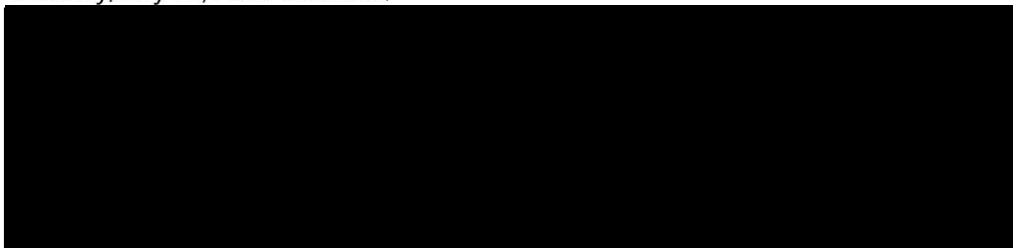
