**Discussion of O-589-20: AN EMERGENCY ORDINANCE AMENDING ORDINANCE NO. 072, SERIES 2020 RELATING TO THE FISCAL YEAR 2020-21 CAPITAL BUDGET, FOR THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT BY INCREASING THE VEHICLE/EQUIPMENT FOR GENERAL SERVICES CAPITAL PROJECT FROM \$2,000,000 TO \$3,664,900 FOR GENERAL FLEET PURCHASES.**

The following was discussed:

- \$26 million to be moved forward from Fiscal Year 2020 to Fiscal Year 2021 for general government needs and COVID-19 response
- \$10 million for utility assistance, which would leave \$16 million to go into Fiscal Year 2021 for appropriations
- \$3.5 million for appropriations for departmental needs
- \$1,664,900 for Public Works, Codes and Regulations and Fleet and Assets to purchase new equipment, and hire new employees
- CARES Act expenditures close out on December 30, 2020
- CARES Act is for COVID-19 pandemic relief
- Science Center requesting a one-time expense amount of \$750,000 to get through the pandemic
- Science Center was closed until July and is now running at 20% of attendance due to COVID-19
- Science Center board is actively looking for other sources of funding
- Question whether taxes will be raised

- Question and concerns about increasing payroll for Public Works by hiring for new positions
- \$600,000 to the Office of Resilience and Community Services to establish a Mobile Response Team to address homelessness
- The objective of the Mobile Response Team is to move the unsheltered to shelter
- Homelessness in Jefferson County has reach over 8,500
- Question whether Metro Government should be focusing more on violence in the city
- Question whether there is additional funds available under expenditures
- Budget was increased with Fraternal Order of Police contract
- \$350,000 for Office of Safe and Healthy Neighborhoods
- Question whether Metro Government could use the capital money instead of borrowing
- Metro Government is maintaining by paying off \$45 million and borrowing \$45 million
- Question whether these programs appear to be reoccurring expenses
- Question with the weather turning, if Metro Government has enough in the budget for outreach for human services for people to be sheltered and feed during the winter months
- Question whether Metro Government should pause and keep unassigned funds until the end of January 2021
- Question whether each item on the Ordinance can be voted on individually
- \$580,000 to Codes and Regulations will allow them to keep the inmate crews for cutting grass and the removal of graffiti
- Clean up vacant property to keep up property values
- Public Works will need to hire contractors to do the ramps
- There is an Ordinance for companies that are hauling loads on the back of trucks to secure them
- Sweep street cleaning was cut from 4 times a year
- Brightside cancelled all cleaning in Jefferson County for the year
- There ia s cleanliness index that was created by Brightside
- Interest rates on 5 year note is currently low, the longer the loan the lower the rates
- Question whether the \$2 million that was taken from pension fund can be repaid from the CARES Act
- Pension contribution is frozen for Fiscal Year 2021
- Question why wasn't the \$26 million put into unassigned funds
- Question asked if the stimulus checks were to stabilize the economy
- Question whether the CARES Act is to address health care
- Violent crimes are at a record number, and neighborhoods are not safe
- Question about how The Group Violence Intervention will work with their partners and the youth
- Outreach workers will be used to reach and work with the youth
- Detail plans needed on how money will be spent on homelessness
- Question if there is a draft ideal of what the administration would like to do with left over money from the CARES Act funds
- West-end Library has infrastructure needs that would be a one time expense
- The Office of Resilience and Community Services submits quarterly reports to Metro Council
- Downtown Partnership does the clean-up for downtown and has there own tax base and budget
- Questions from meeting are to be forwarded to Chair Hollander
