Rachel Roarx, Legislative Aide for District 21, explained that this previously-approved appropriation was being amended to clarify how often the pick up would occur and how many times it would occur, and more funds were needed so the amount was increased.

Council Member Peden asked whether Southfield Commons was supposed to do some of the work on Brentlinger Road in this area, and whether they were finished with their portion of the work.

Jared Townes spoke about the work Southfield Commons had completed.

Beth Stenberg, Metro Council Financial Analyst, said that she could provide information about Council Member's Peden's question and that the MAP appropriation (MAP031721PWRep) approved earlier in the meeting was also assigning \$100,000 to this project in addition to this \$50,000.
