LITIGATION



- 105 NEW lawsuits were filed in 2019.
- In 2019, they settled 11 cases for \$1,893,000.00 versus \$9,851,115.00 in demands. A difference of \$7,958.115.00.
- Summary Judgment was awarded in 4 cases where Plaintiffs had made demands/claimed damages in excess of \$2,000,000.00.
- Our team was able to have a \$1,000,000.00 judgment awarded against Louisville Metro overturned on appeal.
- The Litigation Team was also able to win dismissals in 28 other litigated/claim related matters.



LITIGATION



- Litigators recovered \$670,000.00 on behalf of Metro entities on two claims: The first due to breach of contract/negligence and the second a disputed Revenue Commission tax claim.
- The Litigation Division recovered \$613,452.11 for our criminal justice partners through forfeitures. In 2019, those criminal justice partners who received those monies included:
 - Louisville Metro (LMPD)
 - Jefferson County Sheriff
 - Shively Police
 - Jeffersontown Police
 - Middletown Police

The amount of civil forfeiture monies paid to Louisville Metro (LMPD) was \$174,120.41.

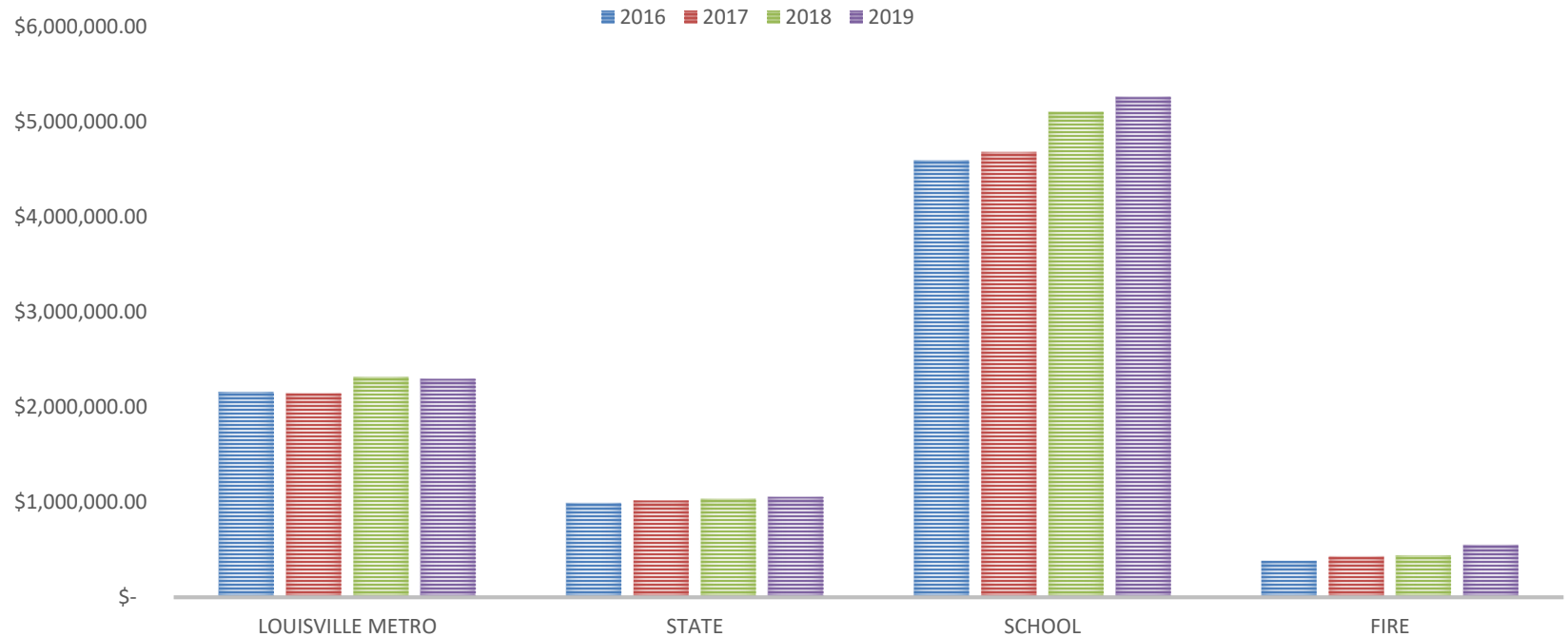

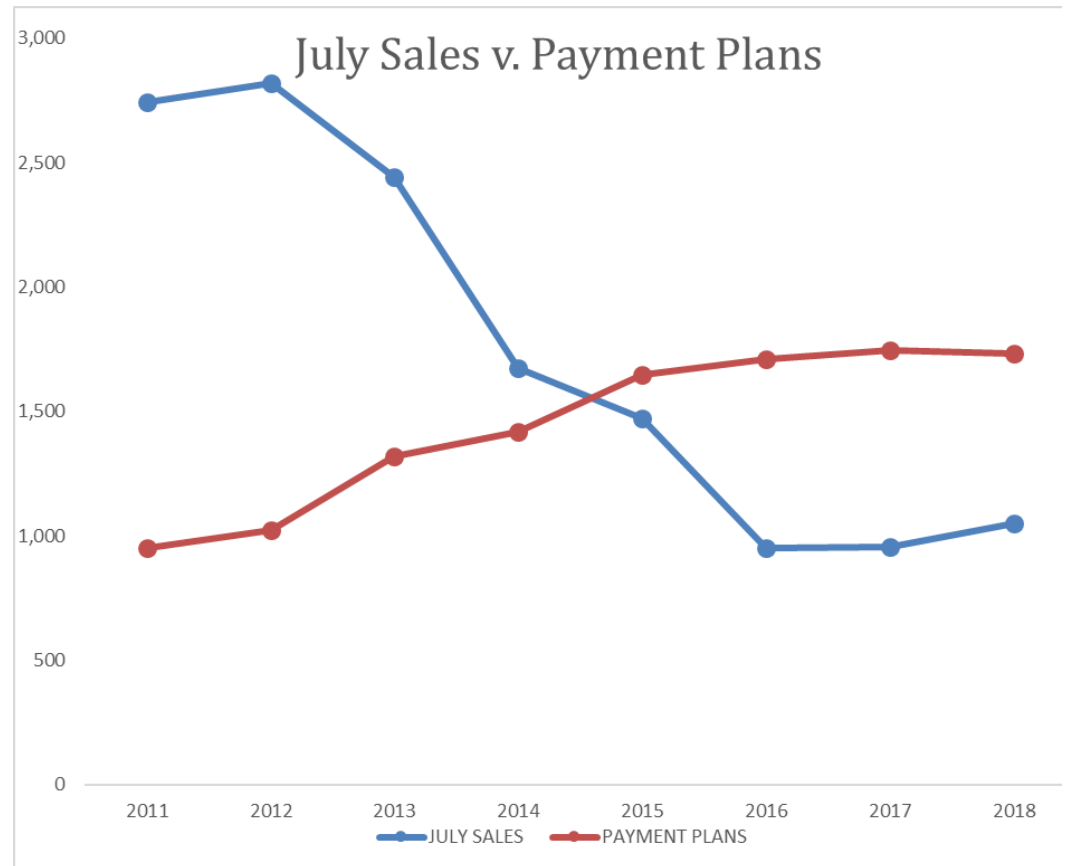

DISTRIBUTION OF DELINQUENT TAXES COMPARISONS 2016-2019



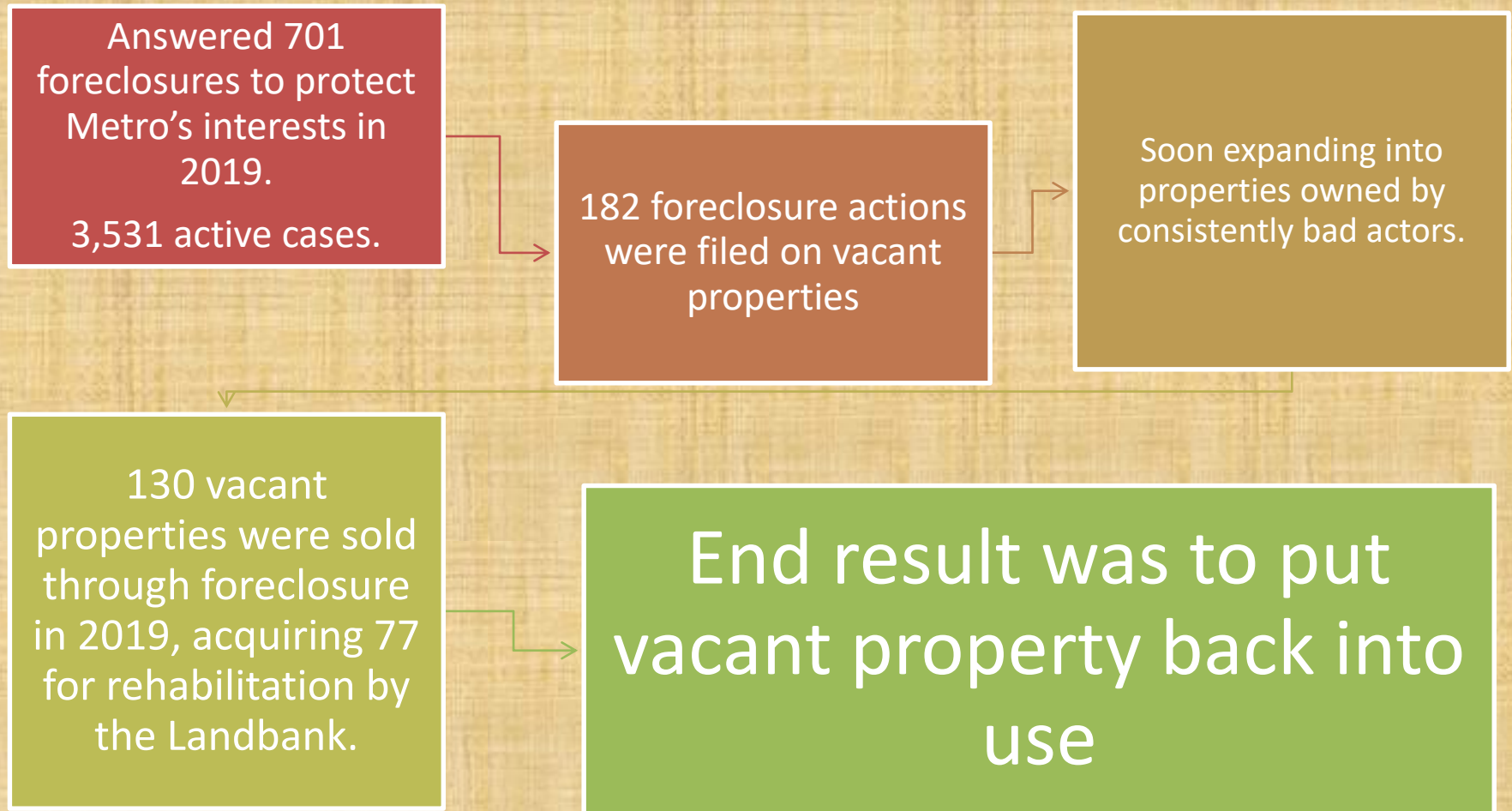
Tax Payment Plans

The County Attorney's Office initiated a program to aid individual taxpayers to stay in their homes and avoid foreclosure. Just this past year, 1,730 of the 2018 tax bills were put on payment plans, allowing homeowners to take advantage of our program while at the same time reducing the amount of tax delinquencies sold to outside collectors, again outpacing those tax bills sold to third parties at the tax sale. Over 2,600 tax bills are currently on payment plans!

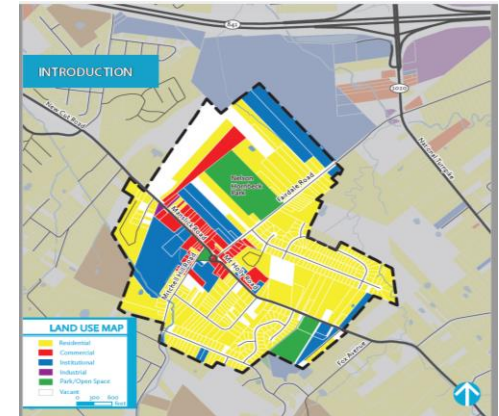

POSSESSION OF MARIJUANA

In August of 2019, County Attorney Mike O'Connell announced the office would no longer prosecute possession of small amounts of marijuana where—

- The amount of marijuana was one ounce or less
- The individual was 21 years of age and older
- The marijuana possession charge was the only or highest charge
- No guns were involved
- The charge did not include trafficking, cultivation, driving under the influence, public intoxication, or public use or display.

As Mike noted in his announcement, studies consistently show that whites and blacks use marijuana at equal rates across the nation. Yet, African Americans are four times more likely to be arrested for possession of marijuana than whites are.

Referring to these disparate arrest rates, Mike said, “For me to truly be a minister of justice, I cannot sit idly by when communities of color are treated differently.” “This is a problem that belongs to us all. In my role as Jefferson County Attorney, I can do more to develop reforms that avoid needlessly bringing people into the justice system. I choose to act.”

CRIMINAL DIVISION

- The Criminal Division covers both a wide variety and a large number of cases. This ranges from traffic violations up to murder, robbery, and rape.
- Many of the cases are handled by our prosecutors throughout all stages: DUI; Domestic Violence; Dependency/Abuse/Neglect; Mental Inquest; Disability; Casey's Law, and many more.
- For the most serious violent offenses (ex. Murder, rape, and robbery), our prosecutors handle the early stages of the case. This includes arraignment, setting bonds, and probable cause hearings.
- In all cases, our office has a particular focus on crimes where a gun is used.
